Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of St. Francis Area Developmental Center Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 - Description of the Plan

The following description of the St. Francis Area Developmental Center ("Organization") Employee Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Organization, who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute up to \$23,000 and \$22,500 of pretax annual compensation, as defined in the Plan, for calendar years 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for calendar years 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization will make a Safe Harbor Non-Elective Contribution equal to three percent of each eligible participant's compensation. Also, the Organization may, at its discretion, make a matching contribution of up to three percent compensation. Also, the Organization may at its discretion, make a profit sharing contribution. All contributions are subject to certain IRC limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Organization's contribution and (b) Plan earnings. Allocations are based on participant annual compensation or account balances, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in the Organization's safe harbor contributions plus actual earnings thereon. Vesting in the Organization's discretionary matching and profit sharing contributions is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

Investment Options - Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions into a number of investment fund options. Participants may change their investment options at any time via telephone or a secure Internet website.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in periodic payments.

Forfeited Accounts - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,087 and \$1,085, respectively. Forfeitures first must be used to restore forfeited account balances for reemployed participants, and any remaining amounts may be used to pay plan administration expenses or reduce employer contributions. Forfeited accounts in the amount of \$0 were used to reduce employer contributions for the years 2024 and 2023.

Administration Fees - Administration expenses may be paid by the Plan using forfeited accounts or they may be paid by the Organization.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 3 - Investment in Great-West Fixed Account

The Plan is invested in the Great-West Fixed Account which is a group annuity contract invested in assets held in the Great-West Life and Annuity Insurance Company's general account. The contract's main characteristic is that it allows for principal value and accrued income to remain stable regardless of fluctuations in market interest rates or the price of underlying assets.

As described in Note 2, because the Great-West Fixed Account is a fully benefit responsive investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Great-West Fixed Account. Contract value, as reported to the Plan by the Great-West Fixed Account, represents the results of operations for the reporting period and net assets held at the reporting date.

Note 4 - Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No level 2 or 3 inputs were used to value the investments.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

Note 7 - Tax Status

The Internal Revenue Service has determined and informed the Organization by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and require a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2020.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Concentrations of Credit Risk

As of June 30, 2024, all investments of the Plan are held by Capital Bank and Trust Company. The Plan does not require collateral.

Note 10 - Subsequent Events

Subsequent events were evaluated through April 5, 2025, which is the date the financial statements were available to be issued.
