## Independent Auditors' Report

### **The Board of Trustees of 403(b) Thrift Plan of Job Path, Inc.**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Job Path, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2024, and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of June 30, 2024, and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

**1. Description of Plan**

The following description of 403(b) Thrift Plan of Job Path, Inc. (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Job Path, Inc. (the “Employer”) except as noted below. An employee is eligible for participation in the Plan upon their date of hire. To be eligible for Employer matching contributions, an employee must complete two years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In November of 2016, the Plan added Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively “Empower”) as additional vendors to the Plan. All contributions for active participants, as of November of 2016 and forward, are sent to Empower only. Plan participants were given the option to transfer their assets from Mutual of America Life Insurance Company to Empower. Some assets still remain with Mutual of America Life Insurance Company.

***Contributions***

Participants may elect to complete a salary reduction agreement and an enrollment form. Each year, eligible participants may contribute up to 100% of their eligible compensation to the Plan on a pre-tax or Roth basis. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employer. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

Participants who complete two years of service and defer at least 3% of their eligible compensation are eligible to receive an Employer matching contribution equal to 5% of their eligible compensation.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s matching contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed.

***Vesting***

A participant is 100% vested in their contributions and Employer matching contributions plus allocated earnings thereon at all times.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum, installments or an annuity. In-service withdrawals may be taken by a Participant in the event of hardship, as defined and after age 59 ½.

***Notes Receivable from Participants – Empower***

Participants may borrow from their account a minimum amount of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 2% above the published prime rate as of the first business day of the month the loan is originated. The maximum repayment term allowed is five years unless the loan qualifies as a residential mortgage loan, in which case the repayment term may not exceed fifteen years. A participant can only have two loans outstanding at any time. Principal and interest is paid ratably through deductions from payroll.

***Loans to Participants/Collateralized Assets – Mutual of America Life Insurance Company***

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Only one loan may be made in any twelve consecutive month period. Defaults in loans are treated as a distribution at the time of default against the participant's account.

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested balance or \$50,000. Loans to the participant are made directly from Mutual of America Life Insurance Company. The participant's account is not reduced by the loan amount but serves as security for the loan. The loan amount is moved into a fixed income collateral account within the borrower's account. The loan must be repaid directly to Mutual of America Life Insurance Company within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default.

***Loans to Participants/Collateralized Assets – Mutual of America Life Insurance Company***

At June 30, 2024 and 2023, there was 1 collateralized loan outstanding with a total principal balance due of \$4,461 and \$6,065 which also represents a collateralization of the participant's account. There were no loans in default as of June 30, 2024 and 2023. At June 30, 2024 and 2023, the collateralized loan outstanding has an interest rate of 5.85% with maturity in 2027.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis; investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements*, where applicable, which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the insurance company general accounts, which are valued at contract value. The insurance company general accounts are valued at contract value, which represents contributions made under the contract, plus interest credited, less benefits paid and expenses. The separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from the financial statements. Investment related expenses are included in net appreciation in value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 2, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments held at June 30, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, Empower Life & Annuity Insurance Company of New York, and Empower Trust Company, LLC, qualified institutions.

**4. Investments**

The Plan offers two insurance company general accounts, which are the Mutual of America Interest Accumulation Account and the Guaranteed Interest Fund, as investment options under the Plan. As of June 30, 2024 and 2023, the total investments in the insurance company general accounts amounted to \$212,556 and \$209,547.

**5. Insurance Company General Accounts**

***Mutual of America Interest Accumulation Account***

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America. Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00%. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The principal and previously credited interest is guaranteed by Mutual of America. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A as of February 2023), S&P Global Ratings (A as of December 2022), and Fitch Ratings (A- as of March 2024).

***Guaranteed Interest Fund***

The Guaranteed Interest Fund (the “Fund”) is a general account product that is offered through a group annuity contract. Principal and interest are both fully guaranteed and backed by the general account assets of Empower Life & Annuity Insurance Company of New York. Each quarter an interest rate is established for all money, regardless of when it was deposited. The credited interest rate may stay the same or change each quarter.

Participants may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. If a participant transfers out of the Fund, however, Empower Life & Annuity Insurance Company of New York reserves the right to restrict transfers for thirty days.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+ as of December 2023), Standard and Poor’s (AA as of December 2023), Moody’s Investors Service (Aa3 as of December 2023), and Fitch Ratings (AA as of December 2023).

**6. Separate Accounts**

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan's separate accounts include various asset classes which are: equity funds, fixed income funds, growth funds, money market funds, balanced funds, bond funds, asset allocation funds, and retirement funds.

**7. Related Party Transactions**

Certain investments are managed by Mutual of America Life Insurance Company. In addition, Mutual of America Life Insurance Company makes loans to participants whereby the participant's account in the Plan serves as security for the loan. Mutual of America Life Insurance Company is a custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain investments are managed by an affiliate of Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC. Empower Life & Annuity Insurance Company of New York is a custodian of the Plan and Empower Trust Company, LLC is a trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**8. Tax Status**

On March 31, 2017 the Internal Revenue Service ("IRS") issued an opinion letter to the volume submitter document preparer, Alliant Insurance Services Inc., indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**9. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with the certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
