To Whom It May Concern,

I am writing on behalf of Anders Developmental & Transition Home LLC to explain the delay in filing our 2022 plan documents and to respectfully request a waiver or reduction of any penalties assessed as part of the Department of Labor's filing requirements.

We are a small business with three employees. During the relevant period, we retained Paychex to manage our payroll and plan responsibilities. Contributions to the plan were made for less than one month before being zeroed out. As our designated administrator, I relied on Paychex to handle all associated plan filings. At the time of our service termination, I believed that all necessary filings had been completed.

When I later discovered that the plan year's return was not submitted, I made several attempts to file electronically. However, I encountered persistent issues including system rejections of my PDF upload and repeated error messages due to the filing being late. It was only recently that I discovered the system requires XML-formatted submissions, further explaining my previous filing failures.

I respectfully request that the Department consider these circumstances as reasonable cause for the delay. There was no intent to neglect filing requirements—only lack of understanding, genuine confusion and technical difficulties compounded by an overreliance on a third-party payroll administrator. I am hopeful this brings my company into compliance going forward.
