INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Options for Southern Oregon, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Options for Southern Oregon, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. Plan Description

The following description of Options for Southern Oregon, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Options for Southern Oregon, Inc. (the Employer) that work 20 or more hours per week. The Plan has no minimum age or service requirement for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to be qualified under Section 403(b) of the Internal Revenue Code (IRC). The Plan's most recent restatement was effective July 1, 2021. The Plan Administrator oversees governance of the Plan.

Contributions

Participants may elect pretax and after tax (designated as Roth) deferrals to be contributed to their account in lieu of receiving cash payments directly as salary or wages. However, such amounts may not cause the participant's total contributions to exceed limitations provided by the IRC. Additionally, employees age 50 or older, or who will attain age 50 before the end of the calendar year, are eligible to contribute catch-up contributions up to Internal Revenue Service (IRS) limits. With approval by the Plan Administrator, the Plan also allows for participants to make rollover contributions from existing qualified plans into the Plan.

The Employer may contribute matching or other Employer contributions to the Plan at its discretion. Employees are eligible for Employer contributions upon reaching 90 days of service if normally scheduled to work 20 or more hours per week. The percentage of the matching contribution is to be determined by the Employer each year, up to a maximum of 6 percent of compensation. For the years ended June 30, 2024 and 2023, the Employer made a matching contribution of to 6 percent of eligible compensation. There were no other Employer contributions for the years ended June 30, 2024 and 2023.

Participants may direct the investment of their contributions into various investments offered through The Variable Annuity Life Insurance Company (VALIC), the Plan's third-party investment custodian.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and earnings on the specific investments held in the participant's account, and charged with an allocation of administrative expenses paid by the Plan, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum of the lesser of \$50,000 or 50 percent of their vested account balance, with a minimum of \$1,000 and participants may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate of interest. Loan terms range up to five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time commensurate with the repayment period permitted by commercial lenders for similar loans.

Notes Receivable from Participants, continued

Additionally, the custodians may allow participants to borrow directly from the custodians' general assets. These loans are secured by the balance in the participant's account, which may be redirected to a fixed annuity contract or other stable value investment. These loans, referred to as Plan loans, are not reported as separate assets on the accompanying statements of net assets available for benefits. Plan loans bear interest at Prime plus 1 percent. At June 30, 2024 and 2023, \$36,470 and \$9,588, respectively, of participant balances were secured as collateral for these loans.

Vesting

Participants are fully vested in their accounts at all times.

Payments of Benefits

On termination of employment, a participant may be entitled to receive a distribution from the Plan. The availability of the distribution depends on the amount of the participant's account balance. The participant may elect to receive an amount equal to the balance in his or her account in the either a lump-sum amount or in installments over a specified period.

The Plan provides for hardship withdrawals in the event of immediate and heavy financial need in an amount not to exceed the lesser of the participant's balance or the amount of the financial need. Participants aged 59½ or older may take in-service distributions from their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive insurance contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements. The Plan's investment in benefit-responsive fixed annuity contracts is carried at contract value, which represents invested principal plus credited interest. See Note 3 for a discussion of investment contracts.

Investment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments held by plans qualified under IRC Section 403(b) are limited to registered investment companies (mutual funds) and fixed or variable annuity contracts.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of June 30, 2024 and 2023, an allowance has been recorded in the amount of \$70,728 and \$65,801, respectively, related to the amount of loans in default. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Administrative expenses of the Plan are paid by Plan assets, or may be paid by the Employer. Plan expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments. Fees for the administration of notes receivables from participants and distributions are included in administrative expenses and charged directly to the participant's account.

Recent Accounting Standard Adopted

On July 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective July 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Investment Contracts

The Fixed Account Plus, Short-Term Fixed Account and Fixed Interest Option are fixed rate annuity contracts guaranteed by The Variable Annuity Life Insurance Company (VALIC) which provide a guarantee of principal and a guaranteed minimum rate of interest for the life of the contract of no less than 1 percent. Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Administrator believes the occurrence of such events is not probable. There is no charge for cash surrender or withdrawals. The contracts are considered fully benefit-responsive and are reported at contract value as of June 30, 2024 and 2023.

4. Information Certified by the Plan's Custodians

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information was certified as complete and accurate by the custodians, The Variable Annuity Life Insurance Company (VALIC) and VALIC Trust Company, Inc., as of and for the years ended June 30:

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by VALIC, the custodian of the Plan for the years ended June 30, 2024 and 2023. As defined by the Plan, these transactions qualify as party in interest transactions. Fees paid directly to VALIC and its affiliates for investment-related and contract administrator fees were \$58,027 and \$32,637 for the years ended June 30, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions set forth in ERISA.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

The Plan has adopted a volume submitter 403(b) Plan sponsored by Northwest Retirement Plans, Inc. The sponsor of the volume submitter has obtained an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017 that the documents are acceptable under section 403(b) of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the Plan Administrator believe the Plan is currently designed and being operating in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

8. Fair Value Measurements, continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds in a group annuity contract that are registered with the SEC and are deemed to be actively traded. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
