### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of PRIDE Industries 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PRIDE Industries 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PRIDE Industries 401(k) Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

# PRIDE Industries 401(k) Retirement Plan

## Notes to Financial Statements

---

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the PRIDE Industries 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of PRIDE Industries and certain participating employers (the Organization or Sponsor), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is the Plan's sponsor and serves as plan administrator. The Plan also covers all employees performing services for the Organization under a public contract subject to the Davis Bacon Act, Service Contract Act, McNamara-O'Hara and other federal, state, or municipal Prevailing Wage Laws.

The Organization acquired Crossroads Diversified Services, Inc. (Crossroads), effective January 1, 2021 (acquisition date). Crossroads' employees became participants in the Plan on the acquisition date.

On June 3, 2024, the Crossroads Diversified Services, Inc. 401(k) Plan's assets of \$438,006 were merged into the Plan.

**Eligibility** – Employees of the Organization, except for highly compensated employees, are eligible to participate in the Plan on the date of hire. Participants must complete six months of service to be eligible to receive any employer contributions. Eligibility for wage rate contributions is dependent upon specific public contracts.

Highly compensated employees (HCE) are eligible to participate in a 403(b) Plan sponsored by the Organization once they become a HCE in the prior Plan year. The liability at June 30, 2023 relates to amounts deferred by HCE's in the year following their qualification for the 403(b) Plan. These amounts were transferred to the 403(b) Plan subsequent to June 30, 2023.

### Contributions

*Participant contributions* – Each year, participants can contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans.

*Employer match and profit-sharing contributions* – The Organization may elect to make discretionary matching and profit-sharing contributions to the Plan. The Organization match is 50% of employee contributions, up to 5% of eligible compensation deferred to the Plan. Profit sharing contributions are allocated for each plan year in an amount determined by the Organization. There were no profit-sharing contributions for the year ended June 30, 2024.

*Employer wage rate contributions* – Under certain prevailing wage contracts, the Sponsor is required to make wage rate contributions to the accounts of participants. These contributions are equal to the fringe benefit amount determined according to the prevailing rate schedule for each person reduced by contributions made for medical, dental, and vision benefits which satisfy the fringe benefit rate stated in the prevailing rate schedule.

Contributions are subject to regulatory limitations.

## PRIDE Industries 401(k) Retirement Plan Notes to Financial Statements

---

**Participant accounts** – Each participant’s account is credited with the participant’s contributions and Organization discretionary matching and wage rate contributions, as well as allocations of the Organization’s discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions and employer wage rate contributions plus actual earnings thereon. Vesting in the Organization’s discretionary matching and profit-sharing contribution portions of their accounts is based on years of continuous service. Participants vest in employer discretionary matching and profit-sharing contributions based on the following schedules:

**Payment of benefits** – On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Terminated participants with a vested account balance of \$1,000 or less may be paid as a single lump-sum without the participant’s consent. If a participant terminates employment and his or her vested balance is over \$1,000, but not over \$5,000 on the cash-out date and distribution instructions are not provided, the account balance will be rolled over to an individual retirement account established in the participant’s name.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan, must be used before year end, and will first be used to pay the Plan’s administrative expenses, with any remaining amount used to reduce future Organization discretionary matching contributions. As of June 30, 2024 and 2023, forfeited nonvested accounts totaled approximately \$63,000 and \$113,000, respectively. For the year ended June 30, 2024, Company matching contributions were reduced by \$185,000 from forfeitures.

## Notes to Financial Statements

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's custodian and trustee, Empower Trust Company, LLC (Empower Trust) certified the fair market value of all investments held by the Plan at June 30, 2024 and 2023. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Benefit payments** – Benefits are recorded when paid.

**Administrative expenses** – The Plan permits the payment of Plan administrative expenses to be made from the Plan's assets. Plan administrative expenses include fees paid to the Plan's recordkeeper and third-party administrator.

The Sponsor absorbs the remaining cost of plan administration including bookkeeping and other administrative services. The plan administrator reviews administrative and investment management expenses for compliance with the provisions of the Plan.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date, and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through April 4, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (level 3). The three levels of inputs within the fair value hierarchy are defined as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at June 30, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The CTs can be redeemed daily, and there are no redemption restrictions or notice requirements.

### NOTE 4 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Organization believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Organization has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 6 – INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust the trustee and custodian of the Plan, has certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Organization has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

#### **NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and will Form 5330 with the IRS.
