### **Opinion**

**NOTES TO FINANCIAL STATEMENTS**  
**JUNE 30, 2024 AND 2023**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Washington Teamsters Welfare Trust (the "Plan") is a multiemployer benefit plan designed to provide health and welfare benefits to eligible participants, which include active employees of participating employers. The Plan is funded by employer contributions in accordance with applicable collective bargaining agreements, and self-payments in an amount fixed by the Board of Trustees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee must meet the requirements of an employer's collective bargaining agreement and work a minimum number of hours (generally 80 hours) per month to maintain eligibility for benefits. Continuation of benefits under the dollar bank provision is available to participants who do not meet the minimum monthly hours of service requirement.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan Agreement and amendments regarding specific provisions of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Contributions**

Participating employers make monthly contributions for each hour of service in covered employment worked by eligible participants as required under collective bargaining. The Board of Trustees sets contribution rates based on information provided by the Plan's consultant. Employer contributions receivable is based on contributions received subsequent to year end for hours worked during the Plan year. No allowance is provided for uncollectible accounts. Contributions due as a result of payroll compliance procedures are recoded when collected.

Eligible participants may elect to continue coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) in specific instances where coverage under the Plan would otherwise terminate.

**D. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**E. Benefits and Benefit Obligations**

The Plan provides medical, dental, vision, prescription drug, mental health, supplemental income, life and accidental death and dismemberment benefits for eligible members and their dependents. Benefits are paid directly from Plan assets, except for life, accidental death and disability insurance benefits which are provided under contract with insurance companies. Benefits are recorded when paid.

The obligations for premiums and claims payable and reserve for claims incurred but not reported in statements of benefit obligations are estimates of the costs of claims incurred under terms of the Plan at June 30 and paid subsequent to June 30. The obligation for future benefits based on participants' accumulated eligibility (lag months) reported in statements of benefit obligations is an estimate of the cost of benefits earned in May and June that will be paid in July and August. Participants may accumulate up to six months of continuing coverage in their dollar bank. The obligation for future benefits for accumulated eligibility (dollar bank) reported in statements of benefit obligations recognizes the cost of benefit continuation based on participants' dollar banks at year end. Life extension and long-term disability reserves reported in statements of benefit obligations are an estimate of the cost of benefits for disabled participants.

**F. Tax-Exempt Status**

The Plan received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9). The Board of Trustees and Plan management believe the Plan is designed and operated in compliance with applicable regulations. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Plan Termination**

Upon the termination of the Plan, the Plan Agreement and Declaration of Trust provide that all assets remaining in the Trust after payment of all expenses and Plan obligations shall be expended and used for continuation of the Plan until such assets have been exhausted, or transferred to another trust or trusts providing similar benefits. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

**H. Concentrations, Risks and Uncertainties**

Investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investment securities in the near term could materially affect the amounts reported in the financial statements.

**H. Concentrations, Risks and Uncertainties (Continued)**

Benefit obligations are based on certain estimates and assumptions pertaining to health care inflation rates, participant demographics and claims experience which are subject to change. Due to uncertainties inherent in these estimates and assumptions, it is at least reasonably possible that changes in estimates and assumptions in the near term would be material to the financial statements.

The Plan places its cash with a financial institution deemed to be credit worthy. Cash balances may at times exceed the federally insured limit of \$250,000 per bank. Bank short term money market sweep accounts are not federally insured. Sweep account balances totaled approximately \$10,000,000 at June 30, 2024.

the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are securities registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. Mutual funds and money market funds are deemed to be actively traded. Government debt securities are valued by a third-party pricing source that incorporates market observable data such as reported sales of similar securities, broker quotes and reference data. The following tables summarize the Plan's investments at June 30 based on the inputs used to value them:
