As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by

and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of The McCall Foundation, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. Contributions to provide benefits under the Plan are made by plan participants and McCall Behavioral Health Network (the "Plan Sponsor").

General - The Plan is a 403(b) tax-deferred annuity plan which was originally established January 1, 1995, by Central Naugatuck Valley Help, Inc. and was named the Central Naugatuck Valley Help, Inc. Tax Sheltered Annuity Plan. The Plan was amended in its entirety effective January 1, 2010, and was amended again effective January 1, 2019, to meet the compliance requirements of the Bipartisan Budget Act. As a result of a merger between the plan sponsor and McCall Foundation, Inc., doing business together as the McCall Behavioral Health Network, the Plan was amended further effective January 1, 2022, to change the Plan's year-end from December 31 to June 30 and to create a short-year for the period January 1, 2022-June 30, 2022. Additionally, effective on July 1, 2022, the McCall Foundation Inc. Retirement Plan would be merged into the Plan, the plan sponsor would be changed from Central Naugatuck Valley Help, Inc. to the McCall Foundation, Inc., and the Plan's name would be changed to The McCall Foundation, Inc. Retirement Savings Plan. At the same time, the vesting schedule for employer matching contributions was modified and vesting provisions were added for certain merged accounts attributable to employer nonelective contributions. Finally, effective on April 1, 2023, a Roth provision was added to the Plan. The Plan covers substantially all employees upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Plan participants are immediately eligible upon hire, and may make salary deferral contributions, as defined in the Plan, which are 100% vested, subject to the annual limitations of the Internal Revenue Code ("Code"). Such deferrals may be contributed on a pre-tax or after-tax (Roth) basis, or a combination thereof. Participants become eligible for employer matching contributions once they have earned six months of service. The employer matching contributions are based on a discretionary percent of participants' elective deferrals, not to exceed a discretionary percent of each

participant's eligible Plan compensation and are paid each pay period for each participant who has contributed to the Plan with a true-up at the end of the year. The matching formula is set by the plan sponsor, and for the Plan year ended June 30, 2024, the employer match was set as 100% of participant deferrals, including participant's Plan catch-up contributions, up to a maximum of 4% of each participant's eligible Plan compensation.

Additionally, participants may contribute amounts representing rollover distributions from other qualified plans. Such rollover contributions are always 100% vested.

Participants' Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the plan sponsor's matching (or other) contributions and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions to the Plan are participant directed and credited to participant accounts by The Standard, the Plan's Third-Party Administrator, when received by The Standard or Reliance Trust, the custodians of the Plan, and invested in custodial accounts defined in section 403(b)(1) of the Code.

Vesting - Participants are immediately vested in their contributions, including any rollover contributions, plus actual earnings thereon. The vesting percentage for employer matching contributions is based on a schedule ranging from employment less than 1 year (0%) to 3 or more years (100%). For employer non-elective (profit sharing) contributions attributable to the account balances transferred in from the merging plan, the same vesting schedule ranging from employment less than 1 year (0%) to 3 or more years (100%) is applicable, however a six-year vesting schedule ranging from employment less than 2 years (0%) to 6 or more years (100%) is applicable to such amounts for those transferred non-elective balances that relate to participants whose employment terminated prior to the date of the plan merger.

Forfeited Accounts - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan and receive (or are deemed to receive) a distribution. These accounts represent the portion of any matching or, for those participants with balances transferred from the merging plan, discretionary non-elective profit-sharing contributions made by the plan sponsor that were allocated to participants who later terminated their employment with the plan sponsor before becoming fully vested in those contributions. Forfeitures are first used to pay certain plan expenses. Any forfeitures remaining are used to reduce the Plan sponsor's future contributions to the Plan. Forfeitures during the year ended June 30, 2024, totaled \$4,898.

At June 30, 2024 and 2023, total forfeitures and other non-vested accounts totaled \$4,669 and \$15,203, respectively.

Participant Loans - Loans are available under the Plan to all active participants on a reasonably equivalent basis and loans shall not be made to highly compensated employees in an amount greater than the amount made available to other participants. The number of outstanding loans per participant is generally limited to one, except in the case of a principal residence loan; and may not initiate more than two loans in the same year. The minimum amount of any loan is \$1,000. Loans must be adequately secured and bear interest at Prime plus 1%. The interest rate for all loans outstanding during 2024 ranged from 4.25%-9.50%. Loans to participants may not exceed the lesser of \$50,000, or 50% of a participant's vested account balance on the date immediately preceding the date on which the loan is approved by the plan administrator. Loans deemed to be in default are recorded as plan withdrawals. Principal and interest are paid ratably through bi-weekly payroll deductions.

Investment Options - Participants can direct contributions to any of the fixed income and equity mutual fund options or to the fixed income insurance contract offered through the Standard.

Withdrawals - A participant who has attained age 59½ may withdraw any part of his vested account resulting from either: elective deferral contributions, employer matching or transferred employer discretionary contributions, or rollover contributions. Additionally, a participant may make a withdrawal at any time of any part of his vested account resulting from rollover contributions. A participant may also make a withdrawal at any time and may withdraw any part of any of his vested account resulting from elective deferral contributions in the event of hardship due to an immediate and heavy financial need to pay for qualifying expenses subject to certain conditions. If a participant dies before distributions commence, the participant's entire vested account balance will be used to provide your beneficiary with a death benefit, which may be in the form of a lump sum or an annuity depending on circumstances

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

- The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.
- Investments in mutual funds are stated at fair value, based on publicly quoted market prices.

- Investments in the Stable Asset Fund are stated at contract value as determined by the custodian.
- Investment income is recorded as earned.
- Benefits are recorded when paid.
- No participants have withdrawn from the Plan that have not been paid.
- Investment transactions are accounted for on the trade date.
- Loans receivable from participants are recorded at their unpaid principal balance plus accrued interest. Interest is charged on loans at rates similar to those prevailing in the market at the time the loan is made. Plan management has determined that all receivables are collectible. Accordingly, no allowance for doubtful accounts has been recorded.

Risks and Uncertainties - The Plan provides for various investment options in a group annuity insurance contract and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are stated at fair value and contract value.

The Plan adopted the professional standards relating to *Fair Value Measurements (ASC 820)* issued by the Financial Accounting Standards Board (FASB). The standards define fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and sets out a fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Inputs are broadly

defined under the standards as assumptions market participants would use in pricing an asset or liability.

The Plan's investments are held in mutual funds and a fully benefit responsive insurance contract, and are stated at fair value and contract value. The fair value of mutual funds is based on publicly quoted net asset values of the shares held by the Plan at year-end. The benefit responsive insurance contract is reported at contract value. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Loans to participants are valued at their outstanding balance, which approximates fair value. Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued as it is earned, and dividends are recorded as of the ex-dividend date.

The change in net unrealized appreciation (depreciation) of investments held from the beginning of the Plan year to the end of the Plan year is included with the realized gains (losses) as net appreciation reported in the accompanying statement of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated events and transactions for potential recognition or disclosure through March 24, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIANS

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedules that was prepared by The Standard and Reliance Trust, the custodians of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the custodians that such information, including the information included in the supplemental schedule, is complete and accurate.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs

because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

The following methods may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no unfunded commitments or redemption restrictions regarding plan investments.

Level 1 Fair Value Measurements

Fair value is based on unadjusted publicly quoted prices in active markets that are accessible to the Plan for identical assets or liabilities. These generally provide the most reliable evidence and should be used to measure fair value whenever available. The fair value of mutual funds is based on publicly quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

Fair value is based on inputs, other than Level 1 inputs, that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability through corroboration with observable market data. The Plan currently uses no Level 2 inputs.

Level 3 Fair Value Measurements

Fair value is based on significant unobservable inputs for the asset or liability. These inputs reflect the Plan's own assumptions through their investment advisors about the assumptions that market participants would use in pricing the asset or liability. The Plan currently uses no Level 3 inputs.

5. INVESTMENTS AT CONTRACT VALUE

The fixed income investment contract with The Standard Insurance Company is fully benefit responsive. Fully benefit responsive investment contracts held by a defined contribution plan are required to be reported at contract value, which is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. The average yield and crediting interest rates were 2.94% for the year ended June 30, 2024. The crediting interest rate, which is reset quarterly, will never be below 1% and was calculated by the issuer using a process similar to that used by banks or other insurance companies for similar products and that takes into account yield forecasts from its asset advisory group and the margins required for its business. Certain events, such as premature

termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with The Standard Insurance Company. The plan administrator believes the occurrence of such events, that would also limit the Plan's ability to transact at contract value with the plan participants, is not probable.

6. INCOME TAX STATUS

The prototype document utilized by the Plan obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the form of plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan is required to operate in conformity with the Code to maintain its tax exemption. The plan sponsor believes that, based on the operations of the Plan, the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management is not aware of any uncertain tax positions taken by the Plan. Years subsequent to June 30, 2020 remain open and subject to examination by major taxing jurisdictions.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Stancorp Financial Group, dba The Standard, is the third-party administrator and Kestra Advisory Services, LLC is the investment advisor for the Plan and, in accordance with the ADP Retirement Plan Administrative Services Agreement effective February 1, 2015 between the plan sponsor and The Standard, they provide administrative and investment advisory services to the Plan, thereby qualifying as parties-in-interest as defined in Section 406 of ERISA. The Standard and/or Kestra Advisory Services, LLC may receive revenue from registered investment companies - mutual fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to The Standard and/or Kestra Advisory Services, LLC for their services to the Plan.

If the revenue received by The Standard and/or Kestra Advisory Services, LLC from such registered investment companies - mutual fund service providers exceed the amount owed under that agreement, they will remit the excess to the Plan.

During 2024, administrative fees paid to The Standard from Plan assets totaled \$30,341.

Kestra Advisory Services, LLC provides investment advisory services thereby qualifying as a party-in-interest as defined in Section 406 of ERISA. Fees paid to Kestra Advisory Services, LLC during 2024 totaled \$19,829.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. ADMINISTRATIVE COSTS

Expenses of the Plan, to the extent that the employer does not pay such expenses, may be paid out of the assets of the Plan provided that such payment is consistent with ERISA. Such expenses include, but are not limited to, expenses for bonding required by ERISA; expenses for recordkeeping and other administrative services; fees and expenses of the custodian or annuity contract; expenses for investment education service; and direct costs that the employer incurs with respect to the Plan. Expenses that relate solely to a specific participant or alternate payee may be assessed against such participant or alternate payee as provided in the service and expense agreement or such other documents duly entered into by or with regard to the Plan that governs such matters.

9. PLAN TERMINATION

The plan sponsor expects to continue the Plan indefinitely, but reserves the right to terminate the Plan in whole or in part at any time upon giving written notice to all parties concerned. Complete discontinuance of contributions constitutes complete termination of the Plan. Each participant's account shall be 100% vested and nonforfeitable as of the effective date of complete termination.

10. CONTRIBUTIONS

As a result of the plan merger in 2023, certain employee loan payments for three pay periods relating to two employees were not remitted to the Plan on a timely basis in the previous fiscal year. However, as of June 30, 2023 all such contributions had been remitted in full, with the exception of the lost earnings thereon. The plan sponsor remitted those lost earnings, which approximated \$18, during the year ended June 30, 2024, and the matter is now deemed to be corrected.

11. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

The plan administrator reports the plan's financial activity each year on Schedule H of Form 5500 on the accrual basis of accounting which is consistent with the plan's third-party administrator's method of accounting

and reporting for Form 5500 preparation. However, due to the existence of certain "deemed" loan balances, there are differences between the two reports. 12. SUBSEQUENT EVENTS

On January 27, 2025, the OMB of the United States Federal Government instituted a pause (freeze) on the disbursement of federal grant and loan funds, which became effective on January 28, 2025. The extent to which the funding freeze impacts the Plan sponsor's operations, financial results and cash flows, will depend on future developments, which are highly uncertain and cannot be predicted with any measure of certainty or probability. Furthermore, the related effect of such funding freeze on the Plan sponsor's future employer matching contributions to the Plan, and eligible employee participation in the Plan, cannot be determined.
