NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

1. THE PLAN

The following brief description of Rehabilitation Support Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution deferred compensation 401(k) plan and covers substantially all of the employees of Rehabilitation Support Services, Inc. (the Agency) who meet certain eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Agency are eligible to begin salary deferrals and to receive employer profit sharing contributions after completing one (1) year of service, reach 21 years of age, and have worked 1,000 hours.

Contributions

The Plan automatically enrolls eligible participants at a deferral rate of 3% of participants' compensation. The Plan permits participants to change their deferral rate and contribute up to the statutory limitations. The Agency may also make a discretionary contribution for all eligible participants. The discretionary contribution for the plan years ended June 30, 2024 and 2023 was 5% of the compensation for all eligible participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Agency contributions. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Each participant chooses the fund, funds, or model in which contributions are to be invested. Contributions may be allocated between the funds in any percentage. A participant may change the fund, funds, or model into which contributions are invested or transfer all or any portion of the account balance between funds upon proper notification to the Plan administrator, logging into their participants account, or calling the Investment Advisor or Record keeper directly.

Vesting

Participant accounts become vested as to employer contributions based upon length of service and become fully vested when the participant completes six years of qualifying service, reaches normal retirement, dies, or becomes disabled while employed by the Agency. Vesting is calculated based on the following schedule:

Notes Receivable from Participants

Under the terms of the plan agreement, participants may be approved to borrow a minimum loan amount of \$1,000 subject to the maximum amount which cannot exceed the lesser of 50% of the vested account balance or \$50,000. The loans are secured by the participant's account (subject to the terms of the Plan and in accordance with applicable legal requirements). Participant loans are payable over a period no longer than five years, together with interest at market rates. However, loans made for the purchase of a primary residence may not exceed 30 years.

Payment of Benefits

Upon termination or retirement, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account in a lump sum amount. Distribution of benefits are payable upon a participant's (a) retirement, (b) disability, (c) death, or (d) termination of services with the Agency, under prescribed circumstances. Benefits to terminated participants are recorded when paid.

Forfeitures

Forfeitures shall be applied to offset future employer contributions to the Plan. During the years ended June 30, 2024 and 2023, approximately \$0 and \$226,000 of forfeitures, respectively, were used to reduce employer contributions. Available forfeiture balance at June 30, 2024 and 2023 were approximately \$206,000 and \$104,000, respectively. By the end of March 2025, approximately \$104,000 of forfeitures have been utilized to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are stated at fair value based upon quoted market prices. Changes in the current value of investments, including realized and unrealized gains and losses on assets sold and held during the year, are reflected in the statement of changes in assets available for benefits as net appreciation or depreciation in the fair value of investments. Dividends are recorded on the ex dividend date and purchases and sales of securities are recorded on a trade date basis (the date the order to buy or sell is executed) and interest income is recognized on the accrual basis. Both interest and dividend income earned during the year is reported as investment income on the statement of changes in assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in mutual funds and money market funds.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

The Plan's investments in mutual funds and money market funds are valued utilizing Level 1 inputs. Mutual funds and money market funds are valued based on quoted market prices in active markets.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The Plan currently has no investments utilizing Level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The Plan currently has no investments utilizing Level 3 inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. Interest earned on notes receivable from participants is recognized by the Plan in the period in which it is earned based on the outstanding principal balance times the stated interest rate at the date the note was made.

Benefits

Benefit payments to participants are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Any expenses paid by the Agency are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus, LLC, an affiliate of Ascensus Trust Company and Newport Trust Company, LLC, serves as the custodian of the Plan. Accordingly, Ascensus, LLC has certified that the following data included in the financial statements and accompanying supplemental schedule is complete and accurate as of June 30, 2024 and 2023, and for the following years then ended:

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Money market funds and mutual funds: Valued based on the amount reported by the custodian, based on the quoted market prices of the investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. A prototype document was used by the Plan to obtain its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. PARTIES-IN-INTEREST TRANSACTIONS

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between those participants who have loans and the Plan qualify as party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the affected participant accounts shall be distributed in accordance with the plan document.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of June 30, 2024, and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through March 20, 2025, which is the date the financial statements were available to be issued.
