## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of Worcester Academy DC Retirement Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Worcester Academy DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR-2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from the qualified institution as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### *Opinion*

In our opinion, based on the audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America; and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified information, except for obtaining and reading the certification, comparing the certified information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

Worcester Academy (the “Academy” or the “Employer”) has established a defined contribution benefit plan under Section 403(b) of the Internal Revenue Code. The defined contribution component is maintained for mandatory employee contributions and employer contributions. The tax deferred annuity component is maintained for voluntary employee contributions and rollovers. The net assets of both components are reported in these financial statements. The following description of the Worcester Academy DC Retirement Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan, adopted in 1960, covers all employees of the Academy except student employees. Summer program employees and coaches are also excluded for purposes of employer contributions. Eligible employees may immediately make elective participant contributions upon hire; however, participation is mandatory after attainment of age 21 and one year of service. Employees must be at least 21 years of age and complete one year of service to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – At age 21 and after one year of service, participants must contribute 5% of their pretax annual compensation, as defined in the Plan. In 2018, the Plan was amended to also allow Roth contributions. Participants may elect to make additional contributions in excess of 5% of compensation. Participants who are at least age 50 may make additional catch-up contributions. Participants who have completed 15 years of service with the Academy may make qualified organization lifetime catch-up contributions pursuant to Internal Revenue Code (“IRC”) section 403(b). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Academy will make discretionary employer contributions of 10% of each participating employee’s annual compensation, as defined, to eligible participants who have completed at least 18 years of service with the Academy as of June 30, 2021, while all other eligible participants will receive 7% in employer contributions.

**Investment Options** – Participants direct the investment of their contributions and the Employer contributions into various investment options offered by the Plan. The Plan currently offers traditional fixed annuity contracts, an insurance company separate account and variable annuities, and mutual funds as investment options for participants. Participants determine the percentage of which contributions are to be invested in each fund. Participants may change their investment options as set forth in the Plan document. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions and Academy contributions and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## 1. DESCRIPTION OF PLAN (CONTINUED)

*Vesting* – Participants are always 100% vested in their accounts.

*Participant Loans* – Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% as determined by the plan administrator. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Principal and interest are paid by individual bank transfers outside of the payroll system. Participant notes outstanding at June 30, 2024 and 2023, were \$144,724 and \$101,765, respectively.

*Plan Loans* – Participants invested in fixed annuity contracts may borrow amounts from TIAA up to a maximum equal to the lesser of \$50,000 or an amount which provides a sufficient remaining balance to cover 110% of the loan balance. Loans are secured by the balance in the participant's account and bear interest based on the interest rate of the underlying contract. Such loans are issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5) and do not represent plan assets. Amounts borrowed under this arrangement totaled \$8,407 and \$18,693 at June 30, 2024 and 2023, respectively, and are secured by participant balances of approximately \$9,250 and \$20,500 at June 30, 2024 and 2023, respectively. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs. Defaulted loans totaled approximately \$10,700 and \$10,200 at June 30, 2024 and 2023, respectively. Effective January 1, 2022, TIAA no longer issues plan loans.

*Payment of Benefits* – Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Terminated participants may leave their funds invested in the Plan, may elect five or ten year annual installments, or may elect a lump sum distribution. Upon retirement, disability, or death, a participant or his or her beneficiary may elect a lump sum distribution, annual installments or a joint and survivor annuity. Fixed annuity contracts are subject to restrictions for withdrawals.

A participant may also request a withdrawal from his or her account upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from financial hardship. In addition, a participant may withdraw rollover contributions from his or her account at any time.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Basis of Accounting* – The accompanying financial statements have been prepared using the accrual method of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participant would receive if they were to initiate permitted transactions under the terms of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

*Investment Valuation and Income Recognition* – The Plan’s investments are reported at fair value except for fully benefit responsive contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan’s valuation policies utilizing information provided by investments advisers, custodians, and insurance companies. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid.

*Other Income and Plan Expenses* – Other income consists of revenue service credits generated by Plan investments and is available to pay Plan expenses. Substantially all expenses incurred in the administration of the Plan are paid by the Academy. Unused revenue credits remain in the Plan to be available for future Plan expenses.

*Subsequent Events* – The Plan has evaluated subsequent events through April 4, 2025, the date the financial statements were available to be issued.

## 3. INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivables from participants for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF (insurance companies) and TIAA on behalf of TIAA, FSB (the custodian of the Plan).

## 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## 5. TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is an unallocated fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, with certain distinct features such as guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participants’ accounts, and the options for receiving income upon retirement. Certain traditional annuity contracts with no liquidity restrictions are considered fully-benefit responsive. Such contracts amounted to \$1,867,714 and \$1,956,833 at June 30, 2024 and 2023, respectively, and are reported at contract value in the accompanying financial statements.

## 5. TIAA TRADITIONAL ANNUITY (CONTINUED)

When participants choose to allocate a portion of their retirement savings to TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The traditional annuity also provides the potential for additional interest if declared by TIAA's board of trustees. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting interest rate was 3% in 2024 and 2023 and the average annual yield based on actual earnings was 4.41% and 4.22% for the years ended June 30, 2024 and 2023, respectively.

Contracts with restrictions on withdrawals or transfers may prohibit lump-sum withdrawals and require withdrawals in annual installments over ten years (five years after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits. The subsequent stream of annuity payments occurs outside the Plan and does not represent an obligation of the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

## 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include: quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## 6. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Non-Benefit Responsive Fixed Annuity Contracts* – The non-benefit responsive TIAA fixed annuity contracts are reported at contract value, which approximates fair value. The contract value equals the accumulated cash contributions and interest credited to the plan's contracts, less any withdrawals or transfers. The fixed annuity contracts are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. The TIAA fixed annuity contracts are considered Level 3. The crediting rate is supported by the investment performance of a large diversified portfolio (TIAA's general account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. A twenty-year analysis of crediting rate of TIAA Traditional annuity contracts suggests a rate of return that is representative of a market rate of this type product. Thus application of observed rates would yield a discounted cash flow which approximates contract value.

*Real Estate Separate Account* – reported at a unit value calculated based on the fair value of the underlying investments. The real estate separate account generally invests in real estate properties and real-estate-related investments. The fair value is principally derived from the market value of the underlying real estate holdings or other real-estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The real estate separate account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. Although the underlying assets of this account cannot be quickly sold and converted to liquid assets, TIAA provides a liquidity guarantee to ensure the account has funds available to meet participant withdrawals at quoted unit values. These investments may be redeemed quarterly with one day's notice. Transfers in and out of this account are restricted to one per quarter. There are no unfunded commitments related to these investments. The real estate separate account is listed on the NASDAQ website, and its unit value is updated overnight for each day that NASDAQ is open.

*Variable annuity contracts* – Variable annuity contracts holding CREF and TIAA Access funds are valued at the net asset value of the shares held by the Plan at year end, based on the fair values of the underlying investments. The accounts invest in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Investments are primarily valued using market quotation or prices obtained from independent pricing sources. Shares are redeemable on a daily basis and net asset value is determined each business day. There are no unfunded commitments related to investments in these variable annuities. The CREF accounts are listed on the NASDAQ website, and their unit values are updated overnight for each day that NASDAQ is open.

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds offered by TIAA are generally redeemable every 30 days. Some of the mutual fund offerings incur a 2% fee if redeemed in less than 60 days from purchase.

**7. RELATED PARTY TRANSACTIONS**

The Plan invests in insurance contracts, annuities and mutual funds sponsored by the Plan’s insurance companies and custodian. These transactions qualify as party-in-interest transactions. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are reflected as a reduction of net appreciation in fair value of investments.

**8. TAX STATUS**

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

**9. PLAN TERMINATION**

Although the Plan was established with the intention that it will continue indefinitely, the Academy retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.
