Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Timber Automation, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 29, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the two month period then ended February 29, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Timber Automation, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of February 29, 2024 and December 31, 2023, and for the two month period ended February 29, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Timber Automation, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the board of directors of Timber Automation LLC, the Plan Sponsor, voted to merge the Plan into the Wood Technologies International 401(k) Profit Sharing Plan effective January 1, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Timber Automation, LLC 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Summary of Significant Plan Provisions

The following description of the Timber Automation, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Timber Automation, LLC. (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by a committee within the Company. Fidelity Management Trust Company (the “Trustee”) serves as the trustee of the Plan, holds the Plan assets and maintains the records of the participant data.

Effective January 1, 2024, the Plan sponsor voted to merge the Plan into the Wood Technologies International 401(k) Profit Sharing Plan. The Plan transferred the assets into the plan on February 29, 2024, in the amount of \$11,547,277.

- b. **Eligibility** – Employees, who are not nonresident alien, leased, seasonal, temporary or intern employees are eligible to participate in the Plan upon attaining age 18 and completing 1 month of service. Plan entry dates are the first day of the month following the date the eligibility requirements are met. The eligible participants are automatically enrolled at 3% with an annual auto escalation until the deferral contribution reaches 6%.
- c. **Contributions** – Participants may contribute through pre-tax deferrals, as well as rollover contributions. Participants can defer up to the limits set forth by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective, November 3, 2023, the Plan elected to allow the participants to contribute through Roth contributions.

The Plan allows a QACA safe-harbor matching contributions to the Plan in an amount equal to a participant’s contributions, not to exceed 4% of the participant’s eligible compensation each payroll period. Employer contributions are subject to certain limitations by the IRS.

Additional amounts may be contributed by the Company under the Plan’s discretionary matching contributions and profit-sharing contribution provisions at the discretion of the Company’s board of directors. During the year ended December 31, 2023, no discretionary matching contributions or profit sharing contributions were made.

Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Summary of Significant Plan Provisions (cont.)

- d. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, employer matching contributions and allocations of employer profit sharing contributions and Plan earnings. Participant accounts are reduced with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant contributions, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are fully vested in their own contributions, plus actual earnings thereon. Employer contributions shall be fully vested upon death, disability or upon reaching normal retirement age of 65. If participants terminate employment for any other reason, they are entitled to the portion of discretionary matching and profit-sharing contributions made by the Employer according to the following schedule:

The Plan allows QACA safe-harbor contributions to be fully vested upon 2 years of service.

- f. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000. Note terms cannot exceed five years unless the note is for the purchase of a primary residence. The note is secured by the participant’s vested account balance and bears interest at a rate of prime plus 1%. Participants are limited to only one outstanding note. Principal and interest are paid ratably through payroll deductions.
- g. **Payment of benefits** – Upon retirement, termination of employment or disability, a participant or beneficiary in the event of death, may elect to receive a payment of benefits in a lump sum amount equal to the value of the participant’s vested interest in his or her account. Additionally, a participant may receive an in-service withdrawal from any portion of their account upon the age 59 ½. If the participant’s account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant’s consent before the participant’s normal retirement age will be rolled over to an individual retirement plan designated by the Plan administrator.

The Plan allows hardship withdrawals, subject to account balance limitations and applicable laws.

- h. **Forfeitures** – The portion of a participant’s account to which they are not entitled, as a result of being less than fully vested, shall be forfeited by the participant upon distribution. Forfeitures shall be used first to pay administrative expenses then to reduce employer contributions. During the two month period ended February 29, 2024, no forfeitures were utilized. The Plan had unallocated forfeitures of \$59,233 that were transferred to Wood Technologies International 401(k) Profit Sharing Plan as of February 29, 2024 and \$46,548 unallocated forfeitures as of December 31, 2023, respectively.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** - Investments are reported at fair value. Plan management determines the Plan’s valuation policies utilizing information provided by the Trustee. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. There was no allowance for credit losses as of February 29, 2024 and December 31, 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – The Plan allows certain administrative expenses to be paid from Plan assets.

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the Trustee of the Plan as complete and accurate, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule of assets held:

- a. Investments and note receivable from participant as shown in the accompanying statements of net assets available for benefits as of February 29, 2024 and December 31, 2023.
- b. Net appreciation in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits for the two month period ended February 29, 2024.
- c. Interest and dividends from investments and interest income on note receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the two month period ended February 29, 2024.
- d. All the investment information included in the footnotes as of February 29, 2024 and December 31, 2023.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at February 29, 2024 and December 31, 2023. During the two month period ended February 29, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Collective Trust Fund: This investment is stated at fair value as concluded to be readily determinable. The investment is based on the fair market value of the underlying investments, which is valued at net asset value (NAV) of unites of the collective trust fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain plan investments are issued by the Trustee that qualify as exempt party-in-interest transactions under ERISA. Certain fees incurred by the Plan are included in net appreciation in fair value of investments. The Plan also made direct payments to a service provider that are included in administrative expenses on the statement of changes in net assets available for benefits.

6. Tax Status

The Company adopted a Non-standardized Pre-Approved Profit Sharing Plan with CODA Plan (the "Prototype Plan") sponsored by the Trustee. The IRS has informed the Prototype Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Prototype Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

8. Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA.

The Plan will continue with a merger to Wood Technologies International 401(k) Profit Sharing Plan. A final amended Form 5500 for Timber Automation, LLC 401(k) Plan (EIN 47-4749928) will be filed in March of 2025.
