### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CMU Medical Education Partners Employee Profit Sharing Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of the Plan**

The following brief description of CMU Medical Education Partners Employee Profit Sharing Pension Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a participant-directed, defined contribution profit sharing pension plan covering all eligible employees of the Plan's sponsor, Saginaw Cooperative Hospitals, Inc. (Corporation), d/b/a CMU Medical Education Partners. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees are eligible to participate in the Plan when they have attained the age of 21 and have completed one year of service. One year of service means any Plan year in which 1,000 hours are worked. Rehired employees who had met the eligibility requirements prior to their termination will be immediately eligible to re-enter the Plan. Eligible employees enter the Plan on the earlier of the first day of the Plan year or the first day of the seventh month following the date on which eligibility requirements are satisfied.

**Contributions**

The Corporation can elect to make discretionary contributions to the Plan which will be "allocated" or divided among participants eligible to share in the contribution for the Plan year. For the years ended June 30, 2024 and 2023, the Corporation contributed 4% of each participant's eligible compensation. Employee contributions are not permitted.

**Participant Accounts**

Each participant's account is credited with an allocation of the Corporation's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Corporation's contributions and the earnings thereon are subject to forfeiture. Forfeitures of contributions reduce the Corporation's contributions under the Plan.

**Vesting**

Vesting in the Corporation's contribution to the participant's account plus actual earnings thereon is based on years of service as follows:

**Participant Loans**

Loans are not permitted under the Plan.

**Forfeitures**

Forfeitures of nonvested account balances are used to offset future employer contributions. As of June 30, 2024, there was a balance of \$156,822 in unapplied forfeitures, and a balance of \$75,775 in unapplied forfeitures as of June 30, 2023. Forfeited nonvested accounts from prior years were used to reduce employer contributions by \$231,474 in 2024 and \$615,850 in 2023.

**Payment of Benefits**

The Plan provides for payment of 100% of the account balance to participants upon normal retirement at age 65, death, or total and permanent disability. Participants terminating employment for any other reason are entitled to receive 100% of their vested account balances and the remaining nonvested portions would be forfeited. Participants may elect to receive their benefits in the form of an annuity or lump sum payment, based upon the Plan agreement.

**Administrative Expenses**

All expenses for the administration of the Plan are the responsibility of the Plan. The Corporation may, at its discretion, reimburse the Plan for some or all of these expenses. The Corporation paid for audit and certain pension plan administration expenses during 2024 and 2023.

## 2. Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy.

The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect a company's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended June 30, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

**2. Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value based on quoted market prices in an active market. See Note 4 for discussion of fair value measurements. Purchases and sales of mutual funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment income consists of the actual interest and dividends received on the underlying securities and is reported net of the realized and unrealized appreciation.

**Payment of Benefits**

The Plan recognizes benefit payments to participants when paid.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Subsequent Events**

Subsequent events have been evaluated through March 26, 2025, the date the financial statements were available to be issued.

**3. Financial Data Certified by the Trustees—Unaudited**

The Plan's financial information and data was certified by Newport Trust Company (Newport) from July 1, 2022 to April 17, 2024 and Ascensus, LLC (Ascensus) from April 18, 2024 to June 30, 2024 in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, interest and dividends, and net appreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by the trustees. This certified information has not been audited by independent auditors.

**5. Income Tax Status**

The Plan obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable section of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

**6. Party-in-Interest Transactions**

Newport/Ascensus are the trustees of the Plan and therefore qualify as parties-in-interest.

**7. Plan Termination**

Although it has not expressed any intent to do so, the plan sponsor reserves the right to terminate the Plan and the trust agreement at any time, upon written notice to the trustees and plan administrator. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. Risks and Uncertainties**

The Plan's investments consist of mutual funds. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and long-term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.
