## Notes to Financial Statements

August 1, 2024

### **1. Description of the Plan**

The following description of the Functional Pathways 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a controlled group defined contribution plan sponsored by Functional Pathways of Tennessee, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of Functional Pathways of Tennessee, LLC, Functional Pathways Preferred of Tennessee, LLC, East Tennessee EMG, Inc. and Revolution Industrial Group, LLC (collectively referred to as the “Plan Sponsor”), other than certain excluded employees (such as part-time, temporary, and seasonal employees), as defined, who were 21 or older and have completed 60 days of consecutive service, are eligible to become participants in the Plan generally effective on the first day of the quarter coinciding with or next following the date requirements are met.

Effective August 1, 2024, the Plan merged into the Strategic Retirement Program, a Pooled Employer Plan. Plan assets were transferred into the Plan effective August 1, 2024.

#### **Contributions**

The Plan Sponsor may make a discretionary matching contribution of each participant’s elective salary deferrals. A participant generally must complete at least 1,000 hours of credited service during the plan year and be employed on the last day of the plan year to receive any such contributions.

Participants may elect to contribute a percentage of their annual compensation or a fixed amount per pay period, on a pre-tax or after-tax basis, as a salary deferral. These deferrals are subject to the annual limitations defined by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change the investment options previously elected at any time.

Cash contributions receivable, if any, are unsecured.

**1. Description of the Plan (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant's relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Excess Contributions Payable**

Amounts payable to participants totaling \$40,660 as of December 31, 2023 for contributions in excess of amounts allowed by the IRS, were recorded as a liability with a corresponding reduction to participant cash contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15, 2024.

**Vesting**

Participants are immediately vested in their elective contributions, rollover contributions from other qualified plans, and related earnings thereon. Vesting in the Plan Sponsor's contributions plus related earnings thereon is based on years of continuous service. For Plan Sponsor contributions prior to January 1, 2022 plus related earnings thereon, participants vest ratably over five years after the first year of credited service. For Plan Sponsor contributions after January 1, 2022 plus related earnings thereon, participants vest based on credited years of service as follows:

3 years	100%

**Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or plan expenses. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Document.

As of December 31, 2023, forfeited nonvested accounts totaled \$4,481. Plan Sponsor cash contributions receivable were reduced in the accompanying financial statements by \$4,480 as of December 31, 2023 for the forfeitures used when the Plan Sponsor contributions were remitted to the Plan in 2024.

**1. Description of the Plan (continued)**

**Payment of Benefits**

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiaries) shall receive a lump sum amount equal to the vested value of his or her account. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions in accordance with the Internal Revenue Code (IRC). In-service hardship withdrawals are also available in certain circumstances.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting, as are the annual returns filed under applicable provisions of ERISA and the IRC.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

**Investments**

Empower Trust Company, LLC (Empower) holds the Plan's investments in various mutual funds and the Key Guaranteed Portfolio Fund, a fixed annuity option of Empower. Net appreciation or depreciation in the fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. This includes all investments bought or sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient, would be the recorded amount of such investment.

**Benefit Payments**

Benefits are recorded when paid.

**2. Significant Accounting Policies (continued)**

**Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

**Subsequent Events**

Plan management has evaluated subsequent events through March 24, 2025, the date the financial statements were available to be issued.

**3. Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by Tennessee Pension Administrators, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

**4. Certified Information (Unaudited)**

Empower holds the Plan's investments assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements, including investments held as of August 1, 2024 and December 31, 2023, net realized and unrealized appreciation in the fair value of investments, interest income from the Empower Key Guaranteed Portfolio Fund, investment income, and transfer to Strategic Retirement Program, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by Empower.

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

**5. Fair Value Measurements (continued)**

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of August 1, 2024 and December 31, 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**6. Key Guaranteed Portfolio Fund**

The Plan invests in a fixed annuity contract of Empower that is fully benefit-responsive. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

**7. Party-in-Interest Transactions**

Certain investments are held and managed by Empower; therefore, these transactions qualify as party-in-interest transactions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
