Notes to Financial Statements
June 30, 2024 and 2023

1. Description of the Plan

The following description of the U.M. FDSP Associates, P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - The Plan, established on July 1, 1985, is a defined contribution plan covering substantially all employees of the U.M. FDSP & Associates, P.A. (the Organization). There is no age or service requirement to participate in the salary deferral portion of the Plan. Employees must have one year of service in order to be eligible for matching and discretionary employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's management oversees the governance of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Plan was most recently amended and restated effective October 1, 2023 establishing Reliance Trust Company as the trustee of the Plan.
- B. Contributions - Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions (and employer contributions) into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. The Organization provides a matching contribution to the Plan equal to 100% of the employees' contribution up to 6% of the employees' annual compensation. The Plan allows for a discretionary contribution, as determined by the Organization's Board of Directors. During the years ended June 30, 2024 and 2023, no discretionary contributions were made. Contributions are subject to certain statutory limitations.
- C. Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's matching contributions, and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is also immediate upon entering the Plan.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with the local prevailing market rates determined by the Plan administration. Principal and interest are paid ratably through payroll deductions.

1. Description of the Plan (continued)

- F. Payment of Benefits - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of participant's vested interest in his or her account. As outlined in the Plan document, a participant may request a distribution from their voluntary contribution account for serious financial difficulties. The administrator of the Plan must approve each hardship request. Hardship withdrawals may not be repaid to the plan.
- G. Forfeitures - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$20,629 and \$225, respectively. For the years ended June 30, 2024 and 2023, \$-0- and \$483, respectively, of the forfeiture funds were used to reduce Organization's contributions or pay plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment according to the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of other observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available for all Plan investments.

Level 1 Fair Value Measurements

The fair value of the mutual funds and the money market fund are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses included in changes in net assets available for benefits for the years ended June 30, 2024 and 2023 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended June 30, 2024 and 2023, there were no significant transfers between Level 1 and Level 2 and no transfers into or out of Level 3.

5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of T. Rowe Price mutual funds and money market fund managed by DST Retirement Solutions, Inc., which is an affiliate of T. Rowe Price Services, Inc. T. Rowe Price is the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. As described in Note 2, the Organization pays certain expenses related to plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100 percent vested in their accounts.

7. Tax Status

The prototype for this Plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the prototype received its opinion letter. However, the plan administrator and the plan sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Nonexempt Transactions

During 2024 and 2023, there were certain pay periods where employee withholdings and loan payments totaling \$38,719 and \$19,739, respectively, were not timely remitted to the Plan by the Company. The Company has not yet made lost earnings to the Plan associated with the untimely remittances related to 2024. The Company has made lost earnings to the Plan associated with the untimely remittances related to 2023.

The Company has reviewed procedures and controls, and implemented changes, to mitigate the risk of similar errors in the future.

10. Subsequent Events

The Plan has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.
