Management has obtained certifications from a qualified institution for July 31, 2024 and December 31, 2023 and for the seven months ended July 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Weber Management, Inc. 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 5 to the financial statements, the governing body of Weber Management, Inc. 401(K) Plan approved a plan of liquidation on December 31, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the July 31, 2024 and December 31, 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Weber Management, Inc. 401(K) Plan's internal control. Accordingly, no such opinion is expressed.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

The following description of The Weber Management, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Weber Management, Inc. and Piney Woods Sanitation, Inc. Piney Woods terminated on May 4, 2023. The Plan was established January 1, 2018, amended and restated January 1, 2021, and was amended on May 4, 2023 to become a single employer plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan terminated effective December 31, 2023 and liquidated July 31, 2024.

Eligibility Requirements: Employees who have completed two months of service are eligible to participate in the Plan. There is no minimum age requirement for participation in the Plan.

Contributions: Participants contribute to the Plan in accordance with a participant salary deferral agreement, including Roth 401(K) deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Employers contribute a safe harbor match equal to 100% of deferrals up to 4% of compensation for each payroll period. The Plan also allows for direct rollover contributions from other qualified retirement plans and discretionary contributions from the employers. No discretionary contributions were made in 2024 and 2023. Participants direct the investments of contributions into various investment options offered by the plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, if any, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are 100% vested in participant contributions, including rollover contributions, plus actual earnings thereon. In addition, participants are 100% vested in all employer contributions upon entering the Plan.

Forfeitures: At July 31, 2024 and December 31, 2023, forfeited accounts totaled \$0 and \$0. Forfeited amounts are applied to Safe Harbor Contributions in the Plan year in which the forfeiture occurs. For the seven month ended July 31, 2024 and December 31, 2023, forfeitures applied to Safe Harbor Contributions totaled \$0 and \$0.

Distributions to participants: Lump sum distributions to Plan participants may be made as soon as administratively feasible following severance of employment.

Note receivable from participant loans: The Plan does not permit participant loans.

Administration: Digital Retirement Services (DRS), now known as July services, acts as the Plan record-keeper. Matrix Trust Company acts as Plan custodian. Charles Schwab Trust Company ("CSTC") and Matrix Settlement and Clearance Services (MSCS) are used to facilitate the exchange of information regarding account setup and administration, trading, and settlement between the Plans and mutual fund companies. In addition, July uses these companies to provide daily mutual fund and exchange-traded fund ("ETF") positions and pricing to facilitate the automated processing of trade, income, and position information. Allan Weber and Paul Weber are trustees of the Plan. Certain administrative and record-keeping costs are being absorbed by the Employer.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting: The Plan terminated effective December 31, 2023 and liquidated July 31, 2024. Accordingly, the accompanying financial statements are prepared on a liquidation basis, where all assets are recorded at their estimated net realizable value upon liquidation, reflecting the current market conditions and expected selling costs associated with the disposal of plan assets. The valuation of investments included adjustments to reflect anticipated selling costs and market conditions at the time of liquidation.

Investment Valuation and Income Recognition: Investments are recorded at fair value, except for group annuity investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Employers. No officer or employee receives compensation from the Plan for these services. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES: (Cont'd.)

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Reclassification: Certain amounts in the prior year financial statements have been reclassified for comparative purposes to conform to presentation in the current year financial statements. The overall reclassification has no impact on previously audited financial statements.

Subsequent events: Events that have occurred subsequent to July 31, 2024 have been evaluated through December 27, 2024, which represents the date the Plan's financial statements were available to be issued.

NOTE 3 - INVESTMENTS CERTIFIED BY CUSTODIAN:

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at July 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest, and dividends for the seven months ended July 31, 2024 were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company.

NOTE 4 - TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION:

The Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. The Plan terminated December 31, 2023. The Employer has notified the employees of the termination date and the distribution options for their plan assets. All affected employees will continue to be fully vested in their account balances.

The funds in the plan were frozen as of December 31, 2023. The liquidation of assets and final distributions were completed July 31, 2024.

NOTE 6 - TERMINATED PARTICIPANTS:

Net assets available for benefits at July 31, 2024 and December 31, 2023 include \$0 and \$988,668, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from participating in the earnings and operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participant. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

NOTE 8 - FAIR VALUE OF FINANCIAL INSTRUMENTS:

The Plan reports fair value of financial instruments in accordance with FASB ASC 820 (Statement of Financial Accounting Standards No. 157, *Fair Value Measurements*). FASB ASC 820 defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. FASB ASC 820 applies to reported balances that are required or permitted to be measured at fair value under existing accounting pronouncements; accordingly, the standard does not require any new fair value measurements of reported balances.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Valuation is based upon quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

- Level 2 Valuation is based upon quoted prices for similar assets or liabilities in active markets, quoted market prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Observable inputs may include interest rates, foreign exchange rates, and yield curves that are observable at commonly quoted intervals.
- Level 3 Valuation is based on methodologies that are unobservable and significant to the fair value measure. These may be generated from model-based techniques that use at least one significant assumption based on unobservable inputs for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment, and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in methodologies used as of July 31, 2024 and December 31, 2023.

The following is a description of valuation methodologies used for assets recorded at fair value.

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 9 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
