## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following brief description of the M & H Crates, Inc. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

M & H Crates, Inc. (the “Company”) established the Plan effective as of July 1, 1999. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(c)(7) and regulations there under of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Company, unless a committee or another administrator is appointed.

**ELIGIBILITY**

Employees of the Company are generally eligible to participate in the Plan after completing 1,000 hours of service within the plan year and attaining age 18. Participants who complete 1,000 hours of service during a plan year are eligible for allocations of contributions and forfeitures. Participants are eligible for allocations upon retirement, death or disability, regardless of the number of service hours performed during the plan year.

**CONTRIBUTIONS**

The Company may contribute to the Plan an amount determined at the sole discretion of the Company’s Board of Directors. Contributions to the Plan may be in the form of cash, common stock, or a combination thereof. Participant contributions are not permitted under the Plan.

**PARTICIPANT ACCOUNTS**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each Plan year with an allocation of shares of the Company’s common stock contributed, Plan earnings, and forfeitures of terminated participants’ non-vested balances. Allocations are based on participant’s eligible compensation, relative to total eligible compensation, as defined by the Plan. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance.

**VESTING**

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest ratably and are 100 percent vested after 6 years of service.

**VOTING RIGHTS**

Subject to provisions of the Plan, participants may direct the Trustee to vote the shares of Company stock allocated to the participants’ stock account. The Trustee shall vote any unallocated stock in the Trust Fund.

**PAYMENT OF BENEFITS**

Distributions on account of death, disability or normal retirement age, as defined by the Plan, are made no later than the Plan year following the event. Distributions for other separations from service commence no later than the sixth Plan year following the separation from service. Distributions of account balances exceeding \$5,000 are paid in equal annual installments over a period of up to five years. The period may be extended an additional year for each \$215,000 by which the value of an account exceeds \$1,080,000. Account balances equal to or less than \$5,000 are paid in a lump sum. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash or in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

**NOTE 1 – DESCRIPTION OF THE PLAN – CONTINUED**

**DIVERSIFICATION**

Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth and final year of the qualification period, the percentage increases to 50 percent. Participants who elect to diversify receive a cash distribution.

**PUT OPTION**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company repurchase any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock determined by an individual appraiser. The Company may pay for the purchase with interest over a period of five years after the date the put option is exercised.

**FORFEITURES**

Any portion of the final balance in a participant's account which is not vested will become a forfeiture as of the earlier of distribution of the entire vested account balance or the date the participant incurs five consecutive breaks in service after termination of employment. Non-vested participants are deemed to have received a distribution of their vested account the year following termination of employment.

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year, as defined by the Plan. Forfeitures of terminated non-vested account balances allocated to remaining participants during the year ended June 30, 2024 totaled approximately 6 shares, in the amount of \$15,440. There were no unallocated forfeitures as of June 30, 2024 and 2023.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the accounts of all participants affected will become fully vested and the assets remaining shall be distributed to the participants, former participants, and beneficiaries in proportion to their respective account balances.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The shares of Company common stock are carried at estimated fair value. Fair value of the common stock is determined by annual independent appraisals. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividend income is accrued on the ex-dividend date.

**PAYMENT OF BENEFITS**

Benefit payments are recorded when paid.

**ADMINISTRATIVE EXPENSES**

All expenses of maintaining the Plan are paid by the Company.

**PLAN MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS**

Subsequent events have been evaluated through April 1, 2025, the date on which the financial statements were available to be issued

**NOTE 3 – ADMINISTRATION OF PLAN ASSETS**

The Plan's assets, which consist of the Company's common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, who invests cash received and investment income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Company.

**NOTE 4 – INVESTMENTS**

**NOTE 5 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

**NOTE 5 – FAIR VALUE MEASUREMENTS - CONTINUED**

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no significant changes in the methodologies used at June 30, 2024 and 2023.

*M&H Crates, Inc. common stock:* The value of Company common stock is a Level 3 fair value measurement and is based on an annual independent appraisal. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the financial statements of the Company. The appraiser prepares a preliminary report which Plan management reviews in detail, discusses and approves. This appraisal was performed on a non-marketable, minority basis and was made on a going concern premise using a weighted average of the asset-based approach, utilizing the asset accumulation method, and the income approach, utilizing the capitalization of cash flow method. The appraisal techniques utilized are consistent with the prior year and are illustrated in the following table:

The Plan’s policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended June 30, 2024, there were no transfers into or out of Level 3.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 15, 2017 that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. Although the Plan has been amended since the date of the letter, the Plan Administrator and the Plan’s tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has concluded that there are no uncertain tax positions as of June 30, 2024 and 2023. The Plan is subject to routine audits by taxing authorities and currently has a routine IRS audit in progress. No results or report associated with the audit have been provided to the Plan Administrator; however, no negative results are currently anticipated by the Plan Administrator.

**NOTE 7 – RISK AND UNCERTAINTIES**

The Plan's investments consist of the Company's common stock, which is exposed to various risks, including interest rate, market, and credit, as well as valuation assumptions based on earnings, cash flows and other techniques. Due to the level of risk associated with the investment in common stock, it is reasonably possible that changes in the values of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under ERISA as any fiduciary to the Plan, any party rendering services to the Plan, the employer and certain others. As such, investments in Company common stock are related party and party-in-interest transactions. The Plan's service providers are also considered parties-in-interest. As described in Note 3, the Company pays all Plan expenses.

**NOTE 9 – FUTURE OBLIGATIONS**

Distributions from the Plan are required to be paid during the first or sixth Plan year following the separation from service, as described in Note 1. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions may be made in cash or in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

As of June 30, 2024, required future distributions from the Plan totaled approximately 798 shares, with an approximate value of \$1,795,189. The remaining shares will be distributed as soon as administratively possible. This estimated obligation will fluctuate based on the fair value of the shares.
