### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of American Agricultural Insurance Company Employees Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

## Notes to Financial Statements

Years ended June 30, 2024 and 2023

### **Note A - Description of Plan**

The following description of the American Agricultural Insurance Company Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of American Agricultural Insurance Company (AAIC or the Employer). All employees of the Employer (excluding leased and temporary employees) are eligible to participate in the Plan after attaining age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The AAIC/AFBIS Benefits Administration Committee is the Plan Administrator.

#### *Contributions*

The Plan provides for employee 401(k) deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax deferred limitations established by the Internal Revenue Code (IRC). Participants are also allowed to make voluntary after-tax and Roth 401(k) contributions, which are also subject to IRC limitations. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for annual employer discretionary matching contributions equal to 100 percent of the participant's contribution, not to exceed \$3,000.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution, allocations of the Employers' discretionary matching contribution, plan earnings, and charged with an allocation of mutual fund administrative expenses. Allocations are based on participants' eligible compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions, rollover contributions, the Employers' discretionary matching contributions, and actual earnings thereon subject to investment losses.

#### *Payment of Benefits*

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments.

### **Note A - Description of Plan (Continued)**

#### *Hardship Withdrawals*

Participants may request that all or a portion of their account be distributed in the case of severe financial hardship, as defined in the Plan document.

#### *Participant Notes Receivable*

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates at the time the loan is issued. Principal and interest are paid through scheduled payroll deductions.

#### *Party-in-Interest Transactions*

All plan assets are recordkept by Fidelity Investments, an affiliate of Fidelity Management Trust Company (FMTC). FMTC is the Trustee of the Plan. Transactions with Fidelity Investments qualify as party-in-interest transactions as defined under ERISA guidelines.

Personnel and facilities of American Agricultural Insurance Company have been used to perform administrative functions for the Plan at no cost to the Plan. Participants notes receivable also represent party-in-interest transactions.

#### *Plan Termination*

While they have not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan document and ERISA.

### **Note B - Summary of Significant Accounting Policies**

#### *Basis of Accounting*

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, based on quoted market prices. See Note D for a discussion of fair value measurement.

Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis.

### Notes to Financial Statements (Continued)

#### **Note B - Summary of Significant Accounting Policies (Continued)**

##### *Participant Notes Receivable*

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

##### *Benefit Payments*

Benefits are recorded when paid.

##### *Administrative Expenses*

The Plan pays certain administrative expenses such as record keeping, accounting, legal, and trustee services most of which are netted against investment income; all other expenses are paid by the Employer. Participants pay loan administrative costs.

##### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

##### *Subsequent Events*

The Plan has performed an evaluation of subsequent events through April 3, 2025, which is the date the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements.

#### **Note C - Certified Information**

Certain information related to investments and participant notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, net change in fair value of investments, interest from participant notes receivable, and interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC.

### Note D - Fair Value Measurement

GAAP establishes a three-level hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The levels of the hierarchy and those investments included in each are as follows:

**Level 1** – Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

**Level 2** – Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values for these instruments are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

**Level 3** – Inputs that are unobservable for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

#### **Note E - Tax Status**

The Plan has adopted a volume submitter plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the volume submitter plan document was designed in accordance with the applicable sections of the IRC. Although the Plan and the volume submitter plan document have been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax position and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements as of June 30, 2024 and 2023, in accordance with GAAP.
