NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Tax Deferred Annuity for Employees of Eastern Los Angeles Regional Center (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for more complete information.

A. General

The Plan is a tax deferred annuity plan for eligible employees of Eastern Los Angeles Regional Center for the Developmentally Disabled, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. All employees, except for nonresident aliens, off-site employees, and those represented by a bargaining unit, become eligible for participation upon hire.

B. Contributions

Participants may make voluntary pre-tax contributions and Roth contributions up to the limitations imposed by the Internal Revenue Code (the "Code"). Rollovers are also allowed. The Plan does not allow Company contributions.

C. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions and allocations of Plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations of Plan earnings are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

D. Vesting

Participants are immediately vested in their contributions, rollovers, and earnings thereon.

E. Investments

Participants direct the investment of their contributions among investment options offered by the Plan.

F. Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account. Participants may also elect to receive benefits while still working upon reaching retirement age. The Plan also permits financial hardship withdrawals.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Pooled separate accounts are reported at fair value using net asset value per share (NAV) as a practical expedient and have not been classified in the fair value hierarchy. Investment objectives are apparent from the name of each fund. They may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares. Unallocated insurance contracts are reported at contract value. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Interest and dividends are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes gains and losses on investments sold as well as held during the year.

D. Administrative Expenses

Substantially all costs of operating the Plan are paid by the Company.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at June 30, 2024 and 2023, and investment income for the year ended June 30, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan.

NOTE 4 - INTEREST ACCUMULATION FUND

The Plan's Interest Accumulation Fund is a fully benefit-responsive contract with Mutual of America comprising unallocated insurance contracts. Contributions to the Interest Accumulation Fund are maintained in a principal general account and credited for interest and charged for participant withdrawals and administrative expenses. Mutual of America is contractually obligated to repay

principal and a specified rate of interest that is guaranteed to the Plan. The Interest Accumulation Fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is deemed to be fair value of the fund under current accounting guidance because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is based on a formula established by Mutual of America but may not be less than 1% percent or greater than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The crediting rates for the year ended June 30, 2024 were 3.0% for participants who entered the Plan on or before March 1, 2008, and for participants who entered the Plan after March 1, 2008 were 1.00% January 2020 through December 2022, and 3.00% January 2023 through June 2024.

The Plan's ability to receive amounts due is dependent on Mutual of America's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Interest Accumulation Fund. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the funds of the Plan will be distributed based on individual participant balances.

NOTE 6 - TAX STATUS

Section 403(b) tax deferred annuity plans have not been required to obtain determination letters from the Internal Revenue Service stating they are qualified under the Code. However, the plan administrator believes the Plan has been designed and operated to comply with applicable requirements of the Code and is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting guidance requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by the custodian or its affiliates. Transactions related to these investments qualify as party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through January 23, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
