

#### A. Plan Description:

The following description of the Employee Benefit Plan of Candelen, Inc. (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

##### General:

The Plan is a participant-directed defined contribution plan sponsored by Candelen, Inc. (the Organization) covering all non-bargaining, full-time employees. Leased employees, contract employees and residents of Puerto Rico are excluded from participation. Participants are immediately eligible to participate and are automatically enrolled on the first day of the month following the 30-day notice requirement. Participants must attain 12 months of service to be eligible for employer matching contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The plan administrator is responsible for the oversight of the Plan. Fidelity Management Trust Company is the custodian and trustee of the Plan. Fidelity Investments serves as the recordkeeper, third party administrator, and 3(38) investment advisor.

##### Contributions:

Each year, participants may make traditional contributions up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans unless the rollovers are designated after-tax employee contributions or Roth contributions. Upon meeting the eligibility requirements described above, participants are automatically enrolled at 1 percent pretax deferrals unless an affirmative election is otherwise made. The Organization matched 100% of salary deferrals up to 3% from July 1, 2023, to July 28, 2023, and amended the match to 5% from August 1, 2023, to June 30, 2024. Effective July 1, 2024, the match will be reduced to 3%.

##### Participant Accounts:

Each participant's account is credited with the participant's contribution, allocation of the Organization's contributions plus plan earnings and an allocation of fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Investment Options:

Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan. Participants may change their investment allocations at any time.

#### A. Plan Description (Continued):

##### Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's matching contributions is based on years of continuous services. A participant is 100 percent vested after three years of credited service.

##### Forfeited Accounts:

Nonvested participants' accounts that are forfeited upon termination of service are used to reduce future employer contributions or pay plan expenses. The Plan held \$4 and \$26,826 of forfeited nonvested accounts at June 30, 2024 and 2023. Forfeitures of \$33,492 and \$0 were used to pay plan expenses or reduce employer contributions during the years ended June 30, 2024 and 2023, respectively.

##### Payment of Benefits:

On termination of service, reaching age 59.5 or becoming disabled, a participant is eligible for a lumpsum distribution of his or her vested account balance. The Plan also allows for hardship withdrawals with certain limitations. Terminated participants with vested balances of \$1,000 or less will have their balances distributed upon termination, while vested balances greater than \$1,000 but less than \$5,000 will be rolled into an Individual Retirement Account for the benefit of the participant. Participants may take a distribution from their rollover account at any time.

##### Notes Receivable from Participants:

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate comparable to the rate being charged by lending institutions in the same geographical locale as the Organization. Interest rates are fixed for the term of the loan. Principal and interest is paid ratably through payroll deductions. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence which may be approved for an extended repayment period).

#### B. Summary of Accounting Policies and Investments:

##### Basis of Accounting:

The accompanying financial statements are prepared under the accrual basis of accounting.

**B. Summary of Accounting Policies and Investments (Continued):**

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See *Note D* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

The Organization absorbs administrative and operating costs of the Plan. Fees related to the administration of the Plan or associated with the investment of plan assets may be paid by the Plan or by the Organization. Fees related to member requested services are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

#### C. Information Certified by the Plan's Trustee:

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan and a qualified institution, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.
- Investment and notes receivable from participants as shown in the accompanying supplemental information as of June 30, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedules.

#### D. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active or inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability or that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 or 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan. Mutual funds held by the Plan are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. Related Party and Party-In-Interest Transactions:**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments consist of mutual funds managed by the trustee. The Plan incurred administrative fees of \$12,662 and \$9,917 to the recordkeeper of the Plan during the years ended June 30, 2024 and 2023. The Organization provides certain administrative services at no cost to the Plan.

#### **F. Plan Tax Status:**

The Plan adopted a non-standardized pre-approved plan document provided by FMR, LLC. The pre-approved plan has obtained a favorable opinion letter, dated June 30, 2020, from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements for the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management performs an annual analysis of the Plan's various tax positions, assessing the likelihood of those positions being upheld upon examination by relevant taxing authorities. Management believes the Plan has conducted its operations in accordance with applicable income tax reporting requirements, and has properly maintained its tax-exempt status, and has taken no material uncertain tax positions that qualify for recognition or disclosure in the financial statements.

#### **G. Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **H. Nonexempt Party In Interest Transactions:**

During the year ended June 30, 2023, certain participant contributions totaling \$17,582 and participant loan repayments totaling \$911 were not remitted to the Plan timely and are considered to be delinquent. Plan management completed the calculation of lost earnings to correct participant accounts by June 30, 2024.

#### **I. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
