### **Opinion**

## **1. DESCRIPTION OF THE PLAN:**

The following description of the International Brotherhood of Electrical Workers Local No. 82 401(k) Plan (Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The International Brotherhood of Electrical Workers Local No. 82 401(k) Plan is a multi-employer defined contribution retirement plan covering eligible employees of those employers who have agreed to a collective bargaining agreement with the International Brotherhood of Electrical Workers Local 82. Employees are eligible to participate in the Plan upon completion of the first hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The participants are primarily located in Southwest Ohio. Therefore, the Plan is affected by the economic conditions of the region.

### **Contributions**

Participants may contribute up to the maximum percentage allowable not to exceed the limits of the applicable section of the Internal Revenue Code (IRC). The employers do not make any contributions to the Plan. The Plan also accepts employee rollovers from other qualified retirement plans.

### **Participant accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) Plan earnings, and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the amount that can be provided for by the participant's vested account. Participants are immediately vested in their contributions plus actual earnings thereon.

### **Investment options**

Investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions into any of the investment options provided by the Plan. Investment options include a money market fund and registered investment companies covering a broad range of investment objectives. Participants may change their investment options at any time using the Plan's automated system.

### **Payment of benefits**

Upon termination of service due to death, disability, or retirement, a distribution shall be made to the participant or beneficiary in a single lump sum payment or series of payments. For termination for any other reasons, or if contributions are no longer being made, participants can request a distribution under certain conditions. A participant who has incurred a hardship, as approved by the administrator, may elect in writing to make a hardship cash withdrawal, subject to Plan provisions. Participants may also receive in-service withdrawals, subject to Plan provisions.

### **Vesting**

Participants are immediately vested in their contributions to the Plan plus actual earnings thereon.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at year end.

### **Participant contributions receivable**

Participant contributions receivable represents amounts due from employers related to participant deferrals made prior to year end that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

### **Benefits**

Benefit payments to participants are recorded upon distribution.

### **New accounting standard**

The Plan adopted Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) No. 2016-13, Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, as amended, on July 1, 2023. Topic 326 modifies the measurement of expected credit losses on certain financial instruments. The Plan adopted this new guidance utilizing the modified retrospective transition method. The adoption of this Standard did not have a material impact on the Plan's financial statements.

### **Subsequent events**

The Plan has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There has been no change in the methodology used at June 30, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing prices as reported by the funds. The funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price at the end of each trading day. The funds held by the Plan are deemed to be actively traded.

**3. FAIR VALUE MEASUREMENTS (CONTINUED):**

**4. TAX STATUS:**

The Internal Revenue Service has determined and informed the Plan by a letter dated May 4, 2015, that the Plan, as amended and restated effective July 1, 2014, and related trust are designed in accordance with applicable sections of the IRC. The Plan is required to operate in conformity with the IRC and ERISA to maintain its tax exempt status. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**5. PLAN TERMINATION:**

In the event the Plan is terminated, any obligations of the Plan would be paid and all remaining net assets would be distributed to participants in the manner specified in the Plan document.

**6. RISKS AND UNCERTAINTIES:**

The Plan invests in various investments. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
