## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

### Opinion

We have audited the financial statements of the Stone and Marble Masons of Metropolitan Washington, D.C. Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the accounting principles generally accepted in the United States of America.

### Basis for Opinion

**NOTES TO FINANCIAL STATEMENTS**

JUNE 30, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Stone and Marble Masons of Metropolitan Washington, D.C. Annuity Plan (the Plan), provides only general information purposes only. Participants should refer to the Plan's governing documents for more complete information.

**General** - The Plan is a collectively bargained multiemployer defined contribution retirement plan covers participants and their dependents, who are within the jurisdiction of the Bricklayers and Allied Craftsmen Local Union No. 1 of MD, DC, & VA (the Union), and employed by participating employers who are subject to the Agreement and Declaration of Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Benefits** - The Plan provides for normal retirement at age 65 or, if later, your age on the fifth anniversary of the date your participation in the Plan began. The Plan also provides for severance from covered employment and disability retirement benefits upon meeting certain conditions.

**Participant Accounts** - Each participant's account is increased with the contributions received on behalf of the participant, decreased by any distribution to or on behalf of the participant and is adjusted for any allocation of Plan's net investment income and Plan administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - All participants are fully vested in their account balance upon completion of one hour of service in a plan year.

**Payments of Benefits** - A participant who is eligible to receive retirement benefits may elect to receive benefits in one lump sum amount equal to the value of their account.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Investment Valuation and Income Recognition** - Investment in mutual funds is carried net asset value of the fund which generally represents quoted market prices at the last business day of the Plan's year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Funding Policy and Revenue Recognition** - The Plan is funded entirely by employer contributions. Participants do not contribute to the Plan. All contributions are made in accordance with collective bargaining agreements in effect between the employers and the Union. These agreements provide that employers contribute to the Plan on behalf of each covered employee on the basis of a fixed rate per hour. Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis.

Employers' contributions receivable represents amounts due under the term of collective bargaining agreements. Employer contributions are recorded in the period in which the hours giving rise to the contribution are worked. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

**Payment of Benefits** - Benefits are recognized upon distribution.

**NOTE 3. PRIORITIES UPON TERMINATION**

It is expected that the Plan will continue indefinitely. The Plan shall terminate if and when it is declared terminated in writing by resolution of the Board of Trustees. Upon termination or partial termination of the Plan, the rights of each participant to the benefits that he or she had accumulated to the date of such termination shall be nonforfeitable.

**NOTE 4. TAX STATUS**

The Plan's Administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

## NOTE 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended June 30, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

There have been no changes in valuation methodologies at June 30, 2024 and 2023.

**NOTE 6. RELATED PARTY TRANSACTIONS**

During the years ended June 30, 2024 and 2023, the Stone and Marble Masons of Metropolitan Washington, D.C. Pension Trust Fund (the Pension Fund) paid expenses on behalf of the Plan. As of June 30, 2024 and 2023, \$138,228 and \$72,117, respectively, was due to the Pension Fund.

During the year ended June 30, 2023, the Stone and Marble Masons of Metropolitan Washington, D.C. Health and Welfare Trust Fund (the Health and Welfare Fund) paid expenses on behalf of the Plan. During the year ended June 30, 2024, the Pension Plan paid \$2,000 to the Health and Welfare Fund on behalf of the Plan. As of June 30, 2024 and 2023, \$0 and \$2,000, respectively, was due to the Health and Welfare Fund.

Employers made contribution payments into the Stone and Marble Masons of Metropolitan Washington, D.C. Health and Welfare Trust Fund (the Health Fund) that were for the Plan. As of June 30, 2024 and 2023, \$24,986 and \$23,967, respectively, was due from the Health Fund.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 8. CONCENTRATION OF RISK**

Contributions from three employers accounted for 77% and 73% of total contributions received by the Plan during the years ended June 30, 2024 and 2023, respectively. If contributions from these employers were to cease, it could have a significant impact on the Plan and its net assets available for benefits.

**NOTE 9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through April 2, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
