**NOTE 1      DESCRIPTION OF PLAN**

The following description of the LifePath, Inc. 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of LifePath, Inc. (“Organization”) who have three consecutive months of service or one year of service, if earlier, and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may elect to contribute up to 100% of their eligible compensation beginning three months following their date of hire. Contributions are limited by the IRS annual maximum. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes a provision for matching employee contributions; Upon ratification of the Plan sponsor’s union contract, effective October 1, 2022, employees who participated in the Plan and elected to contribute between 2.5% and 5% of their base rate salary, were eligible for a 50% match of their contribution. The 2% match for those that contributed 5% or greater was removed. Prior to the ratification, 2% of an eligible employee’s base rate salary was matched when the employee contributed 5% or more of their base rate salary. Employees that elected to contribute between 2.5%-5% were eligible for a 40% match of their contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Participant Accounts

Each participant’s account is credited with the participant’s and Plan Sponsors’ contributions and allocations of the organizations’ contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their salary deferrals including catch-up contributions, rollover contributions, and matching contributions. Participants vest 100% in their profit-sharing contributions after three years of service.

Payment Benefits

Vested account balances that do not exceed \$5,000 may only be distributed in a single lump-sum payment and can be done regardless of whether the terminated participant consents to receive it. Vested account balances exceeding \$5,000 may only be distributed upon consent of the participant and may be received as a single lump-sum payment, installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancies of the participant and his/her beneficiary), or partial withdrawals of at least \$1,000.

Notes Receivable from Participants

During the years ended June 30, 2024 and 2023, several participants borrowed money against the vested portion of their accounts. The notes bear interest at APR rates between 4.25% and 9.5% and the rate does not change for the life of the loan. Initial notes receivable require a minimum loan amount of \$1,000 up to a maximum of \$50,000 or 50% of the vested account balance, whichever is less. Loan repayments credited to a particular account of a participant are reinvested in proportion to the participant's most recent investment directive. Participant loans are recorded at amortized cost and are presented as "notes receivable from participants" on the statements of net assets available for benefits

Forfeitures

On June 30, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. Forfeited accounts will be used to reduce future employer contributions.

**NOTE 2**      **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments stated at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. See Note 5 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis.

Investment Valuation and Income Recognition (continued)

Dividends are recorded on the ex-dividend date. Plan investments are part of the Reliance Series Trust.

Net investment gain or loss from registered investment companies represents dividends as well as net realized and unrealized appreciation and depreciation in the fair value of investments.

Net investment gain from common/collective trusts represents interest and dividends earned on assets held in trust as well as unrealized and realized appreciation and depreciation in the fair market value of the assets held in trusts.

Notes Receivable from Participants

Notes receivable are stated at the amount deemed collectible. All notes are deemed current. Interest is recognized as payments are received based on the stated interest rate of the note. Fees for the administration of notes receivable from participants are included in administrative fees and charged directly to the participant's account.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Income Tax Status

The Plan obtained its determination letter on December 19, 1990 in which the Internal Revenue Service stated that the Plan, as then designed, met the applicable requirements of the Internal Revenue Code. The Plan was amended and received a favorable determination letter from the Internal Revenue Service dated March 31, 2014. The Plan has been amended since receiving the latest determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Change in Accounting Standard

On July 1, 2024, the Plan adopted FASB ASU 2016-13, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments, and all related subsequent amendments thereto. This ASU replaced the incurred loss method of measuring financial assets with an expected loss method, which is referred to as the current expected credit loss (CECL) method. CECL requires an estimate of credit losses over the life of the financial asset using historical experience, current conditions, and reasonable and supportable forecasts. As of June 30, 2024, management believes all of the Plan’s current financial assets are excluded from the CECL standard.

**NOTE 4      FAIR VALUE MEASUREMENTS**

Fair value accounting guidance defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosure about fair value measurements.

Fair value measurements are determined under a three-level hierarchy, which gives the highest priority to quoted prices in active markets and the lowest priority to unobservable inputs. The three levels of the hierarch are as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology, other than Level 1 inputs, that are based on observable market data. These include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement, reflecting the Plan's own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value.

There has been no change in the methodologies used at June 30, 2024 and 2023.

For investments that have quoted market prices in active markets, the Plan uses quoted market price as fair value and includes these investments in Level 1 of the fair value hierarchy. The Plan classifies publicly traded registered investment companies (mutual funds) as Level 1. When quoted market prices in active markets are not available, the Plan uses a pricing service to estimate fair value. The fair value estimates obtained from this pricing service are included in Level 2 of the fair value hierarchy. Level 3 inputs would only be used when Level 1 and Level 2 inputs were not available.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 FEDERATED HERMES CAPITAL PRESERVATION FUND (R6 PRICING)**

The R6 Pricing fund is a collective investment fund that seeks to maintain a stable value of \$10.00 per unit. The fund does not guarantee that the value of its units will always remain at \$10.00. The fund’s investment objective is stability of principal and high current income. The fund pursues this investment objective by investing primarily in guaranteed investment contracts (GICs), money market products and other stable value products. Some of the investment contracts within this fund meet the fully benefit-responsive investment contract criteria. Therefore, the fund is reported at contract value. Contract value is the relevant measure for fully benefit-investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may purchase units of the fund daily based on the established unit value of \$10.00. Participants may redeem units of the fund for the purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the Plan to another investment election that is a noncompeting investment, or paying trustee fees. Participants may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the trustee. All participants of the fund have a proportionate undivided interest in all assets of the fund. Net investment income is distributed to participants monthly and is reinvested to purchase additional units. The contract value of this fund was \$858,095 and \$1,414,872 at June 30, 2024 and 2023, respectively.

**NOTE 6**      **COMPLIANCE**

During the year ended June 30, 2023, there was a manual bonus run that was paid on August 9, 2022, where a small group of employee contributions were collected but not remitted. This caused a failure to transmit participant contributions within the time described in 29 CFR 2510.3-102. On October 31, 2022, the employee withholdings totaling \$1,883 were submitted to the Plan. Subsequently, the Plan sponsor elected to correct the error outside VFCP and instructed their TPA to report a late 2022 payroll on the 6/30/2023 Form 5500, calculate the earnings and prepare Form 5330 to pay any excise tax owed. The calculated lost earnings due to the affected participants in the Plan was \$ 6.75. Payment was made prior to 12/7/2022.

For the years ended June 30, 2024 and 2023, the Plan employer contributions include qualified nonelective contribution (QNEC) in the amounts of \$31,901 and \$47,182, respectively and a QNEC match in the amounts of \$8,077 and \$8,239, respectively. These contributions were made in response to the determination that the formula used to calculate Roth deferrals did not agree to the Plan document, thereby causing Roth deferrals to be below the participants elected percentages. The Plan sponsor corrected the formula and recalculated the deferrals for all Roth participants. The correct formula is now being used for all deferral calculations and the Plan sponsor has implemented additional controls to prevent future errors. The Plan sponsor believes this error to be eligible for self-correction as an insignificant operational failure.

**NOTE 7**      **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8      PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from Plan participants and the related interest income are considered party-in-interest transactions. There were no other party-in-interest transactions between the Plan and the trustee or TPA of the Plan, other than the payment of fees from the Plan assets for services rendered.

**NOTE 9      ADMINISTRATIVE COSTS**

Administrative costs paid by the Plan during the years ended June 30, 2024 and 2023 were \$144,645 and \$132,434, respectively. Effective April 1, 2022, the Plan sponsor is required to pay for the 3(16) services and does not charge the Plan.

**NOTE 10     RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments could occur and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 11     SUBSEQUENT EVENTS**

The Plan sponsor has evaluated subsequent events of the Plan through April 5, 2025, the date which the financial statements were available to be issued.
