Independent Auditor's Report

To the Board of Directors
Duffy Health Center, Inc. 403(b) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Duffy Health Center, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Duffy Health Center, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

General – The Plan is a defined contribution plan covering all employees of the Health Center if they are at least 21 years of age except employees who normally work less than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”).

Contributions – At the employee’s discretion, employees may contribute to the Plan. Contributions are subject to annual dollar limitations established by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Health Center may make discretionary matching contributions to participants; no discretionary matching contributions were made during the year ended June 30, 2024. The Health Center may also make non-elective profit-sharing contributions based on a participant’s eligible compensation relative to total eligible compensation. For the year ended June 30, 2024, the Board of Directors of the Health Center approved non-elective profit-sharing contributions totaling \$114,917. To be eligible for matching and non-elective profit-sharing contributions, participants must first complete 3 consecutive months of service, as defined in the plan document.

Participant Accounts – Each participant’s account is credited with the participant’s voluntary contribution, the Health Center’s discretionary matching and non-elective profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of plan earnings are based on a participant’s account balance relative to the total account balance of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Ascensus Trust Company is the custodian for the Plan. At June 30, 2024, participants could direct their contributions to approximately forty (40) investment options/funds offered by Ascensus Trust Company.

Vesting – Participants are immediately fully vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 50% vested after two years of service with 100% vesting after three years of credited service. Participants automatically become fully vested upon death or becoming disabled while under the employment of the Health Center.

Payment of Benefits – A participant may not make withdrawals from their elective account except for:

- (1) Normal retirement - age 65;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

Distributions will be paid as soon as possible following termination date, except for financial hardship withdrawals which are payable immediately. Distributions are paid to participants in a lump sum or non-recurring partial payments.

1. Description of Plan (continued):

Forfeited Accounts – Under the Plan, forfeitures of terminated participants’ nonvested accounts may be used to reduce the Health Center’s discretionary contribution to the Plan or to pay plan expenses. During the year ended June 30, 2024, forfeitures used to reduce employer contributions were \$2,591 and forfeitures used to pay plan expenses were \$12,485. At June 30, 2024 and 2023, forfeitures available to reduce future employer contributions or pay plan expenses were \$43 and \$10,254, respectively.

2. Summary of Significant Accounting Policies:

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Contributions from Plan participants and the Health Center’s contributions are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Operating Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Health Center. Expenses that are paid by the Health Center are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through April 3, 2025, the date the financial statements were available to be issued.

3. Tax Status:

The Plan has adopted a 403(b) volume submitter plan designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination:

Although it has not expressed any intent to do so, the Health Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and would be entitled to the full value of their account.

5. Investments:

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus Trust Company served as the Plan's custodian. They have provided the Plan administrator with certifications as to the completeness and accuracy of cash, investment balances, supplemental schedules, interest and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations.

6. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. Fair Value Measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Money market funds: Valued at the daily closing prices as reported by the fund. The money market funds are open-end mutual funds that are registered with the Securities and Exchange Commission. The money market funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Transactions With Parties-in-Interest:

The Health Center provides certain accounting and administrative services to the Plan for which no fees are charged. The employees that provide these services are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions.

Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the custodian and recordkeeper for the plan and, therefore, transactions with Ascensus Trust Company qualify as party-in-interest transactions.

8. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
