Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Meriwether-Godsey, Inc. Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. Note 1 - Description of Plan

The following description of the Meriwether-Godsey, Inc. Profit Sharing & 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Meriwether-Godsey, Inc. (the “Company”) who have 60 days of service and are age twenty-one or older. The Plan was established July 1, 1991 and amended effective September 1, 2022. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for participant contributions of up to 90% of pretax or after-tax (Roth) annual compensation, as defined in the Plan. Company matching contributions are discretionary and are determined annually by the Company’s Board of Directors. For the plan years ended June 30, 2024 and 2023, deferrals were matched on 50% of employee’s total eligible deferrals, up to 3% of total compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additional amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations.

Participant accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. Forfeited balances of terminated participants’ non-vested accounts are allocated among participants eligible to share for a plan year; however, a portion may be used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

Investment options

Upon enrollment in the Plan, participants may direct the custodian of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

Participant Loans

Participants may borrow from their Plan accounts. Loan terms cannot exceed five years, unless proceeds are used to acquire a principal residence. The loan amount cannot exceed fifty percent of the vested account balance and must be made for at least \$1,000 but less than \$50,000. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Distribution of the vested portion of a participant's account will occur upon the participant's termination due to death, disability or retirement, as defined in the Plan. For termination of service due to other reasons, if a participant's vested account balance is less than \$5,000, the participant will receive a lump-sum amount automatically. If a participant's vested account balance is more than \$5,000, the participant may elect to receive the value of the vested portion of their account as a lump-sum distribution, a partial distribution of their account, or annual installments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary.

Participants who have obtained age 59 ½ may elect to receive in-service distributions of their vested account balance. In certain situations, a participant may receive a hardship withdrawal from the participant's vested portion of their account.

Note 2 - Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Shares of mutual funds and units of common collective trusts are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. If quoted prices are unavailable, estimated fair values are based on comparable investment of other issues with similar credit ratings. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Common/collective trusts

Individual participant accounts for the common/collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Participant loan receivables

Participant loan receivables are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Forfeitures

Plan forfeitures may be used to reduce the employer's contributions or reduce administrative expenses to the Plan. During the Plan years ending June 30, 2024 and 2023, \$881 and \$-0-, respectively, of forfeitures were used to reduce employer contributions. During the Plan years ending June 30, 2024 and 2023, \$-0- and \$-0-, respectively, of forfeitures were used to reduce employer contributions.. Forfeitures of \$2,894 and \$1,112 are available at June 30, 2024 and 2023, respectively, to be used to reduce future employer contributions.

Excess contributions

Excess contributions represent excess participant deferrals due back to the participant as a result of year-end plan testing.

Credit risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Administrative Expenses

Although not required by the Plan, a portion of the costs of Plan administration is absorbed by the Company.

Note 4 - Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. No change in the valuation methods occurred as of June 30, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investments – Valued using quoted prices in active markets for identical assets.

Common collective trusts – Valued at the Net Asset Value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Trustees shall determine whether the assets of the Plan shall be liquidated and distributed or whether the assets shall continue to be held in trust and distributed in accordance with the terms of the Plan. Upon Plan termination, all participants will become 100% vested in their accounts.

Note 8 – Tax Status

The Internal Revenue Service has determined by letter dated October 6, 2020, that the adopted prototype plan is qualified under the appropriate sections of the Internal Revenue Code. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to June 30, 2021.

Note 9 – Financial Information Certified by the Custodian of the Plan

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
