INDEPENDENT AUDITORS' REPORT

To the Trustees of

Jackson Heights, New York

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jackson Child Development Corporation Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Note 1 – Description of Plan

The following description of the Jackson Child Development Corporation Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Jackson Child Development Corporation (the “Company”) except those covered by collective bargaining agreements, leased employees, or non-resident aliens. Employees are eligible on the first day of the Plan year nearest to attainment of age 21 and completion of one year of eligibility service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has individually designated trustees who are responsible for oversight of the Plan, determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

The Plan was amended in October 2022 with an effective date of March 27, 2020, to implement the provisions of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) which affect the Plan and include the coronavirus-related distributions relief provisions; the increased loan limit provisions; the loan repayment extension; and the Required Minimum Distribution waivers for 2020 unless the participant or beneficiary chooses to receive the distribution.

Contributions

The Company may make a profit-sharing contribution at the sole discretion of the Company’s Board of Directors, which is invested in a portfolio of investments as directed by the Company. Voluntary employee contributions are not permitted. During the year ended June 30, 2024, the Company made a discretionary profit-sharing contribution of \$646,540 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

A participant’s vesting in the Company’s profit-sharing contribution is based on years of continuous service, as defined. A participant is 100% vested after six years of credited service. Participants shall also become 100% vested upon attainment of normal retirement age, death, or disability, while an employee of the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than 2 notes outstanding at any time. The notes are secured by the balance in the participant’s account. The note interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through bi-monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, participants with account balances over \$5,000 remain in the Plan until the participant elects to receive an amount equal to the value of the vested interest in his or her account as a lump-sum distribution. A participant will receive an involuntary lump-sum distribution if the total vested balance is \$5,000 or less at the time of distribution. In-service distributions are permitted upon attaining the age 59½ or for required minimum distributions. Hardship distributions are not permitted.

Forfeited Accounts

If a participant terminates his or her employment before becoming 100% vested, he or she forfeits any nonvested amounts. The nonvested portion of a participant's account is forfeited as of the date of distribution of his or her vested interest and may be used to reduce future Company contributions or pay Plan expenses. During the plan year ended June 30, 2024, forfeitures totaling \$29,142 were used to pay Plan expenses, forfeitures totaling \$10,799 were used to restore forfeited account balances, and forfeitures totaling \$182,916 were reallocated as additional employer contributions. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$179,916 and \$47,342, respectively.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with various effective dates beginning January 1, 2023 and beyond. These provisions are intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. Some of the provisions are optional and require the Plan sponsors to amend the Plan to adopt the provision.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with original maturities of three months or less to be cash equivalents. Cash equivalents held by the Plan at June 30, 2024 and 2023, which consist of a money market fund, totaled \$179,607 and \$47,342 respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through the date of the report, which is the date the financial statements were available to be issued. See Note 10 for subsequent events disclosure information.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: A collective trust fund comprised of fully benefit-responsive investment contracts, that is valued at the NAV of units of the bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the contract is determined using level 2 inputs.

Note 4 – Related Party and Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services to the Plan. Fees paid directly by the Plan include audit, investment management and recordkeeping services. Administrative expenses for the year ended June 30, 2024 amounted to \$66,501. These transactions qualify as exempt party-in-interest transactions.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 6 – Tax Status

The Plan is structured and follows a non-standardized prototype profit-sharing plan with cash or deferred arrangement (CODA) pre-approved by the IRS. The IRS issued an opinion letter dated November 30, 2020, that the prototype plan is acceptable in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 – Risks and Uncertainties (continued)

The Plan maintains deposits in reputable financial institutions that may at times exceed amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation (FDIC). As of June 30, 2024 and 2023, there were no amounts in excess over the insured amount. The Plan believes that there is no significant risk with respect to such deposits.

Note 8 – Trustee Certification

Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year), related to investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan.

Note 9 – Delinquent Loan Repayments

During the year ended June 30, 2024, the Company did not remit to the Plan's custodian participant note repayments totaling \$7,672 within the period prescribed by the Department of Labor regulations. The Company intends to correct this error and will make a contribution to the affected participants' accounts to compensate the participants for the potential lost earnings resulting from the delays in remitting the note repayments. The delinquent note repayments are included in the supplemental Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions for the year ended June 30, 2024.

Note 10 – Subsequent Event

In February 2025, the Company remitted the lost earnings on the 2024 delinquent note repayments (see Note 9).
