#### 1. Plan Description

The following description of Oregon Food Bank Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions.

##### **General**

The Plan was established to provide a retirement savings program for the employees of Oregon Food Bank, Inc. (the “Company” or “employer”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Plan’s administrator is Oregon Food Bank, Inc. (the “Plan Administrator”). A committee of administrators is responsible for oversight of the Plan. The administrative committee also determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

##### **Eligibility**

Employees of the Company are eligible to participate in the employee salary deferrals portion of the Plan upon completion of one month of service.

Employees of the Company, who have completed one year of service as defined by the plan document, are eligible to participate in the nonelective employer profit sharing portion of the Plan. Employees enter the nonelective employer profit sharing portion of the Plan on the first day of the month coinciding with or next following the completion of the eligibility requirements.

Employees of the Company, who have completed one year of service as defined by the plan document, are eligible to participate in the nonelective employer safe harbor contributions portion of the Plan. Employees enter the nonelective employer safe harbor contributions portion of the Plan on the first day of the month coinciding with or next following the completion of the eligibility requirements.

Temporary employees are excluded from participation in the Plan until they have worked more than 1,000 hours during a measurement period. On-call employees are excluded from participation in the Plan.

##### **Contributions**

Participants may elect to contribute a portion of their compensation, as defined by the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions as permitted by the Internal Revenue Code. Participants may also contribute as rollover contributions amounts representing distributions from certain other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested into a default fund until changed by the participant.

Additionally, the Company may choose to make safe harbor and discretionary non-elective contributions based on a percentage of eligible participants’ compensation for the plan year. During the year ended June 30, 2024, the Company made safe harbor and profit sharing contributions to the Plan totaling \$953,113.

Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, and employer safe harbor and profit sharing contributions, plus actual earnings thereon.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms may not exceed five years unless the loan is used to acquire a dwelling unit which will be used as the principal residence of the participant, as defined by the Plan.

#### **Payment of Benefits**

On termination of service due to death, disability, termination of employment, or retirement, a participant or his or her beneficiary is eligible to receive payments in the amount equal to the value of the participant's vested interest in his or her account. A participant may elect to receive either a lump-sum amount equal to their account balance or installment payments, as permitted by the Plan. Vested account balances not exceeding \$7,000 will be automatically distributed, as soon as administratively feasible, following termination of employment.

#### **Forfeited Accounts**

If a participant terminates employment with the Company before becoming fully vested, the unvested portion of his or her account is forfeited and the amount attributable to employer contributions may first be used to pay administrative expenses. Any remaining amounts may be used to reduce future employer contributions. At June 30, 2024, no material forfeited nonvested accounts were held by the Plan.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investments and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. If a participant ceases to make loan repayments, and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

Management has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Fair values are provided to the Plan by the investment custodian for all of the Plan's assets as follows:

- **Common/collective trust:** Investments in common/collective trust investments are valued at the net asset value ("NAV") of units of a collective investment trust. The NAV, as provided by the trustee, is used to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This value is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions, including purchases and sales, are valued on a daily basis. Certain participant-initiated withdrawals may be executed subject to a temporary redemption notice period. Were the Plan to initiate a full redemption of the Invesco Stable Asset Fund, under the terms of the collective trust agreement the investment issuer reserves the right to temporarily delay withdrawal from the fund for up to one year. At June 30, 2024, the average yield and crediting rate earned by the fund were approximately 5.00 percent and 2.88 percent, respectively.
- **Registered investment companies:** Registered investment companies and other mutual funds are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at June 30, 2024 and 2023.

#### 5. Related Party and Party-In-Interest Transactions

ADP Retirement Services serves as the Plan's third-party administrator. Accordingly, transactions with ADP Retirement Services qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management services are included in net appreciation in fair value of the respective investment as they are paid at the investment level, rather than by direct payments from the Plan. For the year ended June 30, 2024, the Plan made net direct payments for administrative expenses totaling \$8,704. The plan sponsor pays directly certain other fees related to the Plan's operations.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be 100 percent vested in their employer contributions.

#### 7. Tax Status

The Plan has adopted a volume submitter profit sharing plan agreement which the Internal Revenue Service has determined, by a letter dated October 6, 2020, is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed, and currently being operated, in compliance with the applicable sections of the IRC and, therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if management has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
