Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Voss Electric Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Voss Electric Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Voss Electric Company (“Company”) 401(k) Plan provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan that entitles employees of the Company to be immediately eligible to contribute upon their hiring and attainment of the age of 18, effective August 7, 2023, prior to this date it was 21. There are no participation restrictions based upon years of service or hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

The Company is to make basic contributions on behalf of each participant who has elected to reduce his or her compensation under a compensation reduction agreement. The basic contribution made on behalf of the participant is to equal the amount specified in that agreement, provided that the contribution does not exceed certain established overall benefit limitations. Starting September 5, 2014, if a newly eligible employee fails to go through the enrollment process to decline participation, the employee is automatically enrolled at a default rate of 3%. The 3% will be increased annually by 1% until a maximum of 8% (preceding November 15, 2022, until a maximum of 6%) is reached. Participants may designate their contributions as Roth contributions. Participants may also make rollover contributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may elect each year to contribute to the Plan any amount at the option of the Company’s board of directors. During 2024, the Company elected to increase the matching contribution of 100% of the first 1% of participant deferral to instead match 100% of the first 3% that a participant contributes to the Plan. The match is funded after each payroll. It has been the historical practice of the Sponsor to fund the participant withholding and Sponsor match after each payroll.

3. Participant Accounts

Each participant’s account is credited with the participant’s contribution and earnings and with Plan forfeitures allocated to their account according to the percentage each participant’s compensation for the Plan Year bears to the total compensation of all participants’ compensation for such Plan Year. During the years ended June 30, 2024 and 2023, the Company allocated forfeitures of \$47,000 and \$0, respectively. As of June 30, 2024 and 2023, the forfeiture account balances totaled \$16,735 and \$49,728, respectively. Forfeitures in the amounts of \$13,792 and \$7,218 were added to the account during the years ended June 30, 2024 and 2023, respectively. During the year ended June 30, 2024, expenses of \$1,325 were charged to the accounts of specific participants who took out loans or withdrew funds from their account, and \$45,361 for fees charged for Fidelity I shares recordkeeping fees. year ended June 30, 2023, expenses of \$1,375 were charged to the accounts of specific participants who took out loans or withdrew funds from their account, and \$44,353 for fees charged for Fidelity I shares recordkeeping fees.

4. Vesting

Under the Plan, a participant is at all times fully vested and has a non-forfeitable interest in all basic, rollover, and qualified non-elective employer contributions made on his or her behalf. Employer matching and additional contributions, other than qualified non-elective contributions, vest under the following schedule:

Vesting percentage:	0%	20%	40%	60%	80%	100%

In order to attain a year of service, 1,000 hours of service shall be required to constitute a year of vesting service, with a minimum of 500 hours required in order to avoid a break in service.

5. Notes Receivable From Participants

The Plan allows participants to borrow from their fund accounts an amount that does not exceed the greater of \$50,000 or 50% of the vested value of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50% for 2024 and 2023, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. The loan application fee is charged to the participant's account.

6. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or may elect to receive installment distributions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting – GAAP

The financial statements of the Plan have been prepared on the accrual method of accounting in conformity with generally accepted accounting principles.

2. Payment of Benefits

Benefits are recorded when paid.

3. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when credited to the account. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

6. Administrative Expenses

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses that are paid directly by the Plan sponsor include audit fees. Administrative expenses paid by the Plan include loan fees charged directly to the participants' accounts and investment fees.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE D – TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401(a) of the Internal Revenue Code (the Code), and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, except for comparing such information certified by the Trustee to information included in the Plan’s financial statements and supplemental Schedule of Assets (Held at End of Year):

The Trustee also certified to the completeness and accuracy of \$1,850,939 of net appreciation in fair value of investments, \$382,863 of dividends and interest related to the aforementioned investments, and \$14,878 of interest income on notes receivable for the year ended June 30, 2024.

The Trustee also certified to the completeness and accuracy of \$991,574 of net appreciation in fair value of investments, \$568,242 of dividends and interest related to the aforementioned investments, and \$4,919 of interest income on notes receivable for the year ended June 30, 2023.

NOTE F – RISKS AND UNCERTAINTIES

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE G – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
