## **Independent Auditors' Report**

Plan Administrator and Board of Trustees  
Chicago International Charter School 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Chicago International Charter School 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chicago International Charter School 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Chicago International Charter School 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of the Plan**

The following description of Chicago International Charter School 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General:**

The Plan is a defined-contribution plan covering all full-time employees of Chicago Charter School Foundation, doing business as the Chicago International Charter School (the Foundation). The Plan was established effective August 1, 2019.

On July 1, 2023, the management of three campuses managed by the Foundation was transferred to a separate company and the employees of the three campuses were no longer employed by the Foundation. This resulted in a partial plan termination effective August 31, 2023.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility:**

Any full-time employee of the Foundation who is a citizen or resident of the United States of America and has attained 21 years of age is eligible to participate. Eligible employees may enter the Plan upon the first day of the month following date of hire.

#### **Contributions:**

Participants may contribute up to 90% of eligible compensation on a pre-tax and/or post-tax basis. Contributions to the Plan may also include rollovers from other qualified defined-benefit or defined-contribution plans and employer safe harbor matching contributions.

Employer safe harbor matching contributions are based on a formula matching 100% of employee salary deferrals up to the first 3% of Plan compensation and 50% of employee salary deferrals up to the next 2% of Plan compensation. Employees classified as campus employees, employees who are members of and participating in the Public School Teachers' Pension and Retirement Fund of Chicago, and employees classified as "CTPF", are excluded from receiving the employer safe harbor matching contributions.

# **CHICAGO INTERNATIONAL CHARTER SCHOOL 401(k) PLAN**

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **1. Description of the Plan (continued)**

#### **Participant accounts:**

Each participant's account is credited with the participant's contribution and allocations of (a) the Foundation's contributions and (b) Plan earnings and charged with an allocation of administrative expenses not paid by the Foundation. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants self-direct their contributions and their share of the Foundation's contributions among various investment options.

#### **Vesting:**

Participants are immediately vested in their contributions and all employer contributions plus actual earnings thereon.

#### **Participant loans:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans are required to be repaid within five years of the date of the loan, unless the loan is for the purchase of a primary residence, in which case the loan repayment period may not extend beyond 30 years. Only two outstanding loans are allowable at any time for each participant. The loans are secured by balances in the participants' accounts and bear interest at the Prime rate (8.50% as of June 30, 2024 and 8.25% as of June 30, 2023) at time of issuance plus 1%. Principal and interest is paid ratably through payroll deductions. Outstanding loans must be immediately repaid upon termination of employment and loan defaults are treated as distributions.

#### **Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon reaching normal retirement age (as defined by the Plan), death, permanent disability or resignation from the Foundation, to be paid in a manner specified in the Plan. Upon death, disability or reaching normal retirement age, a participant's account balance becomes fully vested. Upon resignation, participants are entitled to receive the vested portion of their account balance.

The Plan also allows in-service withdrawals from a participant's account balance upon attaining age 59 1/2.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **2. Summary of significant accounting policies**

#### **Basis of accounting:**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment valuation and income recognition:**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes receivable from participants:**

As described in Note 1, the Plan allows participants to borrow against their vested account balance and the loans are secured by the participants' account balances. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. The Plan is required to review the collectibility of the outstanding loan balances and record an allowance for loans considered to be uncollectible. As of June 30, 2024 and 2023, no allowance for uncollectible loans was necessary.

#### **Contributions:**

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Foundation.

#### **Payment of benefits:**

Benefits are recorded when paid.

#### **Administrative expenses:**

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Foundation.

### **2. Summary of significant accounting policies (continued)**

#### **Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the end of the Plan year and the reported amounts of changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates.

#### **Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through March 17, 2025, the date the financial statements were available to be issued.

### **3. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Investments (information prepared and certified by Reliance Trust Company (the Trustee))**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

The Trustee certified the fair value of investments of \$1,746,297 and \$2,079,401 as of June 30, 2024 and 2023, respectively, and notes receivable from participants of \$57,012 and \$50,749 as of June 30, 2024 and 2023, respectively, and to the completeness and accuracy of the dividend and interest income of \$69,345, interest on participant loans of \$2,030, other income of \$7,723, and net appreciation in fair value of investments of \$139,231 for the year ended June 30, 2024.

**5. Fair value measurements**

There are three levels of inputs used to measure fair value. The definition of each input is described below:

---

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### **5. Fair value measurements (continued)**

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the market value of shares held by the Plan at year-end.

Common collective trust fund: Valued at the net asset value (NAV) of the units held by the Plan. The Fund invests in fully benefit-responsive investment contracts that are held at contract value. NAV is determined to be contract value, the value at which participants ordinarily transact. This practical expedient would not be used if it is determined to be probable that the Fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan currently operates under a Prototype Non-standardized Profit Sharing Plan with Cash or Deferred Arrangement, which has an opinion letter dated October 6, 2020. In the opinion letter, the Internal Revenue Service stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended since receiving the letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 8. Plan termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
