Opinion

NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The I.A.T.S.E. Local 504 Health and Welfare Trust Fund (the "Fund") is a multi-employer health and welfare plan organized to provide medical, dental, life and disability benefits to employees and their dependents of companies that have signed collective bargaining agreements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The disbursements of the Fund are under joint control of labor and management trustees. THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are recorded on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts. In certain circumstances participants may make self-payments to continue benefits in accordance with the Fund rules.

D. Tax-Exempt Status

No provision for federal or state income tax is made. The Fund has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. The Fund administrator and the Fund's counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Fund was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Investment Valuation

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

E. Investment Valuation (Continued)

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 2 investments consist of certificates of deposit valued at cost which approximates fair value and a money market fund valued using matrices of trades in similar securities.

F. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under a separate payroll compliance program.

G. Cash and Cash Equivalents

Cash and cash equivalents consist of cash and money market accounts in banks and a brokerage account.

NOTE 3 - GENERAL INFORMATION

A. Administration

Benefit Programs Administration provides administrative services for a monthly fee of \$5,199, effective October 2023. The monthly fee was \$4,951 through September 2023.

B. Eligibility

1. Initial Eligibility

Effective February 1, 2017, eligibility commences on the first day of the month following the date a participant has been credited by a contributing employer or employers with at least 400 hours of work within a six-month consecutive period for which contributions were paid to the Fund.

2. Maintenance of Eligibility

Effective February 1, 2017, once eligibility has been established, maintenance of eligibility requires 300 hours per quarter according to the following schedule:

Work Months	Eligibility
January, February and March	May, June and July
April, May and June	August, September and October
July, August and September	November, December and January
October, November and December	February, March and April

If a participant works less than 300 hours but greater than 150 hours in a calendar (eligibility) quarter and contributions do not cover the premium cost, a participant may continue to maintain their eligibility during the subsequent two quarters provided they pay the Fund the \$4.75 per hour rate for the number of hours necessary to bring their bank hours up to 300 hours for the quarter.

If a participant works less than 150 hours during a calendar (eligibility) quarter in order to continue their eligibility, they may elect COBRA and will be responsible for the full cost of their benefits.

3. Rehire Rule

Effective February 1, 2017, the Trustees adopted a new rehire rule. For employees who became eligible, yet subsequently lose eligibility, they may requalify within one year after they exhaust their ability to buy up the employee's bank hours, if they accrue at least 300 hours within any eligibility quarter within the year to requalify for their benefits. If the employee is unable to accrue 300 hours with an eligibility quarter within the 12-month period, then they will need to requalify under the initial eligibility rules.

C. Continuation of Benefits (Bank Hour Provision)

Participants are allowed to accumulate a maximum of 800 hours (effective January 1, 2024) to provide for future eligibility. Participants who have less than 300 hours reported in a given quarter may use their bank hours to obtain eligibility for that quarter. The estimated future benefits based on participants' accumulated eligibility provision is a three months maximum per participant.

D. Disability

Participants who are unable to work because of a doctor or state certified disability shall, upon showing written proof thereof, have their premiums paid by the Fund for a period of up to one year. This provision is for participants only, and excludes dependents.

NOTE 4 - PRIORITIES UPON PLAN TERMINATION

Upon termination of the Fund, any monies remaining in the Fund after the payment of all expenses and obligations of the Fund shall be paid or used for the continuance of one or more benefits in accordance with the provisions of the Fund.

NOTE 6 - CONCENTRATION OF CREDIT RISK

During the year ended June 30, 2024, the Fund maintained bank accounts with cash balances in excess of the Federal Deposit Insurance Corporation limit of \$250,000 per bank. The amount in excess of the limit is subject to risk if the financial institution did not perform. The Fund has not incurred any losses on the uninsured balance.
