Schedule H, Part III and Part IV:

Rough Rock School Board, Inc. is an organization maintained by an **Indian Tribe**, which performs services for that tribe as a **governmental agency**.

The treatment of this plan, as one sponsored by a governmental entity, is supported by case law, PBGC opinion, and by Executive Order 13084 (issued May 14, 1998). Under interpretation by the courts, the Department of Labor and the IRS, entities that perform governmental functions have been construed to operate governmental plans. The executive order issued by President Clinton confirms that the United States will work with the Tribes on a government-to-government basis. Additionally, PBGC Letter Opinion 81-3 concluded that Congress did not intend to extend ERISA coverage to pension plans maintained as a function of a Tribe’s internal sovereignty. Finally in *Colville Confederated Tribes v. Somday*, it was determined that the retirement plan offered by the Colville Confederated Tribes was in fact “exempt from ERISA as a governmental plan.” The plan was thus exempt from all ERISA reporting and disclosure requirements.

As such, please be aware that all lines on the Form 5500, which relate to ERISA requirements, have been answered accurately, but the answers should not be considered to be in any way an acceptance of ERISA requirements. The Tribe is a sovereign governmental entity and at all times carefully administers the plan in the interest of its employees.
