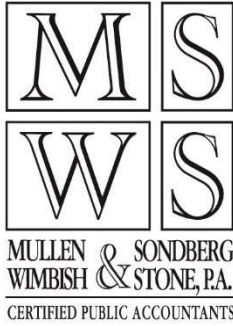

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc of Southern Maryland Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc of Southern Maryland Retirement Saving Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to *29 CFR 2520.103-8* of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with *29 CFR 2520.103-5* of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Arc of Southern Maryland Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 - Description of Plan

The following description of The Arc of Southern Maryland Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Arc of Southern Maryland Retirement Savings Plan (the Plan) was established August 1, 1981 and amended effective July 15, 2017. The Plan is a 403(b) defined contribution plan sponsored by The Arc Southern Maryland, Inc. (the Organization). All full-time employees of the Organization are eligible to make elective deferrals upon hire, and eligible to receive the Organization's employer contributions after completing 1,000 hours of service and attaining the age of nineteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants may elect to defer a portion of their salary and have such deferrals contributed by the Organization to his or her account under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Organization has two different discretionary employer programs. Each year, the Organization may make a general discretionary contribution on behalf of all participants as determined by the Organization. The second discretionary match program will have eligibility requirement of 1,000 hours and 1 year of employment, the Organization will contribute 50% of employee's contribution up to \$2,000. The Plan has a five year graded vesting schedule. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. General discretionary contributions and special discretionary contributions made by the Organization totaled \$140,141 and \$67,058 for the years ended June 30, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) the Organization's match of salary deferrals, (c) an allocation of the Organization's contribution, (d) an allocation of Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested immediately in their elective contributions plus actual earnings thereon. Participants are fully vested in the Organization's employer matching contributions after 5 years of service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over the life expectancy of the participant and/or designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Forfeitures

Forfeitures can be used to reduce the Organization's employer contributions or pay Plan expenses. During the years ended June 30, 2024 and 2023, there were forfeitures of \$636 and \$825, respectively, which were used to pay Plan expenses. There were no forfeitures held at June 30, 2024 and 2023.

Notes Receivable from Participants

The Plan does not allow for participant loans in accordance with the Plan document.

Administrative Expenses

The administrative and investment management expenses related to the Plan's Trustees and Custodian are paid by the Plan. The Organization pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Investments

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value as described in Note 4. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Related Receivables

Contributions from the Organization and participants of the Plan are accrued in the period in which they become obligations under provisions of the Plan agreement. All participant and employer contributions are participant-directed. The plan administrator has determined that all participant and employer contributions receivable are fully collectible; consequently, no amount has been recorded as an allowance for credit losses in the accompanying statement of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants amounted to \$217,337 and \$353,868 for the years ended June 30, 2024 and 2023, respectively.

New Accounting Pronouncements

In June 2016, the FASB issued *ASU 2016-13, "Financial Instruments – Credit Losses"* (*Topic 326*) which significantly changed how entities will measure credit losses for most financial assets and certain other instruments that aren't measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in *FASB ASC 326* were employer contributions receivable and participant contributions receivable.

New Accounting Pronouncements (Cont.)

The Plan adopted the standard effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in new and enhanced disclosures only.

Note 3 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*ASC 820 "Fair value Measurements and Disclosures,"* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under *ASC 820-10* are as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Note 3 - Fair Value Measurements (Cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value as of June 30, 2024 and 2023:

*Registered investment companies - Principal:* Investments whose values are based on quoted market prices in active markets, and are, therefore classified with Level 1, include mutual funds. Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds registered with the SEC. these funds are required to publish their daily net asset value (NAV) and to transact at that price. The investment companies held by the Plan are deemed to be actively traded.

*Registered investment companies - Lincoln:* Valued at the net asset value of the variable annuity contracts, as reported by the Trustee and calculated in a manner consistent with Generally Accepted Accounting Principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by variable annuity contract. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy.

Note 4 - Investment Contracts with Insurance Companies Measured at Contract Value

Principal Life Insurance Company Fixed Income Non 401(a) (PFIO)

The Plan entered into a benefit-responsive investment contract with Principal Financial Group (PFG) to invest the contributions in a group annuity contract issued by Principal Life Insurance Company. The contract is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets. PFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported by PFG.

PFIO is a benefit responsive group annuity contract issued by the Principal Life Insurance Company (PLIC). The method used to calculate the interest crediting rate is defined in the contract under the term "Composite Crediting rate" and is currently set using an indexed rate formula that is derived from the 5-year constant maturity treasury rate (an index published by the Federal Reserve Board) and is subject to a 1% minimum and 3% maximum.

The Principal annuity contract investment, Principal Fixed Income Non 401(a), is a traditional investment contract issued by Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value included in the financial statements was \$602,464 and \$592,555 at June 30, 2024 and 2023, respectively.

The PFIO is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value Fund. As a result, the average yield earned by the Plan is the yield earned on the group annuity contract. The interest rate earned on the contract during the years ended June 30, 2024 and 2023 were 2.49% and 1.11%, respectively.

Because the contract is an insurance contract, the Plan may transact according to the terms defined in the contract at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest twelve months after notification of such termination. In lieu of the twelve month delay of payment, immediate payment may be requested subject to a 5% surrender fee.

The issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract.

Lincoln National Fixed Account

The Plan entered into a benefit-responsive investment contract with Lincoln National Life. Lincoln National Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Lincoln National Life. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed in the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract approximates contract value was \$19,505 and \$18,869 at June 30, 2024 and 2023, respectively. The average yield on the contract during the years ended June 30, 2024 and 2023 was 3.42% and 3.61%, respectively.

Because the contract is an insurance contract, the Plan may transact according to the terms defined in the contract at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest. The issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Transamerica Life Insurance Company General Account

The Plan entered into a benefit-responsive investment contract with Transamerica Life Insurance Company (TLIC). TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by TLIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed in the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract which approximates contract value was \$77 and \$74 at June 30, 2024 and 2023, respectively. The average yield on the contract during the years ended June 30, 2024 and 2023 was 3.46% and 10.28%, respectively.

Transamerica Life Insurance Company General Account (Cont.)

Because the contract is an insurance contract, the Plan may transact according to the terms defined in the contract at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest. The issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Note 5 - Data Obtained from the Custodian and Trustees

Investment Data

Principal Trust Company, The Lincoln National Life Insurance Company, and Transamerica Financial Life Insurance Company, Inc. were the Custodian and Trustees of the Plan for the years ended June 30, 2024 and 2023. All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits, and the Schedule H, line 4i – Schedule of assets (held at end of year) for the year ended June 30, 2024 was summarized from information supplied and certified as complete and accurate by the Custodian and Trustees of the Plan.

Schedule of Assets Held for Investments Purposes

The accompanying Schedule H, line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of June 30, 2024.

Note 6 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the beginning of the year. During the Plan years ended June 30, 2024 and 2023, there were no reportable transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Party-in-Interest Transactions

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged.

The Plan's auditor who audits the Plan's financial statements, the third-party administrator who provides accounting and administrative services, and legal counsel who provides legal advice as needed to the Plan, are paid directly by the Organization. These fees are not reflected in these financial statements.

The Plan's investments are managed by Principal Financial, The Lincoln National Life Insurance Company, and TransAmerica Financial Life Insurance Company. These companies are the Trustees and Custodian as defined in the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Total fees paid to these companies during the years ended June 30, 2024 and 2023 were \$3,172 and \$2,652 respectively.

Note 9 - Income Tax Status and Position

The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective July 15, 2017, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on March 31, 2017 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letters have been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. There have been no subsequent events through April 2, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.
