## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of  
Riverside Industries, Inc. 403(b) Thrift Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Riverside Industries, Inc. 403(b) Thrift Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section —

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). ## Notes to the Financial Statements

### NOTE 1 – DESCRIPTION OF PLAN

The following description of Riverside Industries, Inc. 403(b) Thrift Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed defined contribution 403(b) plan covering all employees of Riverside Industries, Inc. (“Organization” or “Employer”), except those excluded by Section 1.2 of the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Contributions

Each year, participants may contribute a percentage of their includable compensation to the Plan. Participants that are age 50 or older may elect to defer additional amounts (age-50 catch-up contribution) to the Plan. In addition, participants who have completed at least 15 years of service are eligible to make an additional contribution (special catch-up contribution). However, a participant’s total deferral in any taxable year may not exceed a dollar limit which is set by law. Participants may also contribute amounts representing distributions from other eligible plans.

Each plan year, the Board of Directors will determine the amount of matching contribution (if any) and base contribution (if any) that will be made for all eligible participants who are actively employed on the last day of the plan year. The matching contribution will be allocated to each eligible participant based on the ratio of the participant’s salary reduction contribution to the total salary reduction contribution of all participants for the plan year. Age-50 catch up contributions are not eligible for a matching contribution. The base contribution will be allocated to each eligible participant based on the ratio of the participant’s compensation to the total compensation of all participants for the plan year. The base contribution will be made whether or not the participant elects to make a contribution.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Organization’s contributions and Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Investment Options

A participant may direct the Organization to invest their contributions in a variety of investment options allowed by the Plan. All investments are participant directed.

**NOTE 1 – DESCRIPTION OF PLAN – (CONTINUED)**

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s matching and base contributions plus actual earnings thereon is based on years of continuous service.

The vesting schedule for the Plan is as follows:

Plan Loans

The Plan allows for loans to participants from Mutual of America Life Insurance Company (“Mutual of America”) which are secured by the participant’s vested account balance that is segregated in the participant’s interest accumulation account. Participants may borrow from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance to collateralize loans. The interest rates on the loans range from 3.25% to 4.60%. Principal and interest are paid directly to Mutual of America in equal periodic payments through salary reduction. The amount of Plan assets used to collateralize loans at June 30, 2024 and 2023 was \$196,762 and \$135,046 respectively.

Payment of Benefits

On termination of employment, a participant is entitled to the full value of all the participant’s contributions to the Plan, all vested Organization contributions and all related earnings. There are various options available for distributions. For vested account balances under \$5,000, lump sum distributions or direct rollovers will be made. Distributions or direct rollovers of vested account balances of more than \$5,000 cannot be made before the participant’s normal retirement date without the participant’s written consent. In addition, during employment, a participant may withdraw all or a portion of their vested account balance, to the extent necessary, to meet a qualifying financial hardship.

Forfeitures

If a participant leaves the Organization for any reason other than retirement, disability or death, they are entitled to all their contributions, the vested portion of Organization contributions and related earnings. The nonvested portion of Organization contributions and the related earnings will be forfeited. If a terminated participant is re-employed, the forfeited account will be restored upon re-employment if the break-in-service does not exceed five years. If the terminated participant received a distribution of their vested account, the Organization will restore the forfeited portion if the participant repays to the Plan the total amount of the distribution within five years of the date of re-employment.

Each year, if there are any forfeitures, they are used to reduce future Employer contributions to the Plan. During the year ended June 30, 2024, \$7,178 of forfeitures were used to reduce Employer contributions. At June 30, 2024 and 2023, unallocated nonvested accounts totaled \$-0-.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for a fully benefit responsive investment contract and the interest accumulation account, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in the fully benefit responsive investment contract and the Interest Accumulation Account are reported at contract value, which approximates fair value and is comparable to a cash equivalent. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by Mutual of America and Brighthouse Life Insurance Company ("Brighthouse"). See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes interest and dividends and the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

The Organization pays certain administrative expenses incurred in the administration of the Plan. Expenses that are paid by the Organization are excluded from the financial statements. Certain other expenses, including loan set-up fees and other transactional costs, are charged to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

### Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended June 30, 2024 through April 9, 2025, the date on which financial statements were available to be issued.

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

#### *Separate Account Funds:*

Unit value calculated based on the observable net asset value of the underlying investment, which consist solely of mutual funds.

#### **NOTE 4 – GROUP ANNUITY CONTRACT WITH BRIGHTHOUSE**

The Plan has a fully benefit-responsive guaranteed investment contract with Brighthouse totaling \$52,152 and \$50,383 at June 30, 2024 and 2023, respectively. Brighthouse maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.5%. Such interest rates are viewed on a periodic basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Brighthouse, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### **NOTE 5 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America and Brighthouse, the custodians of the Plan.

#### **NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Substantially all the costs and expenses incurred in connection with the operations of the Plan are paid by the Organization. Mutual of America and Brighthouse are the custodians of the Plan's assets and manage the Plan's investments. Therefore, these transactions qualify as party in interest transactions and are denoted as such on the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year).

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE 8 – INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the “Code”). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007 - 71. The Plan is required to operate in conformity with the Code to maintain its tax-exempt status for plan participants under Section 403(b). The sponsor and Plan Administrator believe the Plan is designed and currently being operated in compliance with the applicable requirements of the Code, and therefore believe the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investments. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
