Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of Plan

The following description of The Washington Latin School Defined Contribution Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which became effective January 1, 2007, is a defined contribution plan covering substantially all employees of The Washington Latin School (the "School" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 1, 2022, the Board of Governors of the School approved merger of The Washington Latin School Tax Deferred Annuity Plan ("TDA Plan") into the Plan effective June 30, 2022. As of this date, all assets of the TDA Plan, which consisted of investments, notes receivable from participants, and participants contributions receivable amounting to \$5,122,286, were transferred to the Plan and the TDA Plan ceased to exist. As a result of the merger, the Plan was restated effective June 30, 2022 to include participants contributions and notes receivable from participants.

Eligibility

Upon hire, all eligible employees of the School could immediately elect to participate in the TDA Plan and make pre-tax contributions. All eligible employees of the School can participate upon completion of six months of service during which at least 83 1/3 hours of service are completed in each consecutive month.

Contributions

Prior to June 30, 2022, the Employer matched 100% of a participant's pre-tax elective deferrals made to the TDA Plan up to 4% of their eligible compensation. Subsequent to June 30, 2022, per the Plan restatement, the Employer will continue to match those percentages of participant contributions to the Plan.

Subsequent to June 30, 2022, participants can elect to have a percentage or specified dollar amount of pre-tax dollars deducted from their compensation as defined by the Plan restatement. Participants who are age 50 or older by the end of the Plan year can make catch-up contributions. Participants can also contribute amounts representing distributions from other qualified plans. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed.

Vesting

A participant is 100% vested in their accounts including allocated earnings thereon at all times.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, or due to financial hardship a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in their account.

Notes Receivable from Participants

Per the terms of the Plan restatement effective June 30, 2022, the Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan can borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants can take a loan once in any 12 consecutive-month period, subject to the IRC limits on the total amount that can be borrowed. Participants cannot have more than three outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans have to be repaid within five years, unless the loan is used to purchase a participant's principal residence, or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the NAV of shares held by the Plan at year end. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by Teachers Insurance and Annuity Association of America ("TIAA"), is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The TIAA Traditional Annuity Account is an unallocated contract. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value, which is derived from a discounted cash flow analysis and other factors, approximates fair value. The fair value is derived from a discounted cash flow analysis.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and a distributable event occurred (retirement, termination, death), the participant loan balance was reduced and a benefit payment was recorded. Until a distributable event occurred, the loan would continue to have a balance and accrue interest.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 25, 2025.

TIAA Traditional Annuity Account

The TIAA Traditional Annuity Account is composed of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity, the Supplemental Retirement Annuity, and the Retirement Choice Plus ("RCP") contracts. The non benefit responsive contracts are: the Group Retirement Annuity, the Retirement Annuity and the Retirement Choice ("RC") contracts. The Plan utilizes the RCP contract, which is reported at contract value, and the RC contract, which is reported at fair value. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: RCP – 3.15% - 4.75%; and RC – 3.90% – 6.25%.

Under RCP contracts, lump sum withdrawals and transfers are allowed at any time without any surrender charges. Certain RCP contracts impose a 90-day equity wash rule. Under the RC contract, lump sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers must be paid in 84 monthly installments (7 years).

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

TIAA Traditional Annuity Account

The TIAA Traditional Annuity Account represents approximately 12% and 0% of the Plan's net assets available for benefits, as of June 30, 2022 and 2021, and represents an obligation from TIAA to repay as amounts come due. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 2024), Standard and Poor's (AA+ as of May 2024), A.M. Best Company (A++ as of July 2024), and Fitch Ratings (AAA as of August 2024). The plan administrator does not believe that any events are probable of occurring that would limit the Plan's ability to transact at contract value.

TIAA Real Estate Account

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. The daily unit values are listed on the Nasdaq. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter. The TIAA Real Estate Account has no unfunded commitments at June 30, 2022 and 2021.

5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

On August 7, 2017, the Internal Revenue Service ("IRS") issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Certain investments are managed by TIAA and CREF. TIAA is the record-keeper and a custodian and CREF is a custodian for the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

7. Party-in-Interest Transactions (*continued*)

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2022 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
