Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Washington Latin School Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained a certification from the qualified institutions as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by the qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Emphasis of Matter

As discussed in Note 1 to the financial statements, the Board of Governors of the School approved the merger of the Plan into The Washington Latin School Defined Contribution Plan ("DC Plan") effective June 30, 2022. As of this date, all assets of the Plan were transferred to the DC Plan and the Plan ceased to exist. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We have been informed by the plan administrator that TIAA and CREF hold the Plan's investment assets and execute investment transactions. The plan administrator has obtained a certification from TIAA and CREF as of June 30, 2021, that the information provided to the plan administrator by TIAA and CREF is complete and accurate.

Disclaimer of Opinion

Accordingly, we do not express an opinion on the 2021 financial statement.

1. Description of Plan

The following description of The Washington Latin School Tax Deferred Annuity Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which became effective January 1, 2007, was a defined contribution plan covering substantially all employees of The Washington Latin School (the "School" or "Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 1, 2022, the Board of Governors of the School approved merger of the Plan into The Washington Latin School Defined Contribution Plan ("DC Plan") effective June 30, 2022. As of this date, all assets of the Plan were transferred to the DC Plan and the Plan ceased to exist.

Eligibility

Upon hire, all eligible employees of the School could immediately elect to participate in the Plan and make pre-tax contributions.

Contributions

Participants could elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. The money that was deducted is "pre-tax" dollars. A participant could elect to increase, decrease or suspend deductions according to procedures established by the School. Participants who were age 50 or older by the end of the plan year could make catch-up contributions to the Plan. Participants could also contribute amounts representing distributions from other qualified plans. There was an annual limit as to the amount that could be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. All investments were participant directed.

Vesting

A participant was 100% vested in their accounts including allocated earnings thereon at all times.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, or due to financial hardship a participant was entitled to receive a distribution in the amount equal to the value of the participant's account.

Notes Receivable from Participants

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants could take a loan once in any 12 consecutive-month period, subject to the IRC limits on the total amount that could be borrowed. Participants could not have more than three outstanding loans at a time. The interest rate was based on the prime rate plus 1%. Loans had to be repaid within five years, unless the loan was used to purchase a participant's principal residence or the participant was on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The TIAA Traditional Annuity Account was an unallocated contract. Contract value equaled the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value, which was derived from a discounted cash flow analysis and other factors, approximated fair value. Investments in registered investment companies were stated at fair value as determined by quoted market prices, which represented the net asset value of shares held by the Plan at year end. The pooled separate account was valued at the NAV of units held by the Plan. The NAV, as provided by TIAA, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient was not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Investment Valuation and Income Recognition (continued)

Purchase and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and a distributable event occurred (retirement, termination, death), the participant loan balance was reduced and a benefit payment was recorded. Until a distributable event occurred, the loan would continue to have a balance and accrue interest.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the School and were excluded from these financial statements. Investment related expenses were included in net depreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 24, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2022 and 2021, and net depreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA and CREF"), qualified institutions.

TIAA Traditional Annuity Account

The TIAA Traditional Annuity is comprised of six types of contracts. The fully benefit responsive contracts are the: Group Supplemental Retirement Annuity, the Supplemental Retirement Annuity, and the Retirement Choice Plus (“RCP”) contracts. The non-benefit responsive contracts are the: Group Retirement Annuity, Retirement Annuity and Retirement Choice contracts. The Plan utilized the RCP contract, which was reported at contract value. Unobservable inputs included the risk-adjusted discount rate applied and the range of significant input values was as follows: RCP – 3.20%-4.50%.

Under the RCP contract, lump-sum withdrawals and transfers were available without any surrender charges. Certain RCP contracts impose a 90-day equity wash rule.

The contracts used the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages were time periods that represented when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognized the fact that the level of prevailing interest rates available on new long-term investments could vary over time and that as the long-term investments in a specific vintage mature, they could be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they were immediately invested at the prevailing pay-in-rate for new money. The funds earned interest at the prevailing vintage rates. The vintage always consisted of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represented the minimum amount of interest that would be credited to an account, regardless of the economic environment. The discretionary portion represented interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity Account represented approximately 16% of the Plan’s net assets available for benefits as of June 30, 2021, and represented an obligation from TIAA to repay as amounts come due.

TIAA Real Estate Account

The TIAA Real Estate Account generally invested in real estate properties and real estate-related investments. The TIAA Real Estate Account's value was principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings were valued principally using external appraisals, which were estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes held securities as well. These were generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account could occur daily, transfers out were limited to one per calendar quarter. The TIAA Real Estate Account had no unfunded commitments at June 30, 2021.

5. Tax Status

On August 7, 2017, the Internal Revenue Service ("IRS") issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain investments were managed by TIAA and CREF. TIAA was the record-keeper and a custodian and CREF was a custodian for the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Prohibited Transactions

During the 2018 Plan year, the School failed to remit to the Plan certain participants' contributions within the period described by the Department of Labor's regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. In August 2022, the School made the necessary corrections to satisfy both the Department of Labor and IRS guidance for this matter.
