## NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Northern Rivers Family Services, Inc. and Member Agencies Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was formed on July 1, 2016, as the result of the merger of the Defined Contribution Savings Plan for Employees of Parsons Child and Family Center and The Northeast Parent and Child Society, Inc. Employee’s 401(k) Savings Plan and Trust. The Plan is a defined contribution plan covering substantially all full-time employees of Northern Rivers Family Services, Inc., and its affiliates (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

An employee is eligible to participate in the Plan once they have attained the age of eighteen. There is no service or hours requirement for employee deferrals. Employees are able to enter the Plan on the first day of the month following the date in which they meet the eligibility requirements. Employees are also eligible for Plan Sponsor contributions after one year of service with a minimum of 1,000 hours during the plan year, and after attaining the age of eighteen. The Plan Sponsor provides both matching and discretionary profit-sharing contributions.

The Plan provides an automatic enrollment feature for employees meeting the eligibility rules. Employees that do not opt out or elect a percentage other than two percent will automatically be enrolled at two percent.

#### **Plan Management**

The Plan entered into an agreement with NBT Bank (NBT), whereby NBT serves as a trustee with the discretion and responsibility to (i) select investment alternative categories and specific investment alternatives; (ii) monitor the performance of each such investment alternative; (iii) determine whether the nature, objectives, and risk characteristics of each such investment alternative continue to conform to the category under which it is made available under the Plan; and (iv) replace or discontinue each such investment alternative whenever the Bank determines, in its sole discretion, that it is necessary or prudent to do so. NBT retains Charles Schwab Investment Management, Inc. as custodian for the Plan, and Epic Advisors, Inc. as record keeper for the Plan.

#### **Contributions and Contributions Receivable**

Participants may elect to make a salary deferral contribution up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and the Plan Sponsor’s contributions into various investment options offered by the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### Contributions and Contributions Receivable (Continued)

The Plan Sponsor matches the participant's salary deferral contribution up to 2% of the participant's compensation. In addition, the Plan Sponsor may make an additional discretionary profit-sharing contribution based on a participant's eligible wages. During the years ended June 30, 2024, and 2023, the Plan Sponsor elected to make an additional profit-sharing contribution that equaled 4% and 3.5% of participant's eligible wages, respectively.

### Investment Options

Upon enrollment in the Plan, a participant may direct their employee and employer contributions into any of the mutual funds or the common collective trust fund offered by the Plan. Participants may change their investment options at their discretion.

### Participant Accounts

The Plan allows each participant to select the investments in their individual accounts from the various investment options available. Each participant's account is credited with the participant's contribution and an allocation of (a) the Plan Sponsor's contributions, (b) plan earnings and losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their voluntary contribution plus actual earnings thereon. Vesting of the Plan Sponsor's contributions portion of their account is based upon the earlier of the vesting schedule below, plan termination, the occurrence of normal retirement age (65), occurrence of eligibility for early retirement, and death or disability (permanent and total) while actively employed.

### Forfeitures

Forfeited non-vested account balances are applied first towards reducing administrative expenses and then toward the Plan Sponsor's matching contributions in accordance with the plan document. During the years ended June 30, 2024 and 2023, approximately \$28,000 and \$30,000 of forfeitures were used to pay plan expenses, respectively. At June 30, 2024 and 2023, forfeited non-vested participant accounts were \$31,630 and \$21,507, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Administrative Expenses**

Administrative and participant transaction fees are paid by participant assets of the Plan. Any expenses paid by the Plan are paid by Plan participants as a reduction of investment income.

### **Payment of Benefits**

Benefits are recorded when paid. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, annual installments, or have the payment paid as a direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for its fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan document.

Investment income recognized by the Plan includes earnings from investments, net gains realized from the sale of investments, and the net change in the unrealized appreciation of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Interest income on notes receivable from participants is recognized by the Plan in the period in which it is earned based on the outstanding principal balance times the stated interest rate at the date the note receivable originated.

### **Risks and Uncertainties**

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account. Interest is charged at prevailing interest rates as determined by the plan administrator at the time the note is originated.

Principal and interest is paid through bi-weekly payroll deductions over a term ranging from one to five years. Loans used to acquire a principal residence may be paid over a term that exceeds five years. Participants may have no more than two notes outstanding at any given time.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Notes Receivable from Participants (Continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses have been recorded at June 30, 2024 or 2023.

### Fair Value Measurements

The Plan has financial instruments which are recorded at fair value in the accompanying statements of assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in mutual funds.

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. Generally accepted accounting principles establish a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 inputs are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment. The Plan's investments in mutual funds are valued based upon quoted prices in active markets.
- Level 2 inputs are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly. The Plan does not hold any Level 2 investments as of June 30, 2024, and 2023.
- Level 3 inputs are based on inputs that are unobservable and significant to the overall fair value measurement. The Plan does not hold any Level 3 investments as of June 30, 2024, and 2023.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

### 3. INVESTMENTS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, NBT Bank, the trustee of the Plan, has certified to the completeness and accuracy of the following information included in the accompanying financial statements and the supplemental schedule of assets (held at end of year) as of and for the years ended June 30, 2024 and 2023:

Mutual funds are valued based on the amount reported by the trustee, based on the quoted market prices of the investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodology used at June 30, 2024 and 2023.

## **5. COMMON COLLECTIVE TRUST**

Participants have the option to invest in the Federated Capital Preservation Fund (the “Fund”), issued by Federated Investors Trust Company. The Fund is considered a fully benefit responsive contract, as it primarily holds guaranteed investment contracts (“traditional GICs”), separate account guaranteed investment contracts (“separate account GICs”) and synthetic guaranteed investment contracts (“synthetic GICs”).

Participants may purchase units of the Fund daily based on the established unit value of \$10. The principal value per unit of the Fund is determined at the end of each day by dividing the net assets by the number of outstanding units. Participants may redeem units of the Fund for the purpose of a bona fide benefit payment, making a participant loan, honoring an employee directed transfer of the employee’s interest in the Plan to another investment election or paying fees of the Fund. Participants may make withdrawals from the Fund for other purposes generally only upon 12 months’ advance written notice. All participants of the Fund have a proportionate undivided interest in all assets of the Fund. Net investment income is distributed to participants monthly and is reinvested to purchase additional units of the Fund.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

## **6. TAX STATUS**

The Plan was designed in accordance with the provisions of a prototype non-standardized cash or deferred profit-sharing plan. In a letter dated March 31, 2014, the Internal Revenue Service determined and informed Epic Advisors, Inc. that the form of the Prototype Non-standardized Profit Sharing Plan with CODA described in that letter was designed in accordance with applicable Sections of the Internal Revenue Code (IRC) and, as such, is not subject to income taxes. The plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

## **7. PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between those participants who have loans and the Plan qualify as party-in-interest transactions.

## **8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**9. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of June 30, 2024, and 2023.

**10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through April 9, 2025, which is the date the financial statements were available to be issued.
