Opinion

NOTE A – DESCRIPTION OF THE PLAN

The following description of the International Brotherhood of Electrical Workers Local No. 56 Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

General – The Plan provides health and other benefits to members of IBEW Local No. 56. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits – The Plan provides health benefits (medical, hospital, surgical, major medical), accident and sickness benefits, Health Reimbursement Arrangement (HRA) benefits, and vision benefits to eligible participants and covered dependents. Retired participants are eligible to elect Group Health Plan Benefits prior to medicare eligibility, Medicare Advantage Program Benefits after Medicare enrollment and HRA benefits.

Eligibility for Benefits - Each active participant has a health care credit bank which is funded with a portion of employer contributions. Participants are eligible for medical insurance coverage as long as they maintain enough health care credits for the corresponding coverage quarter. Participants may self-pay to maintain coverage.

Contributions – Participating employers contribute a fixed amount per hour pursuant to the collective bargaining agreement. Participants are permitted to make contributions to maintain eligibility.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition – Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

NOTE C – INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan and Trust qualify under Section 501(c)(5) of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law.

NOTE D – SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through April 4, 2025 the day the financial statements were approved and authorized for issue.

NOTE E - CONCENTRATION OF CREDIT RISK

The Plan maintains its cash accounts at two financial institutions in which balances may, at times, exceed federally insured limits.

NOTE F – PRIORITIES UPON TERMINATION

It is the intention of the Trustees to continue the Plan indefinitely. If the Plan were to be terminated by the Trustees, the assets of the Trust Fund would be used for the exclusive benefit of eligible employees to provide benefits and pay fund expenses until exhausted.

NOTE G – BENEFIT OBLIGATIONS

1. **Amounts Currently Payable To Or For Participants** – The amount reported as amounts currently payable to or for participants represents benefits incurred prior to June 30th and paid in the subsequent year.
2. **Accumulated Eligibility Credits** – Accumulated eligibility credits of participants are estimated by the plan. Such estimated amounts are reported in the Statement of Benefit Obligations at present value.
3. **Postretirement Benefit Obligations** – The amount reported as the postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participants and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

NOTE G – BENEFIT OBLIGATIONS (Continued)

For June 30, 2024 measurement purposes, a 5.75 percent pre-medicare and 4.36 percent post-medicare annual rate of increase in the per capita cost of covered health care benefits and prescription drug benefits was assumed for the year ending June 30, 2024; the rates were assumed to decrease until reaching 4.04 percent in the year 2075, and to remain at that level thereafter. For June 30, 2023 measurement purposes, a 5.86 percent pre-medicare and 4.2 percent post-medicare annual rate of increase in the per capita cost of covered health care benefits and prescription drug benefits was assumed for the year ending June 30, 2023; the rates were assumed to decrease until reaching 4.14 percent in the year 2075, and to remain at that level thereafter.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of June 30, 2024 and 2023 by \$ 239,000 and \$ 201,000 respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

NOTE H - RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE J – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Cash Equivalents - The carrying value of cash equivalents approximates fair value.

Common Stocks - Valued at the closing price reported on the active market on which the individual securities are traded.

Registered Investment Companies - Mutual Funds are valued at the reported net asset value of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE K – HEALTHCARE REIMBURSEMENT ACCOUNT

In addition to other self-insured benefits, the Plan established a Healthcare Reimbursement Account Program (HRA). The program establishes individual accounts for participants which can be utilized by participants to pay for certain health care expenses not reimbursed by other Welfare Fund programs. Individual accounts are increased by \$ 1.00 per hour paid. The balance of participants' accounts was \$ 1,369,277 and \$ 1,350,968 at June 30, 2024 and 2023, respectively.


