NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of Tetco Employees' Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan which covers substantially all employees of Tetco, Inc. and subsidiaries and affiliates (collectively, the “Company”). Employees become eligible to participate in the Plan if they complete sixty days of service and have attained age 21. Entry dates for participants are the 1st day of the following month reaching eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may elect to contribute to the Plan a percentage or fixed amount of their compensation, as a defined in Plan document; however, total deferrals in any taxable year may not exceed a certain dollar amount which is set by law. Each year, eligible participants can elect to defer up to 75% of their compensation up to the maximum, as permitted by the internal Revenue Service (IRS). The employer may make discretionary profit sharing and/or matching contributions each year. Participants who reach the age of 50 before the close of a calendar year are eligible to make catch-up elective deferral contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may elect to change their investment options any time throughout the year via direct telephone or internet access. During the year ended June 30, 2024 and 2023, the Company made quarterly matching contributions totaling \$243,152 and \$276,497, respectively. Contributions are subject to certain limitations.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and employer contributions, as well as allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Participants vest at the rate of 20% in employer contributions for each year of service resulting in a 100% vested interest after five years of service. Upon normal retirement age, or in the event of death or disability, the participant becomes 100% vested.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall be no more than five years except when the proceeds of a loan are used to acquire a dwelling to be used as a participant's principal residence, then the Plan Administration may permit a longer repayment period. The loans are secured by the balance in participant's account and bear interest, as determined by the Plan Administrator. As of June 30, 2024, the interest rate is set at 4.25% to 10% with various maturities through 2032.

Principal and interest are paid ratably through monthly payroll deductions. If a terminated participant ceases to make loan repayments for 90 days and the Plan Administrator believes the loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded. If an active participant ceases to make repayments for more than one quarter and the Plan Administrator believes the loan should be deemed distributed, then the participants loan balance will be considered a deemed distribution for tax purposes, but the loan balance remains a Plan asset until the participant repays the loan or takes a distribution. This is taxable event to the participant.

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of June 30, 2024 and 2023. Interest earned on participant loans was \$32,752 and \$26,247 for the years ended June 30, 2024 and 2023, respectively.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule H, Line 4i – Schedule of Assets (Held at End of Year).

Payment of Benefits

On termination, death, disability or termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested balance in the form of a lump-sum distribution or installments over a period of not more than their or their spouse's assumed life expectancy. Accounts under \$5,000 will be paid in a lump-sum distribution. Hardship withdrawals are also available subject to certain limitations. Benefits paid to participants are recorded when paid.

Forfeitures

Forfeitures of nonvested nonelective and matching contributions may be used to reduce the Company's contribution for that Plan year or to pay Plan expenses. As of June 30, 2024 and 2023, the balance on the forfeiture account totaled \$771 and \$23,233, respectively. For the year

ended June 30, 2024 and 2023, there was \$27,278 and \$0, respectively, utilized to pay expenses or reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for the benefit of the participants and changes in those net assets.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 10 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's unrealized gains and losses as of period-end and realized gains and losses on investments bought and sold during the year.

Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's accounts

and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Contributions

Contributions from Plan participants and the matching contributions from the Plan sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. Profit sharing contributions are recognized upon authorization and in the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by IRS are recorded as liability with a corresponding reduction in contributions.

NOTE 3 – CERTIFIED FINANCIAL INFORMATION

The following is a summary of the Plan's asset information as of June 30, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the John Hancock Trust Company, LLC and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and the supplemental schedule related to the following assets:

NOTE 4 – TAX STATUS

The Internal Revenue Service has determined that the prototype plan, in a letter dated September 4, 2001, and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and its legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examination for years ended prior to June 30, 2021.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan to discontinue contributions at any time, and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 - ROLLOVERS

For the year ended June 30, 2024, the Plan had zero rollovers.

NOTE 7 – BONDING REQUIREMENT

The Plan was in compliance with the bonding requirement by ERISA, Title I, Section 412 as of July 1, 2024 and 2023, respectively.

NOTE 8 – RELATED PARTY TRANSACTIONS

Plan investments are managed by John Hancock Trust Company, LLC, the trustee as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management and other services totaled \$103,035 and \$100,792 for the years ended June 30, 2024 and 2023, respectively.

NOTE 9 - SUBSEQUENT EVENTS

Subsequent events have been evaluated by the Plan through April 8, 2025, the date the financial statements were available to be issued.

NOTE 10 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, *Fair Value Measurements* (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Input to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Investments: Investments held by registered investments companies are valued at the daily closing price, as reported by the fund. Investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The investments held by the Plan are deemed to be actively traded.

NOTE 10 - FAIR VALUE MEASUREMENTS (CONTINUED)

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets recorded at fair value have been categorized based upon the fair value hierarchy in accordance with FASB ASC 820. The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of June 30, 2024 and 2023.

Gains and losses included in changes in net assets available for benefits for the years ended June 30, 2024 and 2023, are reported in the net appreciation (depreciation) in fair value of investments. Unrealized gains/(losses) from the guaranteed investment contract are not reported in the statement of changes in net assets available for benefits as the contract is recorded at contract value for presentation in the net assets available for benefits.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
