## Independent Auditor's Report

**Note 1 - Description of the Plan**

The following description of the Seattle Pacific University Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established by Seattle Pacific University (SPU) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), for the benefit of eligible employees of SPU. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** - Effective July 1, 2023, employees who are at least 21 years of age and have completed at least one hour of service on or after July 1, 2023 became immediately eligible for the Plan. Prior to July 1, 2023, employees who were at least 21 years of age and completed one year of service, as defined by the Plan, were eligible to participate in the Plan. Adjunct faculty and students are not eligible to participate in the Plan.

**Plan Administration** - The Plan is administered by SPU. Transamerica and TIAA perform recordkeeping services for the Plan.

**Contributions** - Effective July 1, 2023, SPU contributes 7% of each participant's eligible compensation, as defined by the Plan, plus an additional amount equal to 5.7% of each participant's wages in excess of the social security taxable wage base. Employees may not make deferral contributions to the Plan but may rollover funds from other eligible plans as defined by the Plan.

**Participant Accounts** - Each participant's account is valued daily and credited with an allocation of SPU's contribution and plan earnings and/or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the value of individual investments in each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeitures** - Participants are fully vested in their rollover contributions and earnings thereon. Each participant vests in the portion of his or her account related to SPU's contributions and earnings thereon based on years of service at SPU according to the following schedule for participants who do not complete at least one hour of service on or after July 1, 2023:

Years of Service	Percentage Vested
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Participants who complete at least one hour of service on or after July 1, 2023 will be 100% vested in SPU's contributions and earnings thereon.

**Note 1 - Continued**

Upon termination of employment by a participant, any unvested contributions and earnings thereon are forfeited and may be used first to pay plan expenses and then to reduce SPU's future contributions to the Plan. Forfeitures are reinstated for employees who are rehired within five years of termination of employment in accordance with the provisions of the Plan. For participants who terminate and have a vested accumulation of \$1,000 or more, the nonvested portion of their account is not forfeited until the five-year break in service is completed. If such participant takes a distribution of the vested accumulation, a forfeiture results at that time. Forfeitures of unvested contributions and earnings thereon used to pay plan expenses and to offset SPU's contributions were approximately \$21,000 and \$155,000 for the years ended June 30, 2024 and 2023, respectively. At June 30, 2024 and 2023, there were approximately \$35,000 and \$14,000, respectively, of unallocated assets.

**Benefit Payments** - Upon termination of service, death, disability, attainment of age 62 or retirement, a participant or beneficiary may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or an annuity to be paid over a fixed reasonable period of time, not exceeding the life expectancy of the participant or designated beneficiary, or other payment forms as designated under the Plan.

Terminated participants or their beneficiaries with account balances of \$1,000 or less will automatically receive the value of their account as a lump-sum distribution. Terminated participants with an account balance of more than \$1,000 but less than or equal to \$5,000 will be payable to a participant or their beneficiary in the form of a direct rollover to an individual retirement account.

**Investment Options** - Participants can direct contributions (or transfer their account balance) into shares of registered investment company funds held by State Street Bank and Trust Company (State Street), a guaranteed investment contract issued by Standard Insurance Company (Standard), or a self-directed brokerage account. Participants may change their investment elections daily.

The Plan also holds shares of registered investment company funds held at TIAA Trust, N.A., separate accounts funding variable annuity contracts issued by TIAA and CREF, and guaranteed investment contracts issued by TIAA and referred to as the TIAA Traditional Annuity. Participants may elect to transfer their account balance from TIAA and CREF (or a portion of their account balance) to State Street or Standard. However, account balances are not allowed to be transferred from State Street and Standard to TIAA and CREF.

**Subsequent Events** - The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.

**Note 2 - Summary of Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses.

**Benefit Payments** - Benefits paid to participants are recognized when they are paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution on the statement of changes in net assets available for benefits.

**Investment Management Fees and Administrative Expenses** - The Plan's investment options are subject to management fees based on a percentage of invested assets. All such fees are charged directly against the investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Certain fees for recordkeeping services provided by Transamerica are paid from the Plan. The majority of the Plan's other administrative expenses are paid by SPU.

**Note 3 - Guaranteed Investment Contracts**

The TIAA Traditional Annuity is a guaranteed investment contract (fixed annuity contract) available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders.

The Plan holds two types of TIAA Traditional Annuity contracts including Retirement Annuities (RA) and Group Retirement Annuities (GRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

RA contracts do not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. With the GRA contracts, lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). RA and GRA contracts do not meet the fully benefit-responsive investment contract criteria and are reported at contract value, which approximates fair value. See Note 4 for discussion of fair value measurements.

During the accumulation phase of the contract, contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The Plan also holds a guaranteed investment contract with Standard that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's ability to receive amounts due in accordance with the contract is dependent on Standard's ability to meet its financial obligations. Standard's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with Standard. Examples of such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the SPU's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, or failure to adopt the Plan in a reasonable period of time.

**Note 4 - Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market delay correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Guaranteed Investment Contracts - As discussed in Note 3, the Plan's TIAA Traditional Annuity RA and GRA contracts are not considered fully benefit-responsive. Nonfully benefit-responsive investment contracts are required to be reported at fair value; however, the Plan's financial statements reflect RA and GRA contracts at their contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. Reporting RA and GRA contracts at contract value did not have a material effect on the Plan's financial statements as contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA's Traditional Annuity's historical crediting rates. Fair value is determined annually for financial statement reporting purposes. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of existing contracts, historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are substantiated utilizing available market data (e.g. Treasury yields).

Separate Accounts - CREF is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. The fair values of accumulation units are based on each account's daily published net asset value (NAV). Except for the CREF Money Market Account, NAV is based on the market value of each account's holdings determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units is published daily and based on the market values of the underlying real estate properties determined by external appraisals, which are estimates of property based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - These accounts primarily consist of registered investment company funds which are valued as previously described.

**Note 5 - Certified Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment income or loss for the year ended June 30, 2024, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company, Transamerica Financial Life Insurance Company, TIAA and CREF. TIAA has been authorized by TIAA Trust, N.A. to certify investments for which TIAA Trust, N.A. is the directed custodian.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

**Note 6 - Party-in-Interest Transactions**

Plan investments include shares of registered investment company funds managed by an affiliate of TIAA and fixed and variable annuity contracts issued by TIAA and CREF. TIAA provides recordkeeping services to the Plan; therefore, transactions with these investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers which are also party-in-interest transactions.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, SPU has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

**Note 8 - Tax Status**

The Plan obtained its latest determination letter dated April 22, 2014, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and Plan's tax counsel believe that the Plan is designed and currently being operated, in accordance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

**Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
