Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplementary information, as listed in the accompanying table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary information, other than the information in the supplementary information that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplementary information agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions and an agent on behalf of a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of the Plan

The following description of the Seattle Pacific University Employee Savings Plan - 403(b) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Seattle Pacific University (SPU) under the provisions of Section 403(b) of the Internal Revenue Code (IRC), for the benefit of eligible employees of SPU. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees of SPU are eligible to make elective deferrals to the Plan except for nonresident aliens and students paid through student employment whose income is exempt from FICA under the IRC.

Plan Administration - The Plan is administered by SPU. Transamerica, TIAA, and Fidelity perform recordkeeping services for the Plan.

Contributions - Eligible employees may elect to defer up to 100% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the calendar year and participants completing 15 years of service with SPU are eligible to make catch-up contributions to the Plan. The Plan has an auto-enrollment provision whereby all newly eligible employees, other than adjunct faculty and temporary employees, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a qualified default investment option until changed by the participant. Deferral rates for automatically enrolled participants will automatically increase by 1% per year until they reach a maximum of 6% unless the participant elects otherwise. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Participant Accounts - Each participant's account is valued daily and credited the employee's elective deferral and an allocation of plan earnings and/or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocation of plan earnings and/or losses is based on the value of individual investments in each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all contributions to the Plan plus actual earnings thereon.

Notes Receivable From Participants - Participants can take a loan from their vested account balance subject to certain limitations. Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Loans must be repaid pursuant to a level, fixed repayment schedule not to exceed five years, unless for a residential mortgage. Loans are secured by the balance in the participant's account and bear interest at a reasonable fixed rate based on prevailing commercial lending rates for comparable loans. Principal and interest are paid through automatic payroll deductions. Participants may not have more than one loan outstanding at any given time.

Benefit Payments - Upon reaching normal retirement age, termination of service, death, or disability, a participant or beneficiary may elect to receive either a lump-sum distribution equal to the value of the participant's account, or an annuity to be paid over a fixed reasonable period of time, not exceeding the life expectancy of the participant or designated beneficiary, or other payment forms as designated under the Plan. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawal). The Plan allows for hardship withdrawals in accordance with the provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Terminated participants or their beneficiaries with account balances of \$1,000 or less will automatically receive the value of their account as a lump-sum distribution. Terminated participants with an account balance of more than \$1,000 but less than or equal to \$5,000 will be payable to a participant or their beneficiary in the form of a direct rollover to an individual retirement account.

Investment Options - Participants can direct contributions (or transfer their account balance) into shares of registered investment company funds held by State Street Bank and Trust Company (State Street), a guaranteed investment contract issued by Standard Insurance Company (Standard), or a self-directed brokerage account. Participants may change their investment elections daily.

The Plan also holds shares of registered investment company funds held at Fidelity and TIAA Trust N.A., separate accounts funding variable annuity contracts issued by TIAA and CREF, and guaranteed investment contracts issued by TIAA and referred to as the TIAA Traditional Annuity. Participants may elect to transfer their account balance from TIAA, CREF and Fidelity (or a portion of their account balance) to State Street or Standard; however, account balances are not allowed to be transferred from State Street and Standard to TIAA, CREF, or Fidelity.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Benefit Payments - Benefits paid to participants are recognized when they are paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution on the statement of changes in net assets available for benefits.

Investment Management Fees and Administrative Expenses - The Plan's investment options are subject to management fees based on a percentage of invested assets. All such fees are charged directly against the investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Certain fees for recordkeeping services provided by Transamerica are paid from the Plan. The majority of the Plan's other administrative expenses are paid by SPU.

Subsequent Events - The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.

Note 3 - Guaranteed Investment Contracts

The TIAA Traditional Annuity is a guaranteed investment contract (fixed annuity contract) available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders.

The Plan holds three types of TIAA Traditional Annuity contracts including Retirement Annuities (RA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

RA contracts do not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). RA contracts do not meet the fully benefit-responsive investment contract criteria and are reported at contract value, which approximates fair value. See Note 4 for discussion of fair value measurements.

SRA and GSRA contracts are fully cashable in a lump-sum and without a surrender charge. The SRA and GSRA contracts meet the fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. For SRA and GSRA contracts, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with participants.

During the accumulation phase of the contract, contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The Plan also holds a guaranteed investment contract with Standard that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's ability to receive amounts due in accordance with the contract is dependent on Standard's ability to meet its financial obligations. Standard's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with Standard. Examples of such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the SPU's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, or failure to adopt the Plan in a reasonable period of time.

Note 4 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market delay correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Guaranteed Investment Contracts - As discussed in Note 3, the Plan's TIAA Traditional Annuity RA contracts are not considered fully benefit-responsive. Nonfully benefit-responsive investment contracts are required to be reported at fair value; however, the Plan's financial statements reflect RA contracts at their contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. Reporting RA contracts at contract value did not have a material effect on the Plan's financial statements as contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA's Traditional Annuity's historical crediting rates. Fair value is determined annually for financial statement reporting purposes. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of existing contracts, historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are substantiated utilizing available market data (e.g. Treasury yields).

Separate Accounts - CREF is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. The fair values of accumulation units are based on each account's daily published net asset value (NAV). Except for the CREF Money Market Account, NAV is based on the market value of each account's holdings determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units is published daily and based on the market values of the underlying real estate properties determined by external appraisals, which are estimates of property based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - These accounts primarily consist of registered investment company funds which are valued as previously described.

Note 5 - Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment income or loss for the year ended June 30, 2024, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company, Transamerica Financial Life Insurance Company, TIAA, CREF and Fidelity Management Trust Company. TIAA has been authorized by TIAA Trust, N.A. to certify investments for which TIAA Trust, N.A. is the directed custodian.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

Plan investments include shares of registered investment company funds managed by an affiliate of TIAA and fixed and variable annuity contracts issued by TIAA and CREF. The Plan's investments also include shares of registered investment company funds managed by Fidelity. TIAA and Fidelity provide recordkeeping services to the Plan; therefore, transactions with these investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, SPU has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan's management believes that the Plan is currently designed and being operated in a manner that did not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the Internal Revenue Service (IRS); however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
