## INDEPENDENT AUDITORS' REPORT

To the Trustees of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Just Kids 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Just Kids 401(k) Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Cam-Held Enterprises, Inc.'s (the "Employer" or "Plan Sponsor") management, who is responsible for the integrity and objectivity of the financial statements. Cam-Held Enterprises, Inc. and Just Kids Diagnostic and Treatment Center, Inc. are related entities under common ownership. The Plan covers eligible employees of both entities. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments in mutual funds and common/collective trusts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a further discussion of fair value measurements. The Plan's fully benefit-responsive investment account is reported at contract value (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. During the year ended June 30, 2024, the Plan's net investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$1,980,725.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Events Occurring After the Report Date: The Plan Sponsor has evaluated events and transactions that occurred between July 1, 2024, and April 7, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. Any such disclosures have been reflected within the financial statements.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document, which is available from the Plan administrator, for a more complete description of the Plan's provisions.

General: The Plan, established January 1, 1989, is a participant-directed defined contribution plan covering all eligible employees of the Plan Sponsor who have completed at least six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Empower Retirement, LLC ("Empower Retirement") served as the Plan record-keeper through June 30, 2024. Empower Retirement uses Empower Trust Company, LLC, formerly known as Great West Trust Company, LLC as well as Empower Life & Annuity Insurance Company of New York (the "Custodian"), for its trustee and custodial services. The Plan Sponsor elected to change the Plan's record-keeper and custodian with a planned effective date of July 1, 2024. On June 28, 2024, the Plan's investments, excluding the guaranteed investment account, were liquidated and transferred to the new custodian. Service contracts for the new record-keeper and custodian did not begin until July 1, 2024. As of July 1, 2024, Vanguard Retirement Plan serves as the Plan record-keeper and Ascensus Trust Company serves as the Plan custodian. The Plan Sponsor uses United Benefit Pensions, Inc. as its third-party administrator.

Contributions: Contributions are subject to certain limitations. Employees may elect to defer a maximum amount not to exceed Internal Revenue Service ("IRS") limits for the Plan year ended June 30, 2024. In addition, participants who attained age 50 by June 30, 2024 were eligible to make an additional bonus deferral. Each year, participants may contribute to the Plan a percentage of eligible compensation, as defined in the Plan document, or in specific dollar amounts. Eligible compensation for the Plan is defined by the Plan document as W-2 wages, excluding compensation in addition to base pay, plus elective deferrals. Participants may also contribute amounts distributed from other qualified plans.

The Plan also allows participants to designate a portion of their contributions to be treated as "Roth" contributions. A contribution treated as a Roth contribution is subject to current federal income tax at the time it is contributed to the Plan. However, if certain requirements are satisfied prior to the distribution of such amounts from the Plan, distributions of amounts attributable to Roth contributions (including earnings thereon) will not be subject to federal income tax at the time of distribution.

**NOTE 2 - DESCRIPTION OF THE PLAN (continued)**

Effective July 1, 2021, the Plan was amended to include an automatic enrollment feature known as an eligible automatic contribution arrangement. Unless participants elect otherwise, participants will be automatically enrolled to defer 3% of eligible compensation. There is no automatic escalation feature. Contributions will be invested in a qualified default investment alternative until changed by each participant.

The Plan also provides for non-elective employer contributions. Participants are eligible to receive employer contributions upon working 950 hours during the Plan year and if they are employed on the last day of the Plan year. Non-elective employer contributions are calculated by employee classification. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with each participant's contribution, any employer contributions, earnings and an allocation of administrative expenses. As a participant-directed plan, each participant's investment choices determine his/her share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Plan Sponsor contributions are vested in accordance with the following schedule:

Forfeitures: Forfeitures are applied against any employer contributions made during the Plan year or used to pay Plan expenses. The forfeiture balance at June 30, 2024 and 2023 totaled \$56,599 and \$29,905, respectively.

Investment Options: Upon enrollment in the Plan, participants may direct the Custodian to invest contributions in various investment options managed by the Custodian, its affiliates, and other large investment management companies. Participants may change their investment options, transfer part or all of past investments to other funds, and change their deferral rates at any time.

Notes Receivable From Participants: Participants may borrow from their vested fund account balances, a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or one-half of the value of their vested fund account balances. The maximum payment term allowed for any loan is five years unless the loan qualifies as a residential mortgage loan, in which case the term may not exceed fifteen years. The loans are secured by the balance in each participant's

account and bear interest at prevailing market rates at the time the loan is taken. Outstanding loans at June 30, 2024 bear interest ranging from 4.25% to 9.50% per year. Principal and interest is paid ratably through payroll deductions.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan (deemed distribution) which could result in taxable income to the participant. During the year ended June 30, 2024, there were three deemed distributions totaling \$3,559.

In-Service Withdrawals: In-service or hardship withdrawals are permitted by the Plan for active employees when they reach the age of 59 ½ or in the event of financial hardship.

Payment of Benefits: On termination of service due to death, disability, or retirement as defined in the Plan, participants are generally entitled to payments of their full account balances in the form of lump-sum payments. On termination of service due to other reasons, the balance of a participant's vested account becomes distributable to him/her upon election. If a participant terminates with a vested account balance that does not exceed \$5,000 and did not consent to a distribution, the participant's account will be distributed into a rollover IRA to be established by the record-keeper on the participant's behalf.

Required minimum distributions as mandated by IRS regulations will commence when a participant attains age 72. Due to changes made by the Setting Every Community Up for Retirement Enhancement ("SECURE 2.0 Act of 2022"), effective January 1, 2023, the required minimum distributions age increases to age 73.

Administrative Expenses: The Plan pays for all investment-related expenses, while the Plan Sponsor pays for all other costs of maintaining and administering the Plan.

Plan Amendments: The Plan Sponsor has a right under the Plan to amend the Plan at any time.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed pursuant to the Plan document.

**NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN**

Investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable held at June 30, 2024 and 2023, and the ERISA-required supplemental schedule, net appreciation in fair value of investments, interest and dividends, and notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan Sponsor utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset and liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during the year ended June 30, 2024.

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV is based upon quoted market prices.

Common/Collective Trusts: Valued at the NAV of units held by the Plan at year-end. The NAV is determined by the Custodian of the funds and is based upon the fair value of the underlying assets held by the funds.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As described in Note 2, the Plan’s investments, excluding the guaranteed investment account, were liquidated as of June 28, 2024 and held as cash and cash equivalents by Ascensus Trust Company until its service contract began on July 1, 2024. The assets were subsequently reinvested in accordance with the investment elections of the participants.

(a) This category includes a common/collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings, valued at the NAV of units held by the plan at year-end. The NAV is determined by the Custodian of the fund and is based on the fair value of the underlying assets held by the fund. In accordance with ASC Topic 820, *Fair Value Measurements*, certain investments are measured at fair value using the NAV per share (or its equivalent) practical expedient that have not been classified in the fair value hierarchy. The fair value amount presented in this table is intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

**NOTE 5 - GUARANTEED INTEREST ACCOUNT**

The Plan holds a fully benefit-responsive guaranteed interest account (“GIA”) with the Custodian. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIA issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIA. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The GIA is invested in various variable annuities. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract approximated fair value as of June 30, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed periodically for resetting by Empower Retirement. The average and actual yield credited to participants for the year ended June 30, 2024 was 1.58%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business. Such events also include: (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Plan's GIA contract was not terminated as planned by July 1, 2024, and therefore, the asset balance was not liquidated and transferred to Ascensus Trust Company by July 1, 2024. Participants are able to transfer their balance to Ascensus Trust Company. Any funds remaining are expected to be automatically migrated to Ascensus Trust Company by July 2025.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 7 - TAX STATUS**

The Plan Sponsor elected to adopt Empower Retirement's volume submitter plan, which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - TRANSACTIONS WITH PARTY-IN-INTEREST**

At June 30, 2024 and 2023, certain Plan investments were managed by the Custodian and managed by Ascensus Trust Company at June 30, 2024, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in administrative expenses. Participant loans also qualify as party-in-interest transactions.
