Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan for Graham-Windham Services to Families and Children (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting as described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of (1) Schedule H, Part IV, Line 4a – Schedule of Delinquent Participant Contributions (modified cash basis) for the year ended June 30, 2024 and (2) Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) as of June 30, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules (modified cash basis), we evaluated whether the supplemental schedules (modified cash basis), other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules (modified cash basis), other than the information in the supplemental schedules (modified cash basis) that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules (modified cash basis) related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the 403(b) Thrift Plan for Graham-Windham Services to Families and Children (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan covering substantially all employees of Graham-Windham Services to Families and Children (the "Employer"). Effective March 1, 2025, the name of the Employer was amended to Graham Windham. An employee is eligible for participation in the Plan upon his or her date of hire. Employees are not eligible to participate in the Plan if they are leased employees or non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to complete a salary reduction agreement and an enrollment form. The salary reduction agreement between the employee and Employer states either a percentage of compensation or dollar amount will be contributed to the Plan each pay period. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employer.

The Employer makes matching contributions on behalf of each participant who has completed at least 1 year of service (i.e., a period of twelve consecutive months with at least 1,000 hours of service) and has attained at least 21 years of age. The participant will receive the lesser of (a) 50% of the eligible participant's salary reduction contributions deferred during the Plan year while the participant satisfied the participant requirements for Employer matching contributions, or (b) 1% of their eligible gross wages while the participant satisfied the requirements for receiving an Employer matching contribution.

There are annual dollar limits provided by the Internal Revenue Code ("IRC") regarding the amounts which can be contributed by a participant, and which can be allocated to a participant in a qualified retirement plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan permits participants to contribute amounts representing distributions from other qualified plans (rollover contributions).

Vesting

A participant is immediately vested in his/her contributions plus actual earning thereon. For Employer contributions, a participant is vested 20% upon 2 years of service, 60% upon 3 years of service, 80% upon 4 years of service, and 100% upon completion of 5 years of service.

Investment Elections

Each participant files an election form designating the portion in which contributions on behalf of the participant are to be allocated among several investment funds. Investment options may be changed at the participant's discretion.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations of Plan earnings are based on each participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Forfeitures

If a participant terminates his or her employment with the Employer, the non-vested contributions plus allocated earnings thereon may be used to reduce future Employer contributions. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$965 and \$0. During 2024 and 2023, \$25,837 and \$15,116 of forfeitures were used to reduce Employer contributions.

Loans to a Participant / Collateralized Assets

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Loans are limited to voluntary and rollover contributions and only one loan may be made in any twelve consecutive month period. Defaults on loans are treated as a distribution at the time of default against the participant's account.

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of the lesser of 50% of the employee's voluntary and/or rollover contributions or \$50,000. Loans to the participant are made directly from Mutual of America Life Insurance Company ("MOA"). The participant's account is not reduced by the loan amount, but serves as security for the loan. The loan amount is moved into a fixed income collateral account within the borrower's account. The loan must be repaid directly to MOA within a five year period in substantially equal payments (not less frequently than quarterly). The five year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, his or her loan will be deemed in default.

Loans to a Participant / Collateralized Assets (continued)

At June 30, 2024 and 2023, there were 78 and 81 loans outstanding with total principal balances due of \$319,547 and \$252,363, which also represents a collateralization of participant accounts. During the years ended June 30, 2024 and 2023, 8 and 13 loans were defaulted and \$11,085 and \$21,221 was included in benefits paid to participants. Interest rates on the loans were between 4.6% and 5.85% with maturities through 2031.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. A participant may not withdraw any amounts allocated to his or her Employer contribution account before he or she terminates employment. However, the Plan allows for distributions from employee and Employer contributions for hardship withdrawals, or after the attainment of age 59 ½.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Under this basis, contributions and investment income are recognized when received and expenses are recognized when paid, except for investments and the related gains or losses which are measured at fair value. Management has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist. As of June 30, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The insurance company general account is valued at contract value and represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Investments in separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses relating to investment management are paid directly by the respective investment vehicle and are included as a reduction to net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 8, 2025.

3. Information Certified (Unaudited)

Certain information related to investments in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

4. Insurance Company General Account

Amounts placed in the MOA Interest Accumulation Account are credited with interest at a rate determined by MOA. MOA guarantees to credit interest for the life of the contract to amounts in the MOA Interest Accumulation Account of their general account at a rate at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula and cannot be less than 2.85% for 2024 and 1.60% for 2023. MOA determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In MOA’s sole discretion, it may credit a higher rate of interest to a participant’s contract in the general account, although it is not obligated to credit interest in excess of the minimum guaranteed rate. MOA compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The principal and previously credited interest is guaranteed by MOA. This guarantee is subject to MOA’s financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A as of February 2023), Standard and Poor’s (A as of December 2022), and Fitch (A- as of March 2024).

The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value. The MOA Interest Accumulation Account represents approximately 20% and 21% of the net assets available for benefits as of June 30, 2024 and 2023.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

6. Tax Status

The Employer has an IRS approved volume submitter plan that received an IRS opinion letter dated March 31, 2017. The Employer believes that the Plan, as amended, is designed and currently being operated in compliance with applicable sections of the IRC.

U.S GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest

All Plan investments are managed by MOA. MOA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Separate accounts are reported at the value provided to the Plan by MOA. Included in this value are fees which are netted in the appreciation of the fair value of these investments which are considered party-in-interest transactions.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

8. Prohibited Transactions

During fiscal year 2024 and 2023, the Employer failed to remit to the Plan certain participants' contributions totaling \$485,781 and \$366,602, within the period prescribed by Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight and the Employer is in the process of making the necessary corrections. The lost earnings calculated on the late remittances totaled approximately \$359 and \$609.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
