### 1. Description of Plan

Effective July 1, 2017, Victor Community Support Services Profit Sharing Plan was renamed Victor Community Support Services, Inc. Retirement Plan (“the Plan”). Additionally, effective July 1, 2017, eligibility conditions require participant to meet the age requirement of 21 years old and possess two years of service with Victor Community Support Services, Inc. (“VCSS”).

The following description of the Plan provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a non-contributory defined contribution retirement plan of VCSS. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

VCSS and Victor Treatment Centers, Inc. (a related party) have each established separate plans that use separate contribution formulas and maintain separate investment accounts. These plans may allow that service in any of these entities be combined for purpose of qualification for contribution, allocation, and vesting. A contribution will be allocated based upon the compensation received in each individual entity using the combined hours for all entities.

#### Plan Benefits

The Plan covers all employees of VCSS. Employees who are at least twenty-one years of age and have completed two years of service are eligible to participate in the Plan. Eligible employees enter the Plan on the earlier of January 1 or July 1 immediately following the meeting of the requirements above.

Participants must work at least 1,000 hours during a plan year and must be an active employee on the last day of the plan year to be eligible to receive an allocation of that year’s annual employer contribution. Annual employer contributions are at the discretion of VCSS.

Annual employer contributions are allocated to each participant in the same ratio that each participant’s benefit factor for the plan year bears to the sum of the benefit factors of all participants for the plan year. A participant’s benefit factor is his/her compensation multiplied by the actuarial factor in Appendix A of the Plan.

Plan earnings less expense are allocated to all participants (active and those pending distribution) based upon their proportional beginning balances.

#### Termination

If an employee terminates prior to six years of service, except for reasons of death or attaining normal retirement age (as defined by the Plan), they forfeit the right to receive a portion of their accumulated plan benefits. Plan benefits are paid to terminated employees in one lump sum.

**1. Description of Plan, continued**

**Vesting**

Vesting for employer contributions is pro-rated on years of continuous service. A participant is 100% vested after 5 years of credited service. A year of credited service is defined by the Plan as 1,000 hours worked in a plan year.

Participants subject to the eligibility conditions implemented effective July 1, 2017 are 100% vested after two years of credited service.

**Payment of Benefits**

Benefits under the Plan generally may be paid in the form of a lump-sum amount equal to the value of the participant's vested account balance.

**Forfeitures**

Upon termination of employment, non-vested portions of the participant's accounts are forfeited. Forfeitures are allocated to the remaining participants in the same manner as employer contributions. For the years ended June 30, 2024 and 2023, forfeited, non-vested accounts which were fully reallocated during those plan years totaled \$38,489 and \$151,652, respectively.

**Death Benefits**

If an active employee dies, the employee's benefit becomes 100% vested and the beneficiary will receive the balance of the employee's account.

**2. Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, revenues, and expenses as of the date and for the period presented. Actual results could differ from those estimates.

**Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments and revenue at fair value. The specific techniques used to measure fair value for these financial statement elements are described in the notes below that relate to each element.

**Administrative Expenses**

The Plan absorbs all the custodian expenses of the plan. All other plan administrative expenses are paid by the employer. During 2024 and 2023, total custodian expenses of the Plan were \$82,076 and \$80,135, respectively.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the statement of net assets available for benefits.

**Subsequent Events**

Management has evaluated subsequent events through April 5, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Investments**

The Plan's investments are held by Charles Schwab. During the years ended June 30, 2024 and 2023, the Plan's investments (including investments bought, sold, and held during the years) appreciated in value by \$1,487,478 and \$670,350, respectively.

**5. Plan Termination**

Although it has not expressed any intent to do so, VCSS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**6. Tax Status**

The trust established under the Plan to hold the plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service ("IRS") and the plan sponsor believes that the Plan continues to qualify and to operate as designed.

**6. Tax Status, continued**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**7. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as VCSS' payment of certain Plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$82,076.

The Plan's investment options include funds managed by Charles Schwab or its affiliates. As custodian and recordkeeper, Charles Schwab's transactions qualify as exempt parties-in-interest transactions.
