Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Legal Aid Society Retirement Plan (Plan No. 006—a defined contribution plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by a qualified institution and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4(i)—schedule of assets (held at end of year) as of June 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following description of The Legal Aid Society Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions. This Plan has the same name as another plan sponsored by The Legal Aid Society (the Society or Plan Sponsor), identified as Plan No. 001, which is a defined benefit plan.

General: The Plan is a noncontributory defined contribution plan established on December 1, 2004, covering all employees (except union member employees) of the Society. The Plan is administered by the Society's Retirement and Benefits Committee (the Committee), which is appointed by the board of directors of the Society and is responsible for carrying out provisions of the Plan.

The Plan was most recently amended and restated effective March 31, 2022, upon adoption of the Principal Financial Group Pre-Approved Document for Profit Sharing Plans sponsored by Principal Life Insurance Co. (Principal). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Non-union employees must be 18 years of age to become a participant. There is no service eligibility requirement to participate in the Plan. However, participants must complete a year of service (1,000 hours) during the plan year to be eligible to receive the nonelective contribution.

Contributions: The Plan provides for nonelective contributions based on the eligible compensation of the participants in the Plan. The amount of nonelective contributions will be determined each plan year. For the year ended June 30, 2024, the amount of contribution was 6.5% of the participants' eligible compensation. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participants' accounts: The Plan allows for a participant-directed investment program under Section 404(c) of ERISA, as amended. Each participant's account is credited with an allocation of (a) the employer's contribution and (b) Plan earnings. Administrative expenses are prorated to participants' accounts. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. All of the Plan's investments are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. Payment is made either in a lump sum or in installment payments.

Vesting: Participants become 100% vested after three years of vesting service or normal retirement date (age 65).

Forfeitures: Participants who have a break in service prior to the normal retirement date and prior to becoming vested forfeit the right to their account. Such amounts are maintained in a separate account until the participant incurs a break in service of five years, at which time the account is forfeited. Forfeited amounts will be used first to reinstate participant accounts, if applicable, then to reduce plan expenses, if any, and then to reduce future employer contributions to the Plan. The forfeited nonvested account balances as of June 30, 2024 and 2023, were \$225,926 and \$184,340, respectively. During the year ended June 30, 2024, no forfeitures were used to reduce the employer contribution. During the year ended June 30, 2024, \$8,965 of forfeited nonvested account balances were used to reduce plan expenses, and \$76,949 of forfeited nonvested account balances were allocated to participant accounts.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These transactions are treated as a transfer between the investment fund and the participant notes fund. The notes receivable from participants have terms that range from one to five years or up to 30 years for a home loan, as defined, and are secured by the balance in the participants' accounts. The receivable will bear interest when issued at a fixed rate equal to 1% over the prime rate. At June 30, 2024, the interest rate charged on these notes receivable from participants ranged from 4.25% to 9.5%. Participants may have no more than two note receivables outstanding, as defined. Repayment of both principal and interest are made by payroll deductions of equal amounts.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Society. Expenses that are paid by the Society are excluded from these financial statements. Certain fees related to recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events: The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was April 7, 2025, for these financial statements.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of investments and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer's contributions and employer's contributions receivable: Contributions receivable are reported at their outstanding balances net of an estimated reserve for doubtful accounts. Contributions are recorded based on management's intent at year-end to fund an employer contribution. As of June 30, 2024 and 2023, the allowance was \$0.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Note 3. Information Certified and Provided by the Trustee

The following is a summary of the Plan's asset information as of June 30, 2024 and 2023, and for the year ended June 30, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Delaware Charter Guarantee & Trust Company d.b.a. Principal Trust Company, a member of the Principal Financial Group, the Plan trustee. The Plan Administrator has obtained certifications from the trustee as of June 30, 2024 and 2023, and for the year ended June 30, 2024, that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The trustee also certified the completeness and accuracy of net appreciation in the fair value of investments of \$5,014,655, dividend and interest income of \$28,722 and interest income on notes receivable from participants of \$46,851 related to the aforementioned plan assets for the year ended June 30, 2024.

Note 4. Guaranteed Fund Contract

The Plan invests in a fully benefit-responsive single group annuity contract (guaranteed fund contract) with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed fund contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of net assets available for benefits attributable to the guaranteed fund contract. This contract is included in the financial statements at contract value, as reported to the Plan by Principal.

Note 4. Guaranteed Fund Contract (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest rates are reviewed on an annual basis for resetting. The investment contract is a single group annuity contract with a fixed rate of interest based on a formula established by the contract issuer but may not be less than 1%. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be typically found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (interest credited) on the group annuity contract. The interest rate credited was 4.35% from July 2023 through November 2023, and 4.65% from December 2023 through May 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan adoption agreement (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed fund contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price, which constitutes an active market.

Pooled separate accounts: Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimating fair value. The fair value of the underlying holdings have publicly quoted pricing inputs and are used in determining the NAV of the pooled separate account, which is not publicly quoted.

Collective investment trust funds: Valued based on the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The fair value of all these investments are used in determining the NAV of the collective investment trust, which is not publicly quoted. Each fund is invested based on a predetermined asset allocation of equities and fixed income instruments that matches participants expected retirement date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Society may terminate the Plan at any time. Upon termination, participants will automatically become 100% vested and the assets of the Plan will be administered in a manner that is consistent with the provisions of the Plan.

Note 7. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, Principal, has received on June 30, 2020, an opinion letter from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Party-in-Interest and Related-Party Transactions

Certain plan investments are shares of funds managed by Principal and their affiliates, which are affiliated with the trustee of the Plan. The transactions in these investments qualify as exempt party-in-interest transactions under ERISA. The Society provides administrative services to the Plan at no cost.

Note 9. Risks and Uncertainties

The Plan's investment choices include a variety of funds at various risk levels, which participants in the Plan self-direct. The Plan invests in various investment securities and funds. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities in investment options selected by participants, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
