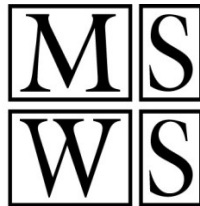

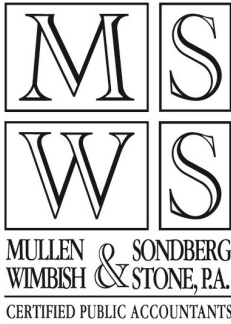

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Board of Directors of  
403(b) Thrift Plan for Employees of Second Family, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan for Employees of Second Family, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan for Employees of Second Family, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Note 1 - Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Second Family, Inc. provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General:* The 403(b) Thrift Plan for Employees of Second Family, Inc. (the Plan), was established June 1, 2021. The Plan is a 403(b) defined contribution plan. The Plan covers substantially all employees of Second Family, Inc. (the Employer) who work normally more than twenty hours per week. Under the provisions of the Plan, an employee may become eligible to participate in the Plan immediately and receive employer discretionary base contributions after completing three months of service. Per Plan provisions, there is no service requirement for employee elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions:* The Plan includes an automatic contribution arrangement whereby all employees who become participants on or after June 1, 2021 shall be deemed to have directed the Employer to make salary reduction contributions on his or her behalf based on a nonqualified graduated percentage based on 1% of compensation for the initial plan year in which automatic enrollment contributions commenced, 1% for the next plan year following the plan year in which automatic enrollment contributions commenced, 2% for the second plan year following the plan year in which automatic enrollment contributions commenced, and 3% for the third year (and each subsequent) plan year in which the automatic contributions commenced. Participants may also elect to defer up to 100% of compensation, up to statutory limits set by the Internal Revenue Service as adjusted each year, as defined in the Plan. Participants may also elect to opt-out of participation in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor determines at its sole discretion how much, if any it will make as an employer discretionary contribution. During the years ended June 30, 2024 and 2023, the employer discretionary contribution amounted to \$387,801 and \$324,164, respectively.

*Participant Accounts:* Each participant's account is charged with applicable fees and credited with the participant's contribution and allocations of (a) the employer's base contribution and, (b) plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator.

*Forfeitures:* Contributions to forfeited non-vested accounts during the years ended June 30, 2024 and 2023 amounted to \$10,800 and \$5,102, respectively. Non-vested forfeiture account balances used to reduce employer contribution and pay plan expenses for years ended June 30, 2024 and 2023, amounted to \$10,518 and \$-0-, respectively. Forfeited non-vested accounts account balances amounted to \$22,265 and \$11,089 as of June 30, 2024 and 2023, respectively.

Note 1 - Description of Plan (Cont.)

*Vesting:* Participants are fully vested immediately in their elective contributions plus actual earnings thereon. Participants are vested in the employer discretionary base contributions based on the following years of vesting service schedule:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than 1 year	0%
1 year	50%
2 years	100%

*Notes Receivable from Participants:* Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to 50% of their vested account balance, or \$50,000, whichever is less. The maximum number of loans that a participant may have outstanding under this Plan at one time is one. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the plan administrator and commensurate with the rates currently being charged by commercial lenders in the appropriate geographic area with respect to comparable loans. Repayment of loans is provided through automatic payroll deductions.

*Payment of Benefits:* On termination of service due to death, disability, retirement or early retirement, a participant may elect to receive either a lump sum distribution amount equal to the value of the participant's vested interest in his or her account, or annual installments that do not exceed the life expectancy of the participant or beneficiary. Eligible distributions may also be rolled over into another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

*Administrative Expenses:* The administrative expense related to the Plan's Custodian are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. The loans to participants bear interest at 5.85% and 4.60% at June 30, 2024 and 2023, respectively. The outstanding notes receivable balance due from participants was \$14,522 and \$7,179 as of June 30, 2024 and 2023, respectively.

Contribution Receivable

Contributions from the employer discretionary base contribution are recorded in the year in which the contributions were deemed earned and designated by the plan sponsor. All contributions are participant directed unless directed by the Plan based on requirements determined by the plan document. The plan administrator has determined that all contribution receivables are fully collectible; consequently, no amount has been recorded as an allowance for credit losses in the accompanying statement of net assets available for benefits. The balance of employer contribution receivables as of June 30, 2024 and 2023 was \$103,492 and \$92,285, respectively.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the guaranteed investment contract with an insurance company which is reported at contract value). Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value is the relevant measurement since it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value provides a good approximation of fair value because the value of the investment contract is deemed to be no less than the participant's accumulated balance, and that each investment purchase is made at fair value since these purchases are not distressed and are conducted between willing buyers and sellers in open market conditions where a participant has a variety of investment choices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to terminated participants amounted to \$96,355 and \$64,572 for the years ended June 30, 2024 and 2023, respectively.

New Accounting Pronouncements

In June 2016, the FASB issued *ASU 2016-13, "Financial Instruments – Credit Losses"* (*Topic 326*) which significantly changed how entities will measure credit losses for most financial assets and certain other instruments that aren't measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in *FASB ASC 326* were employer contributions receivable and participant contributions receivable.

The Plan adopted the standard effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in new and enhanced disclosures only.

Note 3 - Information Prepared and Certified by the Custodian

Investment Data

Mutual of America Life Insurance Company is the Custodian for the Plan for the years ending June 30, 2024 and 2023. All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits, Schedule H, line 4i – Schedule of assets (held at end of year) as of June 30, 2024 was obtained from data that has been certified as complete and accurate by the Custodian of the Plan as of June 30, 2024 and 2023.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, line 4i - Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of June 30, 2024.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*ASC 820-10 Fair Value Measurements* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value as of June 30, 2024 and 2023:

*Pooled separate accounts:* valued at the net asset value of the pooled separate accounts, as reported by the Custodian and calculated in a manner consistent with generally accepted accounting principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held in the pooled separate accounts. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's pooled separate accounts as of June 30, 2024 and 2023 was \$2,182,840 and \$1,217,031, respectively.

(a) This category invests in equity securities and fixed income instruments in accordance with each fund's investment objectives. Shares are available for transactions at the closing net asset value per share on any day the NYSE is open for business.

Note 5 - Investment Contracts with Insurance Company

The Plan entered into a benefit-responsive investment contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Mutual of American Life Insurance Company.

The guaranteed investment contract is fully benefit-responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Mutual of American Life Insurance Company, which approximates fair value, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract as of June 30, 2024 and 2023 was \$243,022 and \$177,148, respectively. The credit interest rate is based on a formula agreed upon with the issuer.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Under the terms of the contract, the guaranteed minimum rate is 1.00%.

The value shown, is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value of a withdrawal request.

Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net value of each participant's account balance would be distributed in accordance with the Plan's provisions.

Note 8 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended June 30, 2024 and 2023, there were no reportable transactions.

Note 9 - Tax Status

The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective June 1, 2021, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on March 31, 2017 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letters have been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requires of the IRS and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company, who is the Custodian as defined in the Plan, and therefore, the transactions qualify as party-in-interest transactions. For the years ended June 30, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$3,517 and \$898, respectively.

The Plan's auditor who audits the Plan's financial statements and third-party administrator who provides accounting and administrative services are paid directly by the plan sponsor. These fees are not reflected in these financial statements.

Note 11 - Prohibited Transactions

The accompanying Schedule H, line 4a – Schedule of delinquent participant contributions as of June 30, 2024 reflect participant contributions that were not remitted timely to the Trustee. The effect of the financial statements was an understatement of earnings. The amount is deemed immaterial and has not been recorded in the financial statements.

Note 12 - Subsequent Events

Subsequent events and transactions have been evaluated for potential recognition in the financial statements. There have been no subsequent events through March 30, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.
