NOTE 1 DESCRIPTION OF PLAN

The following description of 401(k) Profit Sharing Plan for Employees of Starting Point Services for Children, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was adopted July 1, 2001, is a defined contribution pension plan covering all employees of Starting Point Services for Children, Inc. (Plan Sponsor) who are age 21 or older, who are not members of a collective bargaining unit, and have completed a year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees is responsible for oversight of the Plan. The custodian of the Plan determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Plan Amendments

The Plan was amended on July 1, 2008 to make investment options participant-directed, on July 1, 2009 to conform with the Economic Growth and Tax Relief Reconciliation Act (EGTRRA), on March 12, 2014 to allow for loans to participants, and on October 1, 2020, to allow for employee contributions and to change from a 401(a) Profit-Sharing Plan to a 401(k) Profit-Sharing Plan.

Effective July 1, 2022, the plan became a safe harbor 401k profit sharing plan. A safe harbor 401(k) is a specific type of 401(k) plan that simplifies compliance with IRS nondiscrimination tests by requiring employers to make specific, fully vested contributions. Starting Point elected to make a qualified nonelective employer contribution to each eligible participant in an amount of 3% of each participant’s compensation. To become an eligible participant, the employee must be age 21 or older and complete a year of service. Under the safe harbor plan, the definition of a year of service changed from completion of 1,000 hours of service to an actual year of service from the date of hire. Once an employee is eligible, the employee can join the plan on the 1st of the first and seventh month of the Plan year.

Contributions

Each year, participants may contribute any amount up to the maximum permitted under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may decide each plan year whether to make a discretionary employer contribution on behalf of eligible employees, allocated to each eligible participant's account in the ratio that the compensation of each eligible participant bears to the total compensation of all eligible participants. There were no profit-sharing contributions made to the Plan for the year ended June 30, 2024. Contributions are subject to certain IRS limitations.

Per the safe harbor guidelines, the plan is required to make a qualified nonelective employer contribution to each eligible participant in an amount of 3% of each participant's compensation. The safe harbor contribution amounted to \$144,231 for the year ended June 30, 2024.

Participant Accounts

Each participant's account is credited with participant's contributions, employer contributions and Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants are credited with vesting service for all years and months of employment. A participant is vested 20% after two years of credited service, with a 20% increase in each succeeding year until becoming fully vested after the sixth year of service. Account balances that are not vested are forfeited upon the employee's termination of employment.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through by-monthly payroll deductions. Participants may have only one loan outstanding at a time.

Payment of Benefits

On termination of service, disability, or upon reaching the age of 59½ a participant may withdraw the funds from his or her account. The participant may elect to receive either a lump sum equal to the value of the participant's vested interest in his or her account, or annual installments.

Forfeited Accounts

As of June 30, 2024, and 2023, forfeited nonvested accounts totaled \$0 and \$45,440 respectively. Forfeited balances are made available to pay administrative expenses, reinstate previously forfeited account balances of former participants who have been reemployed by the Company, and to reduce the Company's contributions. Any amount remaining is reallocated to the accounts of participants active in the Plan on the last day of the plan year. The method used to allocate these funds to a participant's account is the same method used in allocating the employee's contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Plan Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of Assets (Held at End of Year), including investments held at June 30, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, custodian of the plan.

NOTE 4 FAIR VALUE MEASUREMENTS

The Plan's financial instruments are reported in accordance with ASC 820, which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Money Market Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. These investments are deemed to be actively traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INVESTMENTS AT CONTRACT VALUE

The Plan has a traditional fully benefit-responsive investment contract with Mutual of America Life Insurance Company, the insurance company. The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the insurance company but may not be less than 1%. The crediting rate is reviewed at the discretion of the insurance company for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company represents contributions made under the contracts, plus earnings, less participant withdrawals,

and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the insurance company's ability to meet its financial obligations. The insurance company's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the insurance company to terminate the contract and which require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Plan Sponsor contributions.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment instruments. Investments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 TAX STATUS

The Internal Revenue Service (IRS) ruled, in a letter dated December 4, 2001, that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, was not subject to income tax. The Plan has been amended since receiving the determination letter. The Plan as amended follows a volume submitter plan, which has received an opinion letter from the IRS dated March 31, 2014 indicating that the volume submitter plan document was in compliance with applicable sections of the IRC. The Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the requirements of the IRC.

NOTE 8 TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

NOTE 9 RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments were held and managed during the year by the custodian of the Plan, as defined in Note 3. Therefore, these transactions qualify as party-in-interest transactions, which are deemed to be “exempt” from prohibited transaction rules, as defined by Department of Labor regulations.

NOTE 10 DELINQUENT CONTRIBUTIONS & NON-EXEMPT TRANSACTIONS

During the 2024 fiscal year, employee withholdings in the amount of \$1,456 were late in being transferred to the Plan in accordance with the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The delays were unintentional, and the Plan Sponsor will remit the withholdings and the lost earnings on those withholdings for a total amount of \$1,499 to two participants calculated using the DOL guidelines for late deposits under the Voluntary Fiduciary Correction Program during 2024.

NOTE 11 CORRECTIVE DISTRIBUTION AND DISTRIBUTION PAYABLE

During fiscal year 2024, it was discovered that a participant was contributing into the Plan before becoming eligible to participate in the Plan. These contributions are required to be returned to the individual. This refund, which amounted to \$33,000 as of June 30, 2024, was reported as a corrective distribution and distributions payable. The funds were distributed from the Plan in fiscal year 2025.

NOTE 12 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.
