Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SERV Behavioral Health System 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SERV Behavioral Health System 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SERV Behavioral Health System 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about SERV Behavioral Health System 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.



NOTE 1 DESCRIPTION OF PLAN

The SERV Behavioral Health System 401(k) Retirement Plan (Plan) is administered by SERV Behavioral Health System, Inc. (Organization, Sponsor or Plan Administrator). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, both of which are available from the Organization.

General

The Plan is a voluntary, participant-directed, defined-contribution 401(k) plan as defined under the Internal Revenue Code (IRC), which became effective October 1, 1999, for the benefit of all eligible employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees of the Organization, who have attained age 21 and have completed a service requirement of six consecutive months are eligible to participate in the Plan. The following classes of employees are not eligible to participate in the Plan: employees whose employment is governed by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; employees who are nonresident aliens who do not receive earned income from the Organization that constitutes U.S. earned income; and leased employees. Employees are eligible to make pre-tax and Roth elective deferral contributions, receive employer safe harbor matching contributions, and receive employer discretionary profit-sharing contributions upon enrollment in the Plan. Employees may enroll in the Plan on the first day of the month immediately following their initial date of eligibility. In addition to these requirements, in order for participants to be eligible for profit-sharing contributions, they must complete a 12-month service requirement. However, the participant is exempt from the service requirement if one of the following conditions are met: the participant's death, the participant's termination of employment after having incurred a disability, the participant's termination of employment after having reached early retirement age, and the participant is employed on the last day of the Plan Year.

Participant Contributions

Each Plan Year, participants may make voluntary contributions up to 100% of eligible compensation to their tax deferred or after-tax account, up to the annual Internal Revenue Service (IRS) dollar limit. Participants who are age 50 or older at the end of the calendar year may make additional pre-tax catch-up contributions, subject to IRS limitations. Participants may elect to change their deferral percentage at any time, effective at the beginning of each payroll period. The Plan accepts rollover contributions from other qualified retirement plans in accordance with ERISA.

Employer Contributions

The Organization will contribute a safe harbor matching contribution on behalf of each eligible participant, equal to 100% of the first 3% and 50% of the next 2% of an employee's elective deferral contribution for the Plan Year. The Organization made employer-matching contributions of \$595,016 and \$589,962 for the Plan Years ended June 30, 2024 and 2023, respectively.

The Organization may elect to contribute a discretionary profit-sharing contribution on behalf of each eligible participant each Plan Year, based on an allocation of each employee's eligible compensation. The Organization made profit-sharing contributions of \$958,315 and \$1,172,120 for the Plan Years ended June 30, 2024 and 2023, respectively.

Investment Options

Upon enrollment in the Plan, participants may direct their employee and employer contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily using a telephone or web network.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary employee contributions, employer ADP safe harbor contributions, rollover contributions, plus actual earnings thereon. A participant becomes 100% vested in employer ACP safe harbor and discretionary profit-sharing contributions, plus actual earnings thereon, after completing three years of credited service. Participants are automatically 100% vested in their accounts upon attainment of normal retirement age (defined as 65), disability, or death.

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum of the lesser of 50% of a participant's vested account balance or \$50,000, reduced by the highest loan balance in the participant's account during the preceding twelve-month period. Participants may have one loan outstanding at any given time. Effective October 1, 2019, interest rates on new loans bear interest at prime, plus 1%. The interest rate will remain fixed throughout the duration of the loan. Loans are permitted from any Plan assets, except those with restrictions in trading fees, etc. Loans are repaid in installments for terms up to 5 years through payroll deductions. A loan used to acquire a principal residence for a participant may be repaid over a period greater than 5 years. A participant's vested account balance will be considered by the Plan as security for the outstanding loan balances of all Plan loans made to that participant. There is no penalty for early repayment of loan balances. If a participant defaults on any outstanding loan, the unpaid balance, and any interest due thereon, shall become due and payable in accordance with the terms of the underlying promissory note. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is considered to be a deemed distribution to the participant.

Benefit Payments

After retirement, death, or disability, participants are entitled to receive a lump-sum distribution. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1st of the calendar year following the later of the calendar year which the Participant attains age 73 or the calendar year in which the participant retires. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account ("IRA"), or distributed through a lump-sum payment, partial payments, a monthly life annuity or joint-and-survivor annuity, or through installment payments for a certain dollar amount. If the vested balance is \$1,000 or less, the participant will receive a lump-sum distribution without consent.

Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalties.

In-Service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

Retirement

The plan's normal retirement age is 65. The plan does not allow for early retirement age.

Forfeitures

Forfeited contributions are retained in the Plan and may be used to pay administrative expenses or to reduce employer contributions. The Plan used \$50,874 and \$96,516 to pay administrative expenses during the years ended June 30, 2024 and 2023, respectively, and \$0 was used to reduce employer contributions during the years ended June 30, 2024 and 2023. As of June 30, 2024 and 2023, \$2,863 and \$30,828, respectively, remain available in the forfeiture accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions in accordance with the provisions of the Plan. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses and Participant Transaction Fees

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Organization has evaluated its subsequent events and transactions occurring after June 30, 2024 through April 3, 2025, the date that the financial statements were available to be issued.

Ascensus, LLC (an affiliate of Ascensus Trust Company), as authorized agent for Ascensus Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Money Market Fund and Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

Common Investment Trust – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. (Level 2 inputs)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Ascensus, LLC, the authorized agent for Ascensus Trust Company, Trustee of the Plan and The Vanguard Group, record-keeper, and therefore, those transactions qualify as party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon such termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Organization contributions and earnings thereon, as of the termination date.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the non-standard defined contribution pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
