Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Massey Companies 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Opinion



NOTES TO FINANCIAL STATEMENTS

June 30, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of The Massey Companies 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of The Massey Companies: Massey Construction, Inc.; Massey Electric, Inc. (see Note 9); Massey Shared Services, LLC; TNT Powder Coating, LLC; and Aethon Equine Specialties, LLC (collectively, the "Company") who have completed 6 months of eligible service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Employer Administrative Committee, as the Plan Administrator, is responsible for oversight of the Plan; and has overall responsibility for investments, accounting for assets and allocations to participants' accounts. The Committee has delegated these functions to the custodian and the third-party administrator, Empower Trust Company, LLC and Tennessee Pension Administrators, respectively.

Contributions - Each year, participants may contribute up to the maximum percentage allowable not to exceed limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral percentage automatically increases by 1% each January 1st until it reaches the Plan's automatic increase maximum of 10%, unless changed by the participant. The employer may make a matching contribution equal to a discretionary percentage of the participant's elective deferrals. During the year ended June 30, 2024, the Company contributed a matching contribution of 33% of the participant's elective deferrals for participants employed on the last day of the Plan year. Additional profit sharing amounts may be contributed at the option of the Company. There were no profit sharing contributions made in 2024. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant or a beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or purchase an annuity. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Account balances less than \$5,000 will be automatically distributed in a lump sum payment.

Forfeited Accounts - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$46 and \$2,609, respectively. These accounts will be used to pay administrative expenses. For the year ended June 30, 2024, forfeitures of \$17,036 were used to pay part of the matching contributions.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For Plan years 2020 to 2024, the Plan did not distribute excess contributions to applicable participants by the regulatory deadline of 2.5 months after the Plan's year-end, which subjected the plan sponsor to a 10% tax penalty on the total amount refunded for each Plan year.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through April 10, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Federal Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market fund held in the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Empower Trust Company, LLC, the custodian, that the investment information in the accompanying financial statements and the supplemental schedule, with respect to investments and related investment activity, except for the classification of investments by level, is complete and accurate as of June 30, 2024 and 2023, and for the year ended June 30, 2024. The information certified by the custodian is presented based upon their certifications and is summarized below.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC is the custodian of the Plan and qualifies as a party-in-interest. Fees paid to Empower totaled \$27,679 for the year ended June 30, 2024.

Tennessee Pension Administrators, LLC is the third-party administrator of the Plan and qualifies as a party-in-interest. Fees paid to Tennessee Pension Administrators totaled \$15,065 for the year ended June 30, 2024.

Home Federal Bank of Tennessee is the corporate trustee of the Plan and qualifies as a party-in-interest. Fees paid to Home Federal Bank of Tennessee totaled \$33,480 for the year ended June 30, 2024.

The Plan Sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan Sponsor adopted a non-standardized pre-approved plan sponsored by Tennessee Pension Administrators, LLC. The pre-approved plan received its latest determination letter in June 2020. Although the Plan has not applied for its own determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PARTIAL PLAN TERMINATIONS

Cherokee Millwright was sold in October 2017 resulting in a partial plan termination. Effective October 29, 2017, the Plan was amended to remove Cherokee Millwright as an adopting employer. This amendment affected approximately 100 participants, 85 of whom have taken distributions from the Plan totaling approximately \$3,300,000 since 2017. Approximately \$450,000 remains payable to affected participants at June 30, 2024. Participants took distributions of approximately \$744,000 during the year ended June 30, 2024. All participants affected by the partial plan termination became fully vested in their accounts prior to distributions being taken.

Massey Electric, Inc. was sold in February 2023 resulting in a partial plan termination. Effective February 28, 2023, the Plan was amended to remove Massey Electric as an adopting employer. This amendment affected approximately 70 participants. Approximately \$44,000 remains payable to affected participants at June 30, 2024. Participants took distributions of approximately \$1,400,000 during the year ended June 30, 2024. All participants affected by the partial plan termination became fully vested in their accounts prior to distributions being taken.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investments which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
