Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of June 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the SCCHC Profit Sharing & 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a cash deferred defined contribution profit sharing plan covering all eligible employees of South Cove Community Health Center, Inc. (the “Employer”). The Plan was restated in its entirety most recently on July 1, 2023. Eligible employees are defined as those employees (except leased employees and residents of Puerto Rico) who have attained age 21 and completed three months of service, as defined (“Participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant-directed.

On July 1, 2023, the Plan changed its name to the SCCHC Profit Sharing & 401(k) Plan.

Participant Contributions

Each year, participants may contribute up to 75% of their compensation, as defined by the Plan, subject to the Internal Revenue Code (“IRC”) limitations. Contributions may be directed to pre-tax or Roth accounts. Participants who have reached the age of 50 by the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts to the Plan representing distributions for other qualified plans (“Participant Rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Safe Harbor Contributions

Each year, the Employer will contribute, on behalf of all eligible participants, a safe harbor contribution equal to 3% of eligible compensation. For the Plan year ended June 30, 2024, the Employer contribution amounted to \$567,361, net of forfeitures of \$15,886, which was funded subsequent to year end.

Employer Discretionary Nonelective Contributions

Each year, the Employer at its discretion may decide to make a nonelective discretionary contribution to the Plan. In order to receive this type of contribution, a participant must have completed three months of service, as defined. Allocations are based upon each participant’s proportionate share of compensation to total eligible compensation of each allocation group paid during the year. For the year ended June 30, 2024, the nonelective discretionary contribution was equal to 2% of eligible compensation and amounted to \$388,282 which was funded subsequent to year end.

Notes to Financial Statements

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with a pro rata allocation of (a) the Employer contributions, (b) the Plan's investment earnings and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in elective deferrals, rollovers, and the Employer safe harbor contributions and the related investment earnings thereon. Vesting in the Employer nonelective contributions is based on years of continuous service. Vesting in the Employer nonelective contribution begins on the second year of service with the participant becoming fully vested after six years of service. A participant also becomes fully vested in the Employer nonelective contribution upon reaching normal retirement age or upon death or disability prior to termination of employment.

Withdrawals and Distributions

Participants are entitled to their total vested account balance upon death, disability, retirement or termination of employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance. Additionally, upon reaching age 59½, participants are allowed in-service withdrawals from his/her total vested account balance. If a participant's vested account balance is greater than \$1,000, but no more than \$5,000 and the participant does not elect to receive a distribution, the Plan administrator may distribute the participant's entire vested account balance to an IRA rollover account for the benefit of the participant. Hardship withdrawals are not allowed per the Plan document.

Plan Administration

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Fidelity Management Trust Company ("Fidelity") is the trustee of the Plan.

Forfeitures

A participant who leaves the employ of the Employer forfeits any non-vested balance. Forfeited balances may be used to reduce Employer contributions or pay Plan expenses. At June 30, 2024 and 2023, there were \$15,026 and \$151,914 unused forfeited balances, respectively. During the year ended June 30, 2024, \$172,560 of forfeitures were used to offset a portion of the Employer contribution for the 2023 Plan Year. Subsequent to year end, \$15,886 of forfeitures were used to reduce the Employer safe harbor contribution for the 2024 Plan Year.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Benefits Paid

Benefits are recorded when paid.

Administrative Fees

The Employer, at its discretion, may pay certain administration expenses of the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Fees relating to certain benefit disbursement processing, recordkeeping, and advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Employer has evaluated subsequent events through April 10, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments are held by the Plan's trustee and custodian, Fidelity. The fair values of investments as of June 30, 2024 and 2023, and all investment transactions for the year ended June 30, 2024, including interest and dividends, and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by Fidelity. Information included in the supplemental schedule has also been derived from information certified by Fidelity.

The Plan offers investment choices to allow participants to create a diversified portfolio based on a participant's risk tolerance. Participants may invest among a variety of mutual funds and a common/collective trust.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The investments held by the Plan are deemed to be actively traded.

Note 4 - Fair Value Measurements (Continued)

Units in the Common/Collective Trust Fund: (Through June 30, 2023) Valued at the NAV of units of collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The investment's objective is the stability of principal and high current income. To achieve its investment objective, the common/collective trust invests in high-quality guaranteed investment contracts and synthetic investment contracts which underlying assets consist of security-backed investment contracts, synthetic separate account guaranteed investment contracts (includes fixed income investments) and short-term investments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Party-In-Interest Transactions

Plan investments are held by Fidelity. Fidelity is the trustee and custodian, and, therefore, these transactions qualify as party-in-interest transactions. For the Plan year ended June 30, 2024, administrative fees of \$98,256 were paid to Fidelity and other service providers. The Plan received revenue credits of \$3,680 during the year ended June 30, 2024. The revenue credits were used to pay plan expenses and have been netted against administrative fees on the Statement of Changes in Net Assets Available for Benefits.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 9 - Tax Status

The Plan adopted the FMR LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.



