**June 30, 2024 and 2023**

**1. Description of the Plan**

The following description of the Providence Performing Arts Center Defined Contribution Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement or the Summary Plan Description for more information about the Plan.

***General***

The Plan is a participant-directed defined contribution plan, covering all employees of Providence Performing Arts Center and its wholly-owned subsidiary, Professional Facilities Management, Inc. (collectively, the Employer or Plan Sponsor) who have attained the age of 21 and completed one year of eligible service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Charles Schwab Trust Bank (Charles Schwab) is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

***Contributions***

Participant contributions are not allowed under the Plan, except for certain transfers of amounts from other qualified plans in which the participant was vested.

The Employer may make discretionary profit-sharing contributions to the Plan on behalf of all employees who have completed at least 1,000 hours of service during the Plan year and are employed as of the last day of the Plan year. The Employer discretionary profit-sharing contribution is allocated in the ratio that each eligible individual's eligible compensation, as defined, bears to total eligible compensation.

***Participant Accounts***

Each participant's account is credited with the Employer's discretionary profit-sharing contributions and their allocation of Plan earnings/losses, and any expenses incurred. Allocations are based on participant compensation or individual account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants become 100% vested in their Employer profit sharing contributions and the annual allocation of Plan earnings on those contributions after three years of service. In the event of death, disability or attainment of normal retirement age, the participant shall immediately become 100% vested in his/her account.

***Payment of Benefits***

Upon retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump-sum amount equal to the value of the participant's vested interest in their account. Participants who have reached age 59½ may elect to withdraw all or a portion of amounts in their vested account while still employed by the Employer. If a participant's vested account balance is equal to or less than \$5,000, the participant will receive an immediate cash-out of their vested account balance.

Hardship withdrawals from the Plan are not permitted.

On September 1, 2022, the Plan was amended to implement provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act, which increased the age of the required distributions to begin from 70 1/2 to 72, in addition to other RMD provision changes. The Plan also implemented a provision to permit Qualified Birth and Adoption Distributions (QBADs).

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing three years of service forfeit the non-vested portion of the Employer discretionary profit sharing contribution to their accounts. Forfeitures may be used to reduce future Employer contributions or pay administrative expenses. As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$7,475 and \$9,607, respectively. During 2024, Employer contributions were reduced from forfeited non-vested accounts by \$9,721.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fully Benefit-responsive Investment Contract***

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

At June 30, 2023, the Plan had an investment in the Guaranteed Income Fund, which is a group annuity contract issued by Empower Annuity Insurance Company, which meets this requirement. The Plan's investment in this fund, which represented contributions and reinvested interest income, less withdrawals, and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds, was recorded at contract value. The Plan was not invested in the Guaranteed Income Fund as of June 30, 2024.

***Contributions***

Employer discretionary profit-sharing contributions are recorded annually and remitted in the following Plan year, if applicable.

***Payment of Benefits***

Benefits are recorded when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and are not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through April 8, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of June 30, 2024 and 2023, the Plan’s investments in the money market fund and mutual funds are reported at level 1 within the fair value hierarchy:

**4. Fully Benefit-responsive Investment Contract**

At June 30, 2023, the Plan had an investment in the Guaranteed Income Fund, a group annuity contract, which is a traditional fully benefit-responsive investment contract. Contributions to this fund were deposited into the Empower Annuity Insurance Company’s (Empower) general account, which primarily invests in public bonds, commercial mortgages, and cash and short-term investments.

The account was credited with Employer contributions, plus earnings, and charged for participant withdrawals and administrative expenses. The insurance company was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The minimum crediting rate under the contract was 1.40% as of June 30, 2023, and was reviewed on a quarterly basis for resetting. The guarantee of values provided for investments made with Empower under the Plan’s investment contract was based on the financial strength and claims-paying ability of Empower.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. In order to maintain the issuer's promise to pay withdrawals and exchanges at contract value, the contracts subjected the fund and its participants to certain restrictions, such as withdrawals prompted by certain events (e.g., plan terminations, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules) and could be paid at market value of the funds securities, which could be less than contract value, or could restrict withdrawals in these events. It was not probable that these events would occur. In addition, the account had certain redemption restrictions such that certain withdrawals could be deferred if the amount of withdrawals and transfers during the year exceeded 10% of the pool's beginning of year balance. There were no events that allowed Empower to terminate the contract and required the Plan sponsor to settle at an amount different than contract value to be paid either within 90 days or over time. The Plan was not invested in the Guaranteed Income Fund as of June 30, 2024.

**5. Summary of Information Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Charles Schwab:

Statements of Net Assets Available for Plan Benefits as of June 30, 2024 and 2023, except for contributions receivable;

Investment income on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended June 30, 2024; and

Investment information provided on the supplemental schedule, Schedule of Assets (Held at End of Year) at June 30, 2024.

**6. Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan which has received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by USI Consulting Group (USI), the third-party administrator of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to USI for investment management services of \$4,774 for the year ended June 30, 2024.
