**NOTE A – Description of Plan**

The following description of the Robeson Health Care Corporation Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution Plan established by Robeson Health Care Corporation (the “Organization”) to provide employees with a systematic means of savings and investing for retirement. All permissible employees of the Organization, as defined in accordance with the universal availability standards are eligible to enroll on their date of hire. Deferrals begin on the first day of enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may contribute up to 100 percent of pretax annual compensation, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Organization contributes a matching amount based on 50 percent of employee contribution up to the amount of six percent of the participant’s compensation. An employee who is age 50 or older may make a catch-up contribution as defined by IRS regulations.

**Discretionary Contributions.** Each year, the Organization may make discretionary contributions to participant accounts. Discretionary contributions are made at the discretion of the Organization and the contribution, if any, is be divided among participants eligible for a share at June 30.

**Expenses.** The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators, the trustee, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution, allocations of the Organization’s matching contributions, Plan earnings, and any discretionary contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options.** Upon enrollment in the Plan, participants may direct the investment the Organization’s contributions into various investment contracts and annuity options offered by the Plan.

**Vesting.** Participants are immediately vested in their voluntary contributions and actual earnings thereon.

**Excess Contributions Payable.** Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. There were no excess contributions for the year ended June 30, 2024.

**Participant Investment Rollovers.** Participants can transfer or rollover funds into the Plan from other qualified or 403(b) plans.

**Payment of Benefits.** Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant’s account in either a lump sum or, at the participant’s election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participant’s vested account in a lump-sum.

**NOTE B – Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting.** The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Modified cash basis of accounting is defined as cash basis accounting modified with respect to contributions. Employer and employee contributions and the related contribution receivables are accounted for based on the payroll check dates within the Plan year. Contribution receivables are recorded if Plan contributions from check dates occurring within the Plan year were credited to the Plan after the year end date.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates.** The preparation of financial statements in conformity accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are held in various insurance contracts and annuities and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefit payments to participants are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events.** The Plan has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), the trustee of the Plan, has certified to the completeness and accuracy of all investments, related investment activity, and related activity in the accompanying statements of net assets available for benefits for the years ended June 30, 2024 and 2023, the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024 and accompanying supplemental schedule of assets (held at end of year) as of June 30, 2024.

**NOTE D – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E – Guaranteed Investment Contract with Principal Life Insurance Company**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$807,805 and \$732,275 at June 30, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest that is guaranteed to the Plan. The credit rating is based on a formula established by the contract issuer but may not be less than 1.80 percent. The credit rating is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this amount represents what participants would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amount dues is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (1) amendments to the Plan documents (including the complete or partial Plan termination or merger with another Plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F – Related-Party Transactions**

Certain Plan investments are investment contracts and shares of mutual funds managed by Principal Investment Company. Principal Investment Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for the year ended June 30, 2024 equaled to \$27,353.

**NOTE G – Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE H – Tax Status**

The Internal Revenue Service (IRS) has determined the Organization by a letter dated June 16, 2004, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. The Plan is subject to income tax examinations generally for three years after they were filed.

**NOTE I – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J – Prohibited Transactions**

During the year ended June 30, 2023, the Plan sponsor remitted employee deferrals totaling \$50,457 to the Plan late. These late payments are included on the Schedule of Delinquent Participant Contributions on page 13. The plan administrator calculated the lost earnings related to delinquent contributions using the U.S. Department of Labor’s calculator. Using this calculator, the combined lost earnings for all participants totaled \$887. The participant’s accounts will be credited for their proportionate share of the \$887 in the year ended June 30, 2024.
