NOTE A - Description of Plan

The following description of St. Augustine Preparatory Retirement Plan provides general information. Participants should refer to the plan document for a more complete description of the plan.

General

Participants should refer to the Plan agreement for a complete description of the Plan. The Organization established a 401(k) Plan for the benefit of its employees. The Plan is a defined contribution plan established by St. Augustine Preparatory Academy and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of St. Augustine Preparatory Academy are eligible to enroll, with the Plan having quarterly enrollment dates. The Plan excludes collectively bargained employees, non-resident aliens who receive no compensation from the employer that constitutes U.S. source income, and leased employees. Employees that are enrolled in the Plan are eligible to receive a safe harbor matching contribution. The Organization may also make additional matching or profit sharing contributions at its discretion.

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Contributions

Participants may elect to reduce compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as an elective deferral in accordance with a procedure established by the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth 401(k) contributions. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. For the year ended June 30, 2024, and June 30, 2023, employees of the plan made contributions of \$810,972 and \$650,288, respectively.

The Plan includes an auto-enrollment provision.

The Company makes matching contributions equal to 100% of the employee's contribution up the first 3% of plan compensation plus 50% of the amount of the employee's contribution between 3% and 5% of plan compensation, for a maximum of 4%. For the years ended June 30, 2024 and 2023, the Organization made safe harbor matching contributions in the amount of \$509,658 and \$393,219, respectively.

The Company may make discretionary non-elective contributions to the plan. For the year ended June 30, 2024 and 2023, the Company did not make any discretionary non-elective contributions.

Contributions are subject to certain limitation as mandated by the Internal Revenue Code (IRC).

Investment Options

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their deferrals, safe harbor matching contributions, and actual earnings (losses) thereon. Any discretionary non-elective contribution portion made by the company is vested based on the following table:

Notes Receivable from Participants

Loans and notes receivable from participants are not permitted under this plan.

Payment of Benefits

Participants are eligible to receive benefits upon termination, disability, death or reaching Normal Retirement Age, which is defined by the Plan as 65 years. Payments may be paid in either a single lump sum or installments over a period of time not more than assumed life expectancy. Benefits are recorded when paid.

Administration Expenses

For the years ended June 30, 2024 and 2023, administrative fees of \$48,999 and \$38,478 respectively, have been paid out of Plan assets. All other expenses incurred in the administration of the Plan are paid by the Organization.

Forfeited Accounts

Forfeitures may be used to reduce the amount of employer's matching and non-elective contributions and/or to pay administrative fees. During 2024, no forfeited non-vested accounts were used to reduce employer matching contributions and/or pay administrative expenses.

NOTE B - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present the assets available for Plan benefits and changes in those assets.

The Plan's investments are reported at fair market value.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plans valuation policies utilizing information provided by investment advisors, custodians, and insurance companies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE D - Fair Value Measurements

The Company has adopted the Financial Accounting Standards Board guidance on fair value measurements. A three-tier hierarchy is used to maximize the use of observable market data inputs and minimize the use of unobservable inputs and to establish classification of fair value measurements for disclosure purposes. Financial assets valued using Level 1 inputs are based on unadjusted quoted market prices within active markets for identical assets or liabilities at the measurement date. Financial assets valued using Level 2 inputs are other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly, at the measurement date. Financial assets valued using Level 3 inputs are unobservable for the asset or liability and there is little or no market activity at the measurement date.

John Hancock Pooled Separate Accounts: The pooled separate accounts, which are direct filing entities, are valued at net asset value ("NAV") based on units of the pooled separate accounts. The NAV, as certified by John Hancock, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying mutual fund investment held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

NOTE E - Plan Termination and Amendments

While the Company has not expressed any intent to terminate the Plan, it has the right to do so, subject to the provisions of ERISA. In the event of termination, each participant automatically becomes 100% vested to the extent of the balance in his or her account.

The Plan may be amended at any time by the Company.

NOTE F - Tax Status

The Plan is a Volume Submitter Profit Sharing Plan with CODA which received its most recent tax determination letter on March 31, 2014. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

NOTE G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - Related Party Transactions

The Plan's investments are held, invested and maintained by John Hancock Life Insurance Company, the Plan custodian at June 30, 2024. The custodian also performs recordkeeping services for the Plan. These transactions are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.
